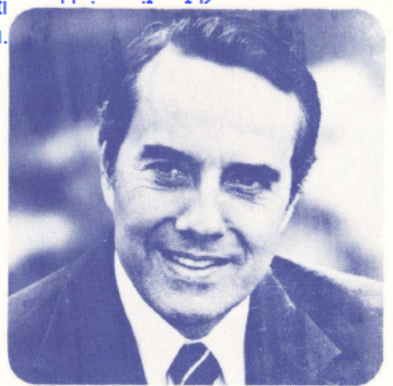

NEW TAX FIGURES WILL HIGHLIGHT MONDAY'S HEARING ON DOLE/GRASSLEY BILL

WASHINGTON -- A bill designed to crackdown on an alarming increase in unreported income tax will be the subject of hearings Monday before the Senate Finance Subcommittee on Oversight of the Internal Revenue Service.

Chairman of the subcommittee, Senator Charles Grassley (R.-Iowa), announced the hearings on the Dole/Grassley Taxpayer Compliance Improvement Act of 1982.

According to Senator Dole, significant new figures will be presented at Monday's hearing: "According to reports, these new figures will reinforce what the committee's initial research has uncovered--tax revenue lost to tax evaders continues to skyrocket."
