SENATOR DOLE'S PERSONAL INCOME TAX INFORMATION

WASHINGTON -- Kansas Senator Bob Dole today disclosed that he and Mrs. Dole paid a total of \$194,650 in federal and state income taxes and self-employment taxes for calendar year 1983 on a joint taxable income of \$351,151. The Doles' tax liability included \$31,834 in Kansas, District of Columbia, and North Carolina state income taxes. Their federal return, filed April 16, reports a total 1983 federal tax payment of \$162,816, which Dole stated, represented 107.04% of their combined salaries. The federal taxes paid by the Doles exceeded their government salaries.

Senator Dole's summary of their joint federal return indicates that Dole earned \$188,917 for speaking engagements, and that 43.54% of this, or \$82,250, was donated directly to charity. An itemized listing of the charitable donations is attached.

Dole stated that he continued to follow his longtime practice of avoiding any possible conflict of interest with regard to speaking engagements: if a speech before a particular group poses a possible conflict of interest, then that speaking fee is donated to a charitable organization.

The summary indicates that none of Dole's income was from stocks or bonds, oil investments or real estate holdings, and that he had no tax-sheltered income. His only other income was from radio programs that netted him \$5,691, and he received \$3,931 in interest from savings accounts, certificates of deposit, and \$13,140.45 in tax-exempt disability pay.

Figures indicate that during the past five years, the Doles have donated \$235,060 to charity and paid a total of \$517,390 in federal taxes.

Summaries of the Doles' joint returns for the years 1979 through 1983 are attached.
