## SENATOR DOLE ANNOUNCES SEMINARS FOR KANSAS SMALL BUSINESSES: ATTRACT PEOPLE WITH **DISABILITIES AS CUSTOMERS AND EMPLOYEES**

## **TOPEKA - FRIDAY, JULY 24 HUTCHINSON - MONDAY, JULY 27 OVERLAND PARK - FRIDAY, AUGUST 7**

WASHINGTON -- "ADA And Small Businesses: Ready, Willing and Able" is the focus of three informational seminars to be held in Topeka on July 24, Hutchinson on July 27 and Overland Park on August 7. The seminars, sponsored by Kansas Senator Bob Dole, the Kansas Association of Independent Living Centers (KACIL) and the U.S. Small Business Administration, are designed to help small businesses comply with the new Americans with Disabilities Act and to attract people with disabilities as customers and employees.

The sessions are intended to provide specific information to Kansas small businesses regarding accessibility and accommodation requirements for people with disabilities, as required by President Bush signing the Americans with Disabilities Act (ADA) into law July 26, 1990.

Gina McDonald, Executive Director of KACIL, will be leading the sessions.

"Having a stable and rewarding job is a basic component of the American dream -- a dream shared by millions of Americans with disabilities. The new ADA law, which I supported, prohibits discrimination against persons with disabilities in all areas of American life, " said Dole.

Title I of the Americans with Disabilities Act of 1990 takes effect on July 26, 1992, prohibiting private employers, state and local governments, employment agencies and labor unions from discriminating against qualified individuals with disabilities in job application procedures, hiring, firing, advancement, compensation, job training, and other terms, conditions and privileges of employment.

"Since passage of the Americans with Disabilities Act, many Kansas employers have voiced uncertainty of how to meet their obligations of implementing this law. That's why I'm pleased to support these seminars because they will offer a unique opportunity for the Kansas small businessman and woman to gain hands-on information about what the Americans with Disabilities Act is and how to effectively implement the law's true intent," added Dole.

Among the issues the seminars will address are:
