WHITE HOUSE'S \$23 MILLION LIE

CLINTON MISSES BOAT ON WICHITA BOATHOUSE

Wrong again! The White House was wrong on the so-called stimulus bill, and they're wrong on the Wichita boathouse. The Clinton administration really missed the boat on this one. It's a \$23 million lie, and there's no way the White House can defend it.

The fact is my letter was a waiver request that had nothing to do with the President's so-called stimulus bill and its billions of dollars in deficit spending. Here are the facts:

- 1) Wichita received \$500,000 from the federal government's CDBG program in 1980 -- that's right, 13 years ago! -- to help purchase and renovate a senior citizen center. Local matching funds helped finish the project.
- 2) The senior center closed in 1992 to move its operations to a larger facility.
- 3) Since that time, the vacant building on the edge of the Arkansas River has turned into a hangout for drugs and crime.
- 4) As a result, city officials -- instead of paying to demolish the building -- now want to lease the building to a charitable foundation that intends to rehabilitate the vacant building with private funds to turn it into a boathouse. To change the purpose of this building, the city was required by law to seek a waiver from HUD.
- 5) The city asked me and area Congressman Dan Glickman to approach HUD to urge that Wichita's request for a waiver be carefully considered -- a request for a waiver of purpose, not a request for new money and deficit spending. On March 5th, my Wichita office sent a letter to HUD asking that the city's waiver request be considered.
 - 6) The White House lied.
- 7) There's no \$23 million boathouse, no deficit spending, no new money, no connection with the President's deadbeat "stimulus" bill, and no truth coming from a White House staff that is ill-serving the President with these sophomoric attacks.
- 8) If the White House wants to play hardball, I'm ready to suit up.

So it looks like another ploy from the never-ending Clinton campaign has backfired. It may be a joke to the White House, but the American people aren't laughing at the Clinton Administration's petty political games -- the American people want the White House to move on to serious issues, such as health care reform, reducing the deficit, waging war on crime, and bringing peace to Bosnia.

Dear Mr. Madrigal:

I am writing on behalf of the Arkansas River Foundation to request reconsideration of your decision to deny a waiver requiring reimbursement of CDGB funds by the City of Wichita for a vacant building that was acquired and rehabilitated with these funds. I understand that this request was denied in accordance with provision CFR 570.505 (b).

This building is currently vacant and I understand that permits have been issued and bids have been let to raze the structure. Given the fact that demolition of this structure will provide no opportunity for reclamation and that razing it will eliminate any reimbursement requirement on the part of the City of Wichita, I suggest that waiving the reimbursement requirement is a common sense solution.

The net gain for the City under the proposed re-use will be to revitalize a deteriorating area and to provide a source of income to the City through a lease agreement with the Foundation. I believe this is a more positive approach than continuing to allow the property to decline and eventually be demolished.

As envisioned by its bousters, the boathouse would be located in the now-vacant Wichita Senior Services building near the Lewis Street Bridge in downtown Wichita. When the foundation beard the building was to be torn down, it asked to lease the building from the city.

The city agreed, but there was a catch. Because the building was bought years ago with federal money, the federal government needed to approve a new use. Without that

At a black-tie banquet Saturday night, President Clinton mocked one of his frequent critics — Sen. Bob Dole — by citing Dole's request "to convert a senior citizens' center to a boathouse in Kansas."

Dole was asked about the Arkansas River boathouse on national TV Sunday, and replied that he doesn't remember the request. The truth is, he did make one.

But Clinton went much further. The president got the banquet crowd roaring when he said that Dole had requested \$23 million in federal aid for the boathouse project, which he implied was "full of pork."

And that is not true, says Wichita attorney Richard Schodorf, vice president of the Arkansas River Foundation. First, because the boathouse will cost only \$850,000 — not \$23 million.

But more importantly, "We're not asking for any federal money at all," Schodori said. "Not a cent, not

I am writing at the behest of the citizens of Wichita, Kansas. It has come to my attention that the City of Wichita has requested a letter of concurrence from your office concerning the use of a building purchased with funds from a CDBG grant.

It is my understanding that the grant was originally obtained to purchase and renovate the building for use as a center for senior citizens. It is also my understanding that the senior center has moved to new quarters and essentially stripped the interior of the facility when they relocated. The building is currently in a state of disrepair with no occupying tenant, leaving it subject to break-ins and further deterioration.

The City of Wichita is considering leasing the facility to a charitable foundation that intends to renovate the structure and use it as a boat house for the general public. Both the building in question and the boat house concept have historical significance to the city. The proposed public use of the facility as well as the revitalization of this blighted area seem to be goals which fit well within the contemplated purpose of the community grant program.
