WASHINGTON, D.C., Jan. 13, 1975 -- Senator Bob Dole today announced the names of 56 Kansas high school seniors he has nominated for appointment to the United States Air Force, Navy, Military and Merchant Marine Academies for classes beginning this summer, 1975.

All of the candidates compete equally for appointment under the "Competitive Method" chosen by Senator Dole as his preference for nominating candidates. Each academy will determine the best qualified nominee this Spring, and he will be charged as Senator Dole's appointment. The remaining nominees, if qualified, will become part of the qualified alternate pool, and may still be selected for appointment on that basis.
