SENATORS DOLE, KASSEBAUM AND IOWA GOVERNOR BRANSTAD

CALL FOR TASK FORCE ON FARM CREDIT PROBLEMS

AT MEETING WITH FEDERAL BANK REGULATORS

WASHINGTON -- Senate Majority Leader Bob Dole (R-KS), Senator Nancy Kassebaum (R-KS), and Iowa Governor Terry Branstad (R) today called for a Presidential Task Force to study problems in the farm economy and agricultural credit market.

"The Task Force would examine ways to best serve the needs of farmers without jeopardizing the solvency of the agricultural credit system. I would envision representatives from all segments of the industry, so we have a true cross-section of the various interests involved," said Dole. "I have discussed this plan with White House Chief of Staff Jim Baker and Treasury Secretary Donald Regan and they have indicated their support. We will be moving forward immediately to see that a Task Force is established."

Dole, Branstad and Kassebaum convened the meeting to discuss increasingly serious farm economy problems in Kansas, Iowa and other agricultural states.

"As the farm economy has deteriorated, the agriculturally oriented banker has found himself in a precarious position, caught between their farmer borrowers experiencing serious cash flow problems and increasingly aggressive regulators trying their best to insure the solvency of the banking system," said Dole, Kassebaum, and Branstad. "On one hand the community banker is expected to follow very specific guidelines set forth by regulatory agencies regarding loan classifications, bad loan reserves and the like -- while at the same time his farm customer is pleading with him for more time and flexibility so he can work his way through these hard times."
