WASHINGTON, D.C.--April 10, 1989--Kansas Senators Nancy Landon Kassebaum and Bob Dole today recommended Topeka banker John R. Price for the job of state director of the Farmers Home Administration.

In a letter to Agriculture Secretary Clayton Yeutter, the senators cited Price's nine years of commercial and agricultural lending experience, his responsibility for servicing \$21 million worth of agricultural and agricultural related loans, and his working relationships with banks across the state. They urged Yeutter to "move promptly" in naming Price to the job.

Price, a 1979 graduate of Kansas State University with a degree in agricultural economics, is currently Vice President of Commercial Banking at Merchants National Bank in Topeka.

We are taking this opportunity to recommend the appointment of John R. Price of Topeka, Kansas, to serve as state director of the Farmers Home Administration.

John, currently Vice President of Commercial Banking at Merchants National Bank in Topeka, has more than nine years of commercial and agricultural lending experience. He is responsible for a lending portfolio of \$21 million worth of agricultural and agricultural related credits, including nine FmHA guaranteed loans. He sits on the Merchants National Bank Discount Committee which functions as the approval body for loans in excess of officers' lending authority.
