WASHINGTON - Senate Republican Leader Bob Dole (R-Ks) today won subcommittee approval for a \$9.9 million major renovation project for the U.S. Federal Courthouse in Wichita. Dole's personal request was approved by the Treasury, Postal Service and Government Appropriations Subcommittee, which marked up the 1991 funding proposal.

"The Wichita courthouse, which houses judges, U.S. Marshals and court-related agencies, has been long overdue for major renovation. What was good for the 1930's is no longer acceptable as we head towards the 21st century. The judges and their staff have let me know how antiquated the current facility is, and after reviewing the facts, it's easy to see how out-of-date the courthouse really is," said Dole.

"Let's face it, when you flat run out of room, the air conditioning and heating don't work, there's no place to park, offices are dilapidated, and one of your courtrooms doesn't even have a jury box, then you know it's time for a serious overhaul."

The Dole funding proposal will be marked up by the full committee tomorrow, and could come to the Senate floor as early as this week.
