WASHINGTON - GARDEN CITY MUNICIPAL AIRPORT WILL BE ABLE TO MAKE NEEDED IMPROVEMENTS TO ITS FACILITY THANKS TO A \$1,355,700 GRANT FROM THE U.S. DEPARTMENT OF TRANSPORTATION ACCORDING TO KANSAS SENATOR BOB DOLE (R-KS). THE GRANT WILL ALLOW THE AIRPORT TO EXTEND THE RUNWAY AND TAXIWAY, INSTALL RUNWAY SIGNS, AND ACQUIRE SNOW REMOVAL EQUIPMENT. THE AIRPORT TRUST FUND GRANT WAS MADE AT THE DISCRETION OF SECRETARY OF TRANSPORTATION SAMUEL SKINNER AND AT THE REQUEST OF SENATOR BOB DOLE.
