## DOLE ANNOUNCES SECOND CONTRACT AWARD FOR CONSTRUCTION OF FEDERAL COURTHOUSE BUILDING IN KANSAS CITY, KANSAS

THE GENERAL SERVICES ADMINISTRATION (GSA), WHICH OVERSEES CONSTRUCTION PROGRAMS FOR ALL FEDERAL CONTRACTS, IS ISSUING THE AWARD TO THE J.E. DUNN CONSTRUCTION COMPANY OF KANSAS CITY, MISSOURI.

SENATOR DOLE AND OTHER NATIONAL, STATE, AND LOCAL LEADERS GATHERED TO BREAK GROUND ON THE SITE ON JUNE 14, 1991, FOLLOWING MORE THAN 6 YEARS OF EFFORTS TO GET THE PROJECT UNDERWAY. WITH THE SITE PREPARATION NEARING COMPLETION, WORK CAN NOW BEGIN ON THE ACTUAL BUILDING.
