WHAT WOULD HE (PRESIDENT CLINTON) NEED TO DO TO GET YOUR SUPPORT?

WE HAVEN'T TALKED. I DON'T KNOW FOR SURE.

IS THIS A SERIOUS EFFORT FOR DEFICIT REDUCTION? BOY! - THERE ARE A LOT OF TAXES IN THERE. I'M NOT CERTAIN THAT YOU INCREASE JOBS BY INCREASING CORPORATE TAXES.

MITCHELL:
THE SENATE IS SCHEDULED TO PROCEED TO S.1, THE NIH
REAUTHORIZATION BILL. I MET WITH PRESIDENT CLINTON AND VICE
PRESIDENT GORE THIS MORNING. I AM LOOKING FORWARD TO THE
PRESIDENT'S ECONOMIC MESSAGE THAT WILL LAY THE FOUNDATION FOR
INCREASING JOBS AND WAGES FOR WORKING AMERICANS.

WILL ALL MAKING OVER \$30,000 BE TAXED? WE DID NOT GO INTO SUBSTANTIAL DETAIL AT THE MEETING. IT WOULD BE BEST TO WAIT UNTIL THE PRESIDENT DELIVERS HIS MESSAGE TOMORROW TO DO THAT.

ARE YOU CONCERNED WITH THE DROP IN THE STOCK MARKET? WE SHOULD WAIT AND SEE ABOUT THE DETAILS FIRST, AS SHOULD WALL STREET.

WILL IT BE EASY TO GET THIS THROUGH? I HAVE NEVER PARTICIPATED IN AN EASY BUDGET AND I DON'T EXPECT THIS WILL CHANGE. WE'VE BEEN ON THE WRONG PATH FOR 12 YEARS AND A CHANGE IN APPROACH IS WHY PRESIDENT CLINTON WAS ELECTED. THE SUBSTANCE WILL INVOLVE SHARED SACRIFICE TO PROVIDE OPPORTUNITIES FOR ALL AMERICANS.

WILL MIDDLE CLASS BE PAYING AGAIN AFTER IN CAMPAIGN HE SAID THEY PAID ENOUGH? WHEN HE LAYS IT OUT \$30-50,000 BURDEN WILL BE VERY MODEST AND HIT HARDER ON THOSE WHO DID NOT PAY THEIR FAIR SHARE OVER THE PAST 12 YEARS.

REPUBLICANS HAVE BEEN STRONG ON THEIR CRITICISM THAT THE PLAN IS HEAVY ON TAX INCREASES AND LIGHT ON SPENDING CUTS? NOW WE ARE GOING TO FIND OUT IF THOSE WHO TALK ABOUT DEFICIT REDUCTION REALLY MEAN IT. WE WILL SEE IF THEIR VOTES MATCH THEIR RHETORIC.
