DOLE DIRECTS \$50,100 TO KANSAS CHARITIES IN 1992; 12-YEAR TOTAL NOW EXCEEDS \$800,000

WASHINGTON - Senator Bob Dole directed more than \$50,000 to Kansas charities last year, according to official Senate financial disclosure reports scheduled for Friday release. The 1992 figures now push his total charitable contributions to more than \$800,000 during the past 12 years, the lion's share of it to Kansas.

Senator Dole has a longtime practice of directing speaking fees, known as honoraria, to charitable organizations. Dole reported that he had given \$64,100 in honoraria to charitable organizations in 1992, \$50,100 of which went to Kansas charities.

During the period 1981 - 1992, Senator Dole has donated a total of \$840,464.88 to charitable organizations. From 1981 -1990, Senator Dole donated 64% of his total honoraria to charities in the amount of \$711,364.88.

Meanwhile, Dole disclosed that he is directing the \$200 honoraria offered for his June 3rd appearance on "The Tonight Show with Jay Leno" to the Lakemary Center in Paola, Kansas, a center for disadvantaged and disabled youth.

"I'm pleased that so many Kansas charities have been able to benefit from the honoraria that is offered by some of the groups that I speak to, " Dole said. "I enjoy communicating my message, but knowing that people in need will often benefit makes it all the more worthwhile."

Since 1990, all honoraria has been directed to charity. 1990, Senator Dole earned and donated a total of \$47,700 to charities. Of this amount \$34,500 was donated to Kansas charities. In 1991, Senator Dole earned and donated a total of \$65,000 to charities. Of this amount \$45,000 was donated to Kansas charities.
