Rostenkowski Offers Tax Changes



WASHINGTON, June 21 — Representative Dan M. Rostenkowski, the chairman of the House Ways and Means Committee, today proposed scaling back the tax advantages of a variety of insurance products and increasing the tax burden on military contractors.

Those changes, he said, would help pay for extensions of several expiring tax breaks and provide relief for mutual fund shareholders and farmers.

Absent from Mr. Rostenkowski's list of revenue-raising measures were various proposals recently considered by a Ways and Means subcommittee to tax more types of income-producing activities carried on by museums, nonprofit hospitals and other tax-exempt organizations.

Subcommittee members said in an interview that a package of proposals failed to win sufficient votes at a recent subcommittee meeting. While they did not rule out the possibility that the proposals would come up again this year, the lawmakers said the proposals would not be made part of the current tax package.

Mr. Rostenkowski's 94-page list of recommended tax changes was presented to committee members as they met behind closed doors to begin work on a bill aimed primarily at making "technical corrections" and other minor changes in the Tax Reform Act of 1986 and renewing various tax benefits that have expired re-

cently or are scheduled to expire this year.

No decisions were made today. The committee is scheduled to begin drafting the tax bill on Wednesday, and aides hoped the package could be completed this week.

The most heated debate at today's session centered on the life insurance proposals, members of the committee said.

Mr. Rostenkowski's recommendations were broader than those considered by the committee during recent hearings on restricting the tax advantages of single-premium life insurance policies. Under certain circumstances, Mr. Rostenkowski's proposals would also restrict the tax advantages of other investment-oriented life insurance policies, including universal-life policies and deferred annuities. In general, the proposals would impose harsher tax treatment on policy loans and distributions made from contracts that require less than 20 years of premium payments.

The proposals would affect amounts attributable to premiums paid beginning today.

The package proposed by Mr. Ros-

tenkowski, the Illinois Democrat, included tax changes costing \$6 billion over three years and an offsetting \$6 billion in revenue-raising measures. While changes to specific proposals are expected to be made by members, Mr. Rostenkowski's package is likely to form the general outline for any bill that eventually emerges from the committee.

Mr. Rostenkowski also proposed completely repealing a preferential accounting method used by military contractors and large building contractors to defer taxes. This "completed contract" method of accounting was sharply curtailed in the 1986 act. The latest proposal would cost the contractors \$2.4 billion over three years.

Mr. Rostenkowski's list also did not include a proposal to impose a 5 percent withholding tax on interest paid to foreign investors. The proposal was contained in an earlier list of options distributed to committee members.

Included on the list was a proposal that would provide relief for millions of mutual fund shareholders. Under a provision of the 1986 law, shareholders would have to pay tax this year on certain fund operating expenses, including investment advisory fees.

Among the expiring tax breaks that Mr. Rostenkowski proposed extending through 1990 are the credit for research and development expenditures, the "targeted jobs" credit for employers who hire disadvantaged youths, the exclusion for mortgage

revenue bonds issued by states to help first-time home buyers, the exclusion for tuition payments received by employees from company-sponsored educational assistance programs and the credit available for investors in low-income housing projects.

Tightening Eligibility

Not included on the list was the exclusion for company-sponsored group legal services plans, which labor groups had pushed hard to renew.

In proposing the extensions, Mr. Rostenkowski also recommended tightening some eligibility requirements. For example, the educational assistance exclusion would no longer be allowed for education leading to a postgraduate degree, except for graduate teaching or research assistants.

Mr. Rostenkowski also proposed providing relief for farmers and boat owners from a new system for collecting tax on diesel fuel. Both groups have long been exempt from diesel fuel taxes. But under the new method, the tax is collected at the wholesale rather than the retail level, and farmers and boat owners have to pay the tax and then file for a refund.

Other revenue-raising proposals included in the Rostenkowski package would require certain corporations to speed up payment of estimated taxes; reduce the deduction available to corporations investing in the stock of another corporation to 50 percent of dividends received, from 70 percent, and repeal a special provision in the 1986 act that allowed corporations owned by Alaskan tribes to sell tax losses to profitable companies.


