RE: Speech to the National Automobile Dealers Association

There will be 500 people attending NADA's Washington Conference. The attendees include presidents, vice presidents and executives of State and City Dealer Associations; NADA Board of Directors and the national leadership of NADA's Dealer Election Action Committee. These people represent more than 25,000 family-owned new car and new truck dealerships that employ more than 865,000 people.

They would like you to provide an outlook of the coming elections. There will be time for discussion and Q&A.

BUDGET TALKING POINTS

• CONGRESS IS TRULY IN AN ENVIABLE POSITION THIS YEAR, BECAUSE FOR THE FIRST TIME IN MANY, MANY YEARS EACH CHAMBER HAS PASSED ALL THE REGULAR APPROPRIATIONS BILLS. AND NOW, ALL OF THEM ARE IN CONFERENCE.

• THAT MEANS THAT THERE IS NO REASON WHY WE CANNOT BEGIN THE NEW FISCAL YEAR, ON OCTOBER 1, WITH ALL THE REGULAR APPROPRIATIONS BILLS SIGNED INTO LAW. IN OTHER WORDS, WITHOUT THE CLIFFHANGER, WILL THE GOVERNMENT BE SHUT DOWN, WILL THE SOCIAL SECURITY CHECKS BE MAILED, OR NAVY SHIPS STOPPED IN MID-SEA.

• I SAID THERE IS NO REASON FOR THIS FISCAL BRINKSMANSHIP --BUT KNOWING CONGRESS THAT DOESN'T MEAN IT WON'T HAPPEN. THERE ARE BOUND TO BE SOME CONTENTIOUS ISSUES THAT WILL HOLD UP AT LEAST A COUPLE OF THE APPROPRIATIONS BILLS -- SPECIFICALLY DEFENSE AND PERHAPS THE LABOR, HHS FUNDING BILLS. - 2 -

• CONGRESS DID AS WELL AS IT DID ON THE BUDGET FRONT THIS YEAR BECAUSE OF THE BUDGET SUMMIT AGREEMENT WHICH WAS REACHED FOLLOWING "BLACK MONDAY" LAST OCTOBER. THE PARAMETERS OF FEDERAL SPENDING WERE PRETTY CAREFULLY DRAWN -- SO CONGRESS HAD VERY LITTLE FLEXIBILITY.

• NEXT YEAR IS ANOTHER STORY. I CERTAINLY HOPE THAT WE HAVE A BUSH ADMINISTRATION, WHICH WILL STICK BY THE COMMITMENT TO CONTINUE TO REDUCE FEDERAL SPENDING, TO ENACT A BALANCED BUDGET AND LINE ITEM VETO AMENDMENT, AND NOT TO RAISE TAXES. IF THERE IS A DUKAKIS ADMINISTRATION, WELL, THEY DON'T CALL IT "TAXACHUSETTS" FOR NOTHING. HOLD ON TO YOUR WALLETS.

TALKING POINTS ON VERTICAL PRICING BILL (S. 430)

- S.430 amends the Sherman Act by lowering the standard of proof needed to bring a vertical price fixing case before a judge. This is very controversial. I understand that NADA is one of the groups opposing the bill because of this portion of the legislation.
- It also reaffirms that vertical price fixing is per se illegal under the antitrust laws. Since the per se rule is merely a recodification of current law, it is relatively noncontroversial with everyone except, perhaps, the Administration.
- o The bill will overturn the principle point of the <u>Monsanto</u> Supreme Court case. Under current law, a plaintiff must show concerted action on the part of the defendants. The Court interpreted this to mean that there must be "something more than evidence of complaints by other dealers" to show concerted action to fix prices.
- S. 430 would change the evidentiary standard to provide that a complaint letter from one customer to the supplier would be enough to bring the case to the trier of fact.
- The Administration objects to S.430 primarily because it unnecessarily changes the burden of proof in such antitrust cases.
- Senator Byrd has reaffirmed that he wants to bring up S. 430 again this year. However, I would not expect the bill to get any less controverial as we get closer to the end of the session.
