

WE'VE ALL PRETTY WELL PUT-OUT OF OUR HEADS BOTH THE GAS LINES, AND THE PANIC HEADLINES, OF THE 1970'S. AND CERTAINLY, THERE HAVE BEEN SOME MAJOR CHANGES SINCE THEN, IN HOW THE MARKET IS STRUCTURED AND OPERATES. BUT OVER-DEPENDENCE ON FOREIGN OIL IS STILL A THREAT TO AMERICAN -19-
