#### BACKGROUND

The event is a luncheon/political briefing for the National Federation of Republican Women "Regents." Regents are high-dollar donors -- politically active and influential. You will be seated with Judy Hughs, President of the National Federation. Judy will also introduce you.

You speak first, at approximately 2:50 p.m. Total time is 10 to 15 minutes. You may open it up to questions if you wish. You will be followed by Ed Rollins, Jean Kirkpatrick, Dave Carney, Judy Kilberg and Susan Engeleiter. Because this group will get a good dose of party politics from Rollins and Carney, the Federation suggests you focus more on issues than party politics. This is not iron clad, however. Certainly, you can raise any issue you want. Walt and I have prepared a brief introduction and some talking points focusing on domestic issues.

#### NATIONAL FEDERATION OF REPUBLICAN WOMEN

NFRW is the largest women's political organization in the country, with 140,000 members in 2,600 clubs throughout the 50 states, D.C., Puerto Rico and the Virgin Islands. It was founded in 1938 and concentrates on grassroots efforts.

## THE SPENDING FREEZE

  SMALL FAMILY PROVIDERS OUT OF THE MARKET.

THE ABC BILL DISCRIMINATES AGAINST CHURCHES THAT PROVIDE CHILD CARE. PARENTS WHO WANT THEIR CHILDREN CARED FOR IN A RELIGIOUS ENVIRONMENT WOULDN'T SEE ANY BENEFIT FROM THE ABC BILL. WHAT'S MORE...FAMILY PROVIDERS WITH RELIGIOUS CONVICTIONS WOULD BE FORCED TO SUPPRESS ALL EXPRESSION OF THESE CONVICTIONS OR CEASE PROVIDING LICENSED CARE.

BEIJING "CHEAP SHOTS" FROM CAPITOL HILL; BUSH FOREIGN POLICY CRITICS CAN'T HAVE IT BOTH WAYS: "FREEDOM JUST AS PRECIOUS IN NICARAGUA AS IT IS IN CHINA".

DOLE SAYS BUSH BATTING 1.000 ON FOREIGN AFFAIRS

WASHINGTON -- TELLING LIBERAL DEMOCRATS "YOU CAN'T HAVE IT BOTH WAYS", SENATE REPUBLICAN LEADER BOB DOLE TODAY ACCUSED CONGRESSIONAL CRITICS OF PRESIDENT BUSH'S FOREIGN POLICY OF "HYPOCRISY" WHEN IT COMES TO "SUPPORTING FREEDOM IN BEIJING BUT TURNING A COLD SHOULDER ON THE STRUGGLE IN NICARAGUA."

"PRESIDENT BUSH IS BATTING A THOUSAND ON THE MAJOR FOREIGN POLICY CHALLENGES OF HIS FIRST FOUR MONTHS IN OFFICE," DOLE SAID "I WISH THE PRESIDENT'S CRITICS WERE AS SENSIBLE AND CONSISTENT AS HE HAS BEEN, IN DEFENSE OF BOTH FREEDOM AND AMERICA'S OWN SECURITY INTERESTS."

"Happily, most of the Congress has supported the President, most of the time. But there are always a few who can't avoid taking pot-shots -- cheap shots -- from the sidelines. They want the President to speak out on behalf of demonstrating students in Beijing, but are themselves silent at the repression of democratic expression in Nicaragua. They rail against a rigged election in Panama, but are silent about a sham election law in Nicaragua. They leap to the bait of every Soviet arms control gambit or grudging political reform, demanding that we respond though new concessions contrary to our own interest or negotiating sense; but don't even stand behind the President in our internal negotiations with our NATO allies.

"President Bush has shown a firm and steady hand in dealing with crises from Panama to China, and is taking an informed, common-sense approach to relations with the Soviet Union," Dole said. "In each case, the President has put us on the right side -- the side of freedom. And he's done it in a way that also enhances our broader security interests."

"On China, the President said the students' goals are right, but -- recognizing that chaos in Beijing would serve neither the students' interests nor ours -- he's also urged that they go about their demonstrations responsibly and peacefully.

"President Bush sent a clear message to Noriega that we'll settle for nothing less than democracy in Panama, and he's working on a bipartisan basis with Congress to develop a sharply focused effort to achieve that goal.

"The bottom line, though," Dole concluded, "is that the American people elected George Bush -- and not these critics -to run our foreign policy. He deserves support, not partisan criticism. For the interest of the nation, I hope he will have #
