Dear Senator Dole:

The National Archives is planning a series of events to commemorate the 50th anniversary of America's participation in World War II. The commemoration will have a national focus, involving not only the National Archives in Washington but the 11 Regional Archives and eight Presidential libraries located in 15 states which are part of the National Archives system.

Events are planned for the full four year period, 1991-1995, and will include three major exhibitions, two of which will travel nationwide, film festivals, symposia, conferences, and educational workshops. As custodian of the Nation's history, it is the privilege of the National Archives to lead the commemoration. Our World War II holdings, visual and written, are without parallel in the world. All public programs will be funded by the private sector.

As archivists and historians it seems to us that this 50th anniversary rememberance should honor the American people, those in the armed forces, in war industry, and in agriculture. This was a war of clear and high purpose and our commemorative programs will focus on that fact.

I feel that these activities will be stimulated and enhanced by the presence of a sponsoring committee, a committee comprised of Government officials who are World War II veterans. It would be a privilege and an assurance to me to carry out these programs under the auspices of such a committee.

Senator, it will be an honor if you will serve as honorary co-chairman of this committee. It is my wish that the committee be headed by yourself and three other honorary co-chairs, all World War II veterans, with equal representation from the House and Senate. Being mindful of your heavy Congressional obligations, I want to assure you that I intend very limited demands on your schedule. From time to time, I would seek your counsel on matters of importance, beyond that, there would be several select commemorative events where I would ask your attendance. On that basis, I hope you will agree to serve.

One such event, tentatively scheduled for early October, will be a luncheon on Capitol Hill to "kickoff" the program with a presentation to the committee. The luncheon invitation would be extended to all Members of Congress who served in the armed forces during World War II.
