SUBJECT: Maryland Federal of Republican Women Speech

Time and Place

Dirksen Auditorium, 12:00.

Format

They want you to speak 10 to 15 minutes with questions afterwards, if you like. Rep. Connie Morella will introduce you.

The main purpose of this forum is honor Republican women running for office. They want you to discuss the importance of women running for local office, as well as the roster of Republican women running for Senate (Judy has attached talking points). In addition, they want you to discuss timely subjects: the budget situation, the Senate's agenda, and the break out of freedom around the world (I have attached talking points).

Audience

About 175 Maryland Republican women, many of whom are candidates, political appointees, and officeholders.

THE BUDGET

- O THIS MORNING I WAS DOWN OUT THE WHITE HOUSE WITH THE PRESIDENT AND THE FOUR CONGRESSIONAL LEADERS TO SET AN AGENDA FOR A BUDGET SUMMIT. I THINK WE ALL AGREE THE TIME HAS COME TO PUT A BOLD PLAN ON THE TABLE.
- O THIS YEAR WE WILL PAY ABOUT \$180 BILLION IN INTEREST.

 INFLATION, INTEREST RATES, AND THE TRADE DEFICIT ARE GETTING WORSE. AND MOST IMPORTANTLY, THE FEDERAL DEFICIT ESTIMATES FOR 1991 APPEAR TO BE RAPIDLY MOVING UPWARD -- FROM \$100 BILLION TO \$150 BILLION IN JUST A COUPLE OF MONTHS.
- O THE BOTTOM LINE IS THAT IF WE DO NOTHING WE WILL FACE A SEQUESTER OF UP TO \$100 BILLION -- THAT'S A 20% CUT OFF OF ALL SEQUESTRABLE GOVERNMENT PROGRAMS. QUITE SIMPLY, WE CAN'T GET BY WITH ANOTHER SLIDE-BY BUDGET.
- O ALTHOUGH CONVENTIONAL WISDOM SAYS YOU CANNOT DO ANYTHING REAL ON THE BUDGET IN AN ELECTION YEAR, I HAPPEN TO THINK MAKING THE TOUGH CHOICES IS GOOD POLICY AND GOOD POLITICS. IF WE COULD CONVINCE THE AMERICAN PEOPLE THAT WE ARE DOING THE RIGHT THING FOR THE RIGHT REASONS -- BECAUSE WE ARE CONCERNED ABOUT THEIR CHILDREN AND GRANDCHILDREN -- THEN, I BELIEVE WE WOULD HAVE WIDESPREAD SUPPORT AROUND THE COUNTRY.
- O I HOPE WHEN THE TIME COMES WE WILL HAVE YOUR SUPPORT.

U.S. SOVIET RELATIONS

- O A LOT HAS HAPPENED IN U.S.-SOVIET RELATIONS THESE PAST COUPLE OF YEARS -- ALMOST ALL OF IT POSITIVE.
- O WE'VE SIGNED THE FIRST TREATY EVER THAT ACTUALLY REDUCED THE NUCLEAR ARSENALS OF THE TWO SUPERPOWERS. WE'VE TAKEN DRAMATIC STRIDES IN ENDING, OR REDUCING THE LEVEL OF REGIONAL CONFLICTS. WE'VE SEEN REMARKABLE CHANGES IN THE POLITICAL AND HUMAN RIGHTS ENVIRONMENT INSIDE THE SOVIET UNION. AND, MOST DRAMATIC OF ALL, WE'VE SEEN A VIRTUAL EXPLOSION OF DEMOCRACY IN EASTERN EUROPE AND ELSEWHERE AROUND THE GLOBE.
- O MANY OF THESE PROFOUND CHANGES HAVE COME -- DIRECTLY OR INDIRECTLY -- AS A RESULT OF INITIATIVES AND POLICIES PURSUED BY PRESIDENT GORBACHEV, AND BY PRESIDENTS REAGAN AND BUSH. THEY HAVE COME AS A RESULT OF CHANGES INSIDE THE SOVIET UNION, AND IN EAST-WEST RELATIONS.

STILL A LONG WAY TO GO

- O SO WE HAVE COME A LONG WAY. I HOPE THE SOVIET UNION WILL UNDERSTAND THAT -- WHATEVER OUR CURRENT PROBLEMS, AND THERE ARE SOME -- WE DO UNDERSTAND HOW MUCH PROGRESS HAS BEEN MADE, IN A SHORT PERIOD OF TIME. AND WE WANT, VERY MUCH, TO MAKE EVEN MORE PROGRESS IN THE DAYS AND MONTHS AHEAD.
- O SO WE HAVE COME A LONG WAY, BUT WE STILL HAVE A LONG WAY TO GO. AND THE ROAD TOWARD OUR DESTINATION IS NOT ALWAYS GOING TO BE STRAIGHT AND EASY. IT DOESN'T DO EITHER OF OUR NATIONS ANY GOOD TO IGNORE, OR FORGET, THAT.

- AN EXCITING YEAR FOR THE REPUBLICAN PARTY NATIONWIDE, BUT PARTICULARLY IN MARYLAND WITH SO MANY QUALIFIED WOMEN CANDIDATES RUNNING AT LOCAL AND STATEWIDE LEVELS.
- THE NEED TO ENERGIZE REPUBLICAN VOTERS FROM THE GRASSROOTS LEVEL UP: FROM THOSE WHO REPRESENT OUR NATIONAL REPUBLICAN AGENDA (CONNIE MORELLA AND HELEN BENTLEY), THE STATE LEGISLATURE, HOUSE OF DELEGATES, AND IMPORTANT LOCAL OFFICES, THIS IS A YEAR OF OPPORTUNITIES.
- THE EXCITEMENT OF HAVING SO MANY QUALIFIED REPUBLICAN CHALLENGERS WHO ARE WOMEN. IN FACT WE HAVE THREE VERY PROMINENT REPUBLICAN WOMEN RUNNING NECK AND NECK WITH THEIR OPPONENTS FOR THE UNITED STATES SENATE:

LYNN MARTIN


RIGHT NOW, PAUL SIMON IS VULNERABLE WITH AN EXTREMELY HIGH UNFAVORABLE RATING. HEAD TO HEAD WITH LYNN, SIMON IS HOVERING AROUND 50% AMONG ILLINOIS VOTERS; BARELY A MAJORITY OF THE VOTE. LYNN'S CANDIDACY HAS ENORMOUS ROOM FOR GROWTH, AND ILLINOIS VOTERS ARE JUST GETTING TO KNOW HER. RECENT SURVEY DATA INDICATES THAT THOSE WHO HAVE TAKEN A CLOSE LOOK AT LYNN LIKE HER MESSAGE. (NOTE: RIGHT NOW, HER NAME RECOGNITION IS LOW, AND ONLY 1/3 OF ILLINOIS VOTERS HAVE FORMED AN OPINION ABOUT HER.)

CLAUDINE SCHNEIDER

OUR MOST EXCITING RACE OF THE COUNTRY IS HAPPENING IN RHODE ISLAND WITH CLAUDINE SCHNEIDER, AN ENERGETIC CANDIDATE WHO IS WELL KNOWN AND WELL LIKED. RIGHT NOW SHE'S WITHIN A 10 POINT STRIKING DISTANCE OF CLAIBORNE PELL, WITH AN APPEALING, FUTURISTIC, ENERGETIC OUTLOOK WHICH IS SELLING.

PAT SAIKI

WE MAY HAVE ANOTHER EXCITING, ENERGETIC WOMAN CANDIDATE IN PAT SAIKI. ACCORDING TO THIS WEEK'S STATISTICAL INFORMATION, RECENTLY APPOINTED SENATOR AKAKA IS ONLY UP 43% TO 42% OVER SAIKI, WHO HASN'T EVEN ANNOUNCED HER CANDIDACY YET. (NOTE: AS YOU KNOW, SHE HAS A PRIMARY CHALLENGER.
