# NATIONAL GRAIN AND FEED 19th ANNUAL COUNTRY ELEVATOR COUNCIL MEETING

I APPRECIATE THIS OPPORTUNITY TO SPEAK TO THIS OUTSTANDING AUDIENCE. YOU ARE THE MEN AND WOMEN WHO MAKE IT HAPPEN, THE DEDICATED WORKERS WHO MERCHANDISE, PROCESS AND EXPORT AMERICA'S UNRIVALED BOUNTY. I AM PLEASED TO WELCOME YOU TO KANSAS, AND TO THANK YOU FOR ALL OF YOUR GOOD WORK.



THIS HAS BEEN A CHALLENGING YEAR FOR AGRICULTURE. CONGRESS SPENT FAR TOO LONG ON SHAPING A NEW FARM BILL, A BILL THAT HAD TO FIT INTO THE TOUGHEST BUDGETARY CONSTRAINTS A FARM BILL HAS EVER FACED. AND ALTHOUGH NO ONE ENJOYS THOSE KIND OF CUTS, A HEALTHIER ECONOMY MEANS PROTECTING AGRICULTURE FROM DOUBLE-

WITH NEAR-RECORD CROPS FILLING GRAIN BINS AROUND THE GLOBE, OUR DOMESTIC MARKET HAS TAKEN A DIVE, EVEN THOUGH OUR BIGGEST CUSTOMER, THE SOVIET UNION, IS DESPERATE FOR FOOD. TRUTH IS, CUTS HAVE IMPACTED FUNDING FOR PROGRAMS SUCH AS THE EXPORT ENHANCEMENT PROGRAM, WHICH HAS ALREADY APPROPRIATED FUNDS SINCE THE BEGINNING OF THE FISCAL YEAR. IT IS TIME FOR NEW IDEAS AND NEW COMMITMENTS TO GET OUR GRAIN MOVING OUT OF OUR PORTS AGAIN.
