LAWRENCE NEWS

- 0 KU CHANCELLOR GENE BUDIG HAS CONTACTED YOU ABOUT THEIR ENDEAVOR TO ESTABLISH AN INTERNATIONAL LECTURE SERIES WHICH WOULD BE KNOWN AS THE "EISENHOWER ADDRESS." HE HAS WRITTEN TO JOHN EISENHOWER, ASKING HIS PERMISSION TO USE THE FAMILY NAME AND SUGGESTS THAT YOU MIGHT WANT TO PUT IN A GOOD WORD AS WELL. I AM PREPARING A LETTER TO JOHN EISENHOWER FOR YOU TO SIGN.
- KU EXPECTS TO INVITE MEXICAN PRESIDENT SALINAS de GOTARI AND WILL LET US KNOW AS SOON AS THEY ARE READY TO APPROACH HIM.
- 0 REN SHULZ WOULD LIKE TO BE APPOINTED STATE DIRECTOR OF THE FARMERS HOME ADMINISTRATION ON AN INTERIM BASIS WHEN JOHN PRICE LEAVES ON NOVEMBER 13TH. SHULZ IS TAKING THIS UP WITH LAVERNE AUSMAN, FmHA ADMINISTRATOR.
- 0 A \$29 MILLION BOND ELECTION FOR NEW ELEMENTARY AND JUNIOR HIGH SCHOOL BUILDINGS IS ON THE BALLOT. THE CITY CONTINUES TO GROW. WHILE VOTERS DID NOT APPROVE FUNDS FOR A NEW HIGH SCHOOL IN 1990, LEADERS FEEL THAT THEY MUST START ADDRESSING NEEDS. EXPECT TO TRY AGAIN IN 1994 FOR FUNDS FOR A SECOND HIGH SCHOOL. WITH 1800, THE H.S. IS THE LARGEST IN THE STATE.
- 0 THE CITY/COUNTY ARE CONTINUING TO FOCUS ON THE EASTERN PARKWAY PROJECT. ARE PREPARING A LAND USE REPORT AND STRATEGIC PLANNING FOR ECONOMIC DEVELOPMENT FOR 2020.
- 0 NO MAJOR LOSSES OR GAINS IN THE COMMUNITY - IS STABLE. DOWNTOWN IS EXCEEDINGLY STRONG. THERE IS TALK OF ANOTHER OUTLET DEVELOPMENT NORTH OF TOWN.
- 0 NEW HOME CONSTRUCTION CONTINUES. ARE ALSO GOOD PUBLIC CONSTRUCTION PROJECTS AT KU.
- 0 STUDENT ENROLLMENT IS UP SLIGHTLY.
