- -- THE ARMED SERVICES COMMITTEE COMPLETED HEARINGS ON THE NEW CLINTON POLICY. THERE ARE SOME LEGAL QUESTIONS STILL TO BE ANSWERED.
- -- I ANTICIPATE THE SENATE TO PUT A POLICY INTO LAW -- SOMETHING MORE RESTRICTIVE THAN WHAT PRESIDENT CLINTON ASKED FOR. BUT I DOUBT THAT IT WILL INCLUDE A TOTAL BAN AS BEFORE.
- -- AS I UNDERSTAND IT, THE NEW POLICY WILL BE CONDUCT BASED, BUT IT WILL PRESERVE THE MILITARY'S ABILITY TO DISCHARGE HOMOSEXUALS. IN PRACTICE, THERE WILL BE VERY LITTLE DIFFERENCE FROM THE CURRENT POLICY -- EXCEPT THAT THE MILITARY WILL NOT BE ALLOWED TO ASK CERTAIN QUESTIONS.
- -- I REMAIN CONCERNED THAT WE ARE MOVING FROM A POLICY THAT PREVENTS GAYS FROM SERVING IN THE MILITARY TO A POLICY THAT ALLOWS GAYS TO SERVE IN THE MILITARY. THERE COULD BE A LOT OF COURT CASES COMING OUT OF THIS.

BACK TO FT. RILEY. WHEN THE

GENERAL DROPPED BY MY OFFICE IN WASHINGTON A COUPLE OF WEEKS BACK TO GIVE ME THE GOOD NEWS THAT HE WAS RETURNING FOR HIS 3RD TOUR HERE -- TO COMMAND THE BIG RED ONE -- IT WAS CLEAR THAT HE WAS LOOKING FORWARD TO RETURNING TO FT. RILEY. THAT IS ANOTHER

TESTAMENT TO STRONG COMMUNITY SPIRIT AND QUALITY OF LIFE WE HAVE HERE. I DON'T KNOW HOW YOU **ESCAPED THE PENTAGON SO** QUICKLY GENERAL ROBLES, BUT WE ARE VERY GLAD TO HAVE YOU BACK. OF COURSE, IF WE GET ANY MORE RAIN, WE MAY START CALLING YOU ADMIRAL.

BRIGHT AS I WOULD LIKE IT TO BE. AND THIS HAS NOTHING TO DO WITH THE LAND EXPANSION ISSUE. IT HAS NOTHING TO DO WITH ANY LACK OF COMMUNITY SUPPORT FOR FT. RILEY. ON THE CONTRARY "CITIZENS FOR A STRONG FT. RILEY" HAS GAINED THE RESPECT AND ADMIRATION OF THE ARMY AND THE

DEPARTMENT OF DEFENSE. OUR CHAMBERS OF COMMERCE ARE MODEL ORGANIZATIONS THAT HAVE KEPT THE TIES CLOSE AND WARM. AND THIS CHAPTER OF THE ASSOCIATION OF THE UNITED STATES ARMY TIES IT ALL TOGETHER TO FORGE A BOND THAT HAS MADE SERVING AT FT. RILEY THE BEST

EXPERIENCE IN ANY SOLDIER'S CAREER. EVERY SOLDIER WHO HAS HAD THE PRIVILEGE TO SERVE WITH THE BIG RED ONE, AND RAISE A FAMILY HERE, KNOWS WHY FT. RILEY MUST REMAIN OPEN AND STRONG. THE FUTURE OF FT. RILEY IS NOT CLOUDED BECAUSE THERE ARE NO THREATS TO OUR

SECURITY OR BECAUSE THE **WORLD IS SUDDENLY A SAFE** PLACE. BOSNIA IS A POWDER KEG THREATENING TO EXPLODE **EUROPE. SADDAM HUSSEIN** REMAINS A BELLIGERENT ADVERSARY. IRAN IS REARMING AT AN ALARMING PACE. NORTH KOREA IS DEVELOPING NUCLEAR WEAPONS. THE

FUTURE STABILITY OF THE FORMER SOVIET UNION IS UNKNOWN. AMERICAN TROOPS ARE STILL IN SOMALIA, MORE HAVE BEEN DEPLOYED TO MACEDONIA, AND SOON OTHERS WILL GO TO HAITI. NO DOUBT ABOUT IT, THE WORLD IS STILL A DANGEROUS PLACE.

THE CHALLENGE THAT FT. RILEY FACES IS THE WHOLE SALE AUCTION OF OUR NATIONAL SECURITY STRUCTURE BY WISHFUL THINKING LIBERALS WHO ARE LOOKING FOR CASH TO FUND THEIR NEW SOCIAL SPENDING SPREE. THE BOTTOM LINE IS THIS. IT IS NOT THAT WE DON'T NEED FT. RILEY. IT IS WHETHER

THE DEFENSE BUDGET IS BEING RAIDED AND OUR FORCES WILL GET WHAT IS LEFT. THE PRESIDENT'S BUDGET PLAN --APPROVED OVER THE **UNANIMOUS OBJECTIONS OF** REPUBLICANS IN BOTH HOUSES -- CALLS FOR SLASHING **AN ADDITIONAL \$120 BILLION OUT OF OUR DEFENSE BUDGET**
