#### MEMORANDUM

#### POLITICAL ENVIRONMENT

The Virginia GOP made solid gains in the '93 elections. Former U.S. Rep. George Allen won the governor's mansion, the first time a Republican has won it in the last 12 years. Jim Gilmore, the GOP nominee for Attorney General, also won, giving Republicans control of two of the three statewide seats. The GOP also gained five seats in the House of Delegates.

There is a political firestorm that you need to be aware of. After Allen won the nomination at the GOP convention, he went to the state party and asked for money for television. Dem. nominee Mary Sue Terry had \$2.2 million in the bank and had just bought \$500,000 worth of T.V. The GOP chairman, Patrick McSweeny, refused to give Allen money to go on T.V. to match Terry's buy. Now that Allen has won, he wants to put his own person in the Chairmanship. McSweeny, however, won't budge and as of today (12/1), it is still a standoff. You will likely be asked about this.

One of our best chances to pick up a Democrat Senate scal in 1994 is in Virginia. Chuck Robb has suffered serious political damage in past years due to allegations about his high-flying lifestyle when he was Virginia's governor from 1983 to 1987 and the more recent, and more damaging, legal problems resulting from his feud with Gov. Doug Wilder. As talk of Robb's impending indictment grew, his political position sank. However, a grand jury did not indict Robb and his political fortunes immediately improved, though they are still very weak.

More recently, there have been press reports that a number of Democrat Party activists have urged Robb to step aside because they fear he will lose the seat. In addition, a canvass of Democrat County Chairmen showed that only 37% of them want him to run for re-election.

The most prominently mentioned name is former Governor Gerald Baliles. However, Democrat Party Chairman Mark Warner, 11th CD Rep. Leslie Byrne, and others have also been mentioned. Richmond attorney Sylvia Clute and former Governor Douglas Wilder have already announced they will run against Robb in the Democrat primary or convention.

#### OLIVER NORTH

Oliver North is a native of upstate New York, but has been a resident of Virginia for over 20 years. He graduated from Annapolis in 1968, commissioned in the Marines and shortly thereafter was assigned as an Infantry Platoon Commander in Vietnam. His military decorations include the Silver Star, the Bronze Star, two Purple Hearts, and three Navy Commendation Medals.

Of course, Oliver North is best known for his involvement in the Iran-Contra Affair. He was indicted, convicted and then, on appeal, the conviction was overturned. North's official position is that he was fully cleared of all legal charges in the so called Iran-Contra Affair on September 16, 1991.

Currently North is chairman and co-founder of Guardian Technologies International, Inc., a Virginia-based manufacturer of protective equipment for law enforcement. He is also president of the Freedom Alliance, a non-profit foundation dedicated to "promoting the principles of individual liberty, a strong defense, and traditional values in national policy." North writes a weekly syndicated newspaper column, broadcasts daily radio commentary and is working on a sequel to his book, <u>Under Fire</u>, an international best seller.

North lives in Fairfax County with his wife Betsy and their four children, Stuart, Tait, Sarah, and Dornin.

#### JAY STEPHENS

Former U.S. Attorney Jay Stephens is a native of Iowa who has lived in the Washington, D.C. area since moving to Virginia in 1973. After graduating from Harvard Law school in 1973, he started his career in the Watergate Special Prosecutor's office and then worked for a period of years with the Overseas Private Investment Corporation. In 1981, he worked at the Justice Department as the Counsel to the Criminal Division Director, and was named Associate Deputy Attorney General by President Reagan. He served two years as the Deputy Counsel to Reagan and was appointed U.S. Attorney in 1988.

Stephens is perhaps best known for his successful prosecution of former D.C. Mayor Marion Barry. Earlier in the year, there was controversy surrounding Attorney General Janet Reno's firing of all U.S. Attorneys, with the most controversial firing being that of Jay Stephens. Stephens was in the middle of the probe into Congressman Dan Rostenkowski's office accounts.

Stephens has also been mentioned recently as a candidate for the 8th CD against Rep. Jim Moran.

Stephens is married and has three children.

#### JIM MILLER

Jim Miller is the recently resigned Chairman of Citizens for a Sound Economy, a free market advocacy group. He lectures at George Mason University where he is a John M. Olin Distinguished Fellow at the Center for Study of Public Choice.

Miller is also involved in several business endeavors. He is Chairman of the Advisory Board of Capital Economics as well as a member of several boards of various advisory groups and small investment corporations.

Miller is probably best known as President Reagan's OMB Director from 1985 - 1988. Prior to that, he was Chairman of the Federal Trade Commission from 1981 - 1985.

Miller holds a Ph.D. in economics from the University of Virginia and has written over 100 articles in professional journals. He has authored, co-authored or edited seven books, the most recent of which is <u>The Economist as Reformer: Revamping the FTC.</u> 1981-1985.

Miller resides in McLean and is married with three children.

Senate Race Update

- The VA Dem Central Committee meets 12/11 to decide the method for selecting a nominee. Sen. Robb prefers a primary rather than a party convention as does Wilder. However, a primary could case more clashes within the Democratic party resulting in a sure Republican win.
- A telephone survey of VA Dem party local chairs by the Charlottesville Daily Progress found most "do not favor" either Sen. Robb or Gov. Wilder. Of the 146 elected local and district Dem chairs, 110 responded to the survey conducted 11/22-26. Only 37% of the 110 favor Robb, 10% favor Wilder, and more than half said they were undecided about who the party should nominate for Robb's seat or that they favor some candidate other than Robb or Wilder.
- On the convention vs. primary, the above poll showed that 49% favor a convention, one-third favor a primary and 18% are undecided.
- As you know, there has been a recruitment effort taking place to persuade ex-Joint Chief of Staff Chair Gen. Colin Powell to run for Senate.

Allen - McSweeney Feud

O On December 4, the VA GOP Central Committee voted 48-25 to ask VA GOP Chair Patrick McSweeney to resign, but he refused. McSweeney argued that he was "elected to a four-year term by thousands of delegates" to the '92 VA convention. Governorelect Allen will not deal with McSweeney on party matters and will instead work through congressional district and local chairmen.

Farris - Warner Feud

 As Senator Warner would not endorse Farris for the LG spot, Farris, backed by his supporters, is considering a run for Senate in 1996.

\*19 VIRGINIA: GOP CMTE VOTE SAYS RESIGN, BUT MCSWEENEY WON'T GO The VA GOP Central Cmte 12/4 voted 48-25 to ask VA GOP Chair Patrick McSweeney to resign, but McSweeney refused. Noting that he was "elected to a four-year term by thousands of delegates" to the '92 VA convention, McSweeney: "Those are the people that I have to answer to." The vote count was "seven votes short of the [75%] needed to oust" a party chair. Gov.-elect George Allen (R), who did not attend the meeting, sought McSweeney's resignation due to his belief that McSweeney "did not do enough to help" his recent campaign and "tried to prevent his nomination, which McSweeney says is not true." Allen "said he would not deal with McSweeney on party matters and would instead work through congressional district and local chairmen." An Allen letter read to the Cmte prior to the vote said he no longer trusted McSweeney. Allen, from the letter: "Reconciliation is impossible." VCU's Robert Holsworth said the "very visible public squabble ... could undermine one of the reasons for Allen's 17-point victory": "The public voted not only for policy change, but for a change to the internal bickering that has consumed the Democratic Party" (Whitley, RICHMOND TIMES-DISPATCH, 12/5). If the vote was a victory for Allen, "some of [Allen's] own supporters acknowledge that it came at an especially high cost. ... It is unfortunate symbolism that one of his first public acts be a purge of his enemies" (Harris, W. POST, 12/5). Allen CoS Jay Timmons: "Some honest differences were aired. The vote hopefully has put that behind us" (AP/W. TIMES, 12/5).

\*12 VIRGINIA: WILDER ACCUSES DEM CHAIR WARNER OF SELF-PROMOTION Two days before Dems meet in Richmond to choose a nominating procedure, Gov. Doug Wilder (D) "suggested" that VA Dem Chair Mark Warner "was promoting a convention so he could become the party's nominee." Wilder, who picked Warner to be Dem chair: "He's supposed to be my friend." Wilder noted Kenneth Gerce, VA Dem vice-chair for finance, "has been quoted as saying that the party needs 'a reasonably well accomplished, but young, white male professional without baggage who can stand up and say, 'I'm not Oliver North.'" Wilder said Warner "does fit that mold." Wilder made his comments after a ceremony naming the Richmond federal courthouse after retired Supreme Court Justice Lewis Powell. Sen. Charles Robb (D) also attended the ceremony, where he and Wilder "shook hands tentatively." Though Wilder, Robb and Dem attys Dan Alcorn and Sylvia Clute "back a primary, many steering committee members favor a convention. ... Privately, they say they feel a convention would give the party a chance to come up with an alternative to Robb and Wilder. ... They don't see Alcorn or Clute as viable alternatives." Warner said 12/9 that he is not interested in running for the Senate: "My intention is to be party chair. ... My job is to try to keep this party united and to minimize dissention. This means I should remain a neutral arbiter throughout this debate about the process" (Whitley, RICHMOND TIMES-DISPATCH, 12/10). Wilder also "accused" Dem Party leaders of "wanting a convention ... because they 'would love to get rid of me so I'd no longer be a thorn in their side.'" Warner said he was "disappointed by the tenor of the governor's comments," and said that he told Geros to "recant or apologize" at the 12/11 Dem gathering "if the vice chairman hopes to retain his party post" (Baker, W. POST, 12/11).

PRIMARY MOMENTUM: FAIRFAX JOURNAL'S Gomlak reports "party activists said members are still divided on the question" of whether to have a primary or convention. "But they said there also appears to be growing support for an early" 6/94 June primary. Alcorn said there is a feeling that a "primary has the momentum" (12/10).

ONE SOLUTION TO XMAS SHOPPING: North "has come up with an unusual way to raise money for his campaign: Give \$40 and you get an autographed copy of his new book." North recently sent letters to potential supporters advertising that for a minimum contribution of \$40 he would send you a "personally autographed copy of 'One More Mission.'" North spokesperson Mark Merritt "said the campaign mailing could sell as many as 5,000 copies -which would bring in as much as \$100,000." Both Merritt and a spokesperson for the publisher "say North will not profit personally from the arrangement. He bought the books involved at a discount and will not receive author's royalties on those copies." Politicians "familiar with campaign fund-raising say the arrangement is unusual but appears to be legal." The FEC "has previously allowed campaign organizations to profit from the sale of books or art." The letter notes: "In full disclosure, please know that almost half of your contribution of \$40 will go to pay

for the book and to cover the cost of postage and handling. But you will also be helping the Oliver North for U.S. Senate Committee" (Jenkins, W. POST, 12/11). Also running: Ex-U.S. Atty Jay Stevens and ex-OMB Dir. James Miller (R) and atty Sylvia Clute (D). Possible: Ex-Gov. Gerald Baliles (D).

With his recent public statements on new gun-control initiatives, President Clinton is elevating showmanship over substance, politics over good policy.

Earlier this year, Senate Republicans and Democrats were able to put aside their partisan differences and pass a truly bipartisan \$22 billion anticrime package. #### **DEFENSE BUDGET CUT TOO FAR, TOO FAST**

DOLE URGES PRESIDENT TO REEVALUATE HUGE CUTS IN DEFENSE, LISTEN TO MILITARY EXPERTS

WASHINGTON - In a joint letter today to President Clinton, Senate Republican Leader Bob Dole, Senator Strom Thurmond (R-SC), and Senator Pete Domenici (R-NM) called on the President to reevaluate his plans for deeper defense cuts and to listen to his military experts who are saying that deeper cuts could put American security in jeopardy.

Senator Strom Thurmond, Ranking Member of the Senate Armed. Services Committee, and Senator Pete Domenici, Ranking Member of the Senate Budget Committee joined Senator Dole in expressing their concern about the deep cuts in the Clinton budget plan.

"Earlier this year, many of us in the Senate expressed our dismay when President Clinton called for cutting an additional S127 billion from our defense program", said Dole. "This was double the amount candidate Clinton had campaigned on."

"It seems to me the Administration went about this backwards. The President laid out a budget plan slashing defense by \$127 billion, persuaded Democrats in Congress to pass it, and then asked his military experts what our defense needs are for the post cold war world", said Dole, referring to the so-called Bottom Up Review released in August. "No one was surprised when the facts showed we were cutting too fast, too far to do the tob. "

"On one hand, the President has sought to expand our military operations around the world in these so-called peace keeping operations, while his budget cuts bring defense spending below a level not seen since before Pearl Harbor. In my view, it is time to sound a wake up call and take a look around the world. North Korea, Iran, Bosnia, Irag -- you don't have to look too far to see the world is still a dangerous place", said Dole.


"Senators Thurmond, Domenici, and I encourage the President to take this matter under personal advisement and to remember the lessons of the past when America cut defense too far, too fast", said Dole. "As Commander-in-Chief, I know he will not delegate responsibility for our national security to the budget people."



Biography

Bob Goodlatte, age 40, has lived in the Sixth Congressional District of Virginia all his adult life.

From 1974 to 1977, Bob attended Washington and Lee University School of Law where he earned his law degree. While in Lexington, he and his wife, Maryellen were married in Lee Chapel.

Bob earned his undergraduate degree in Government from Bates College in Lewiston, Maine. He graduated with honors in the Department of Government. Bob was active in many college organizations and was elected president of the Representative Assembly (student government).

After earning his law degree at W & L. Bob went to work for then Congressman Caldwell Butler. He served as Congressman Butler's District Office Manager from 1977 to 1979. During that time, Bob regularly traveled to Covington, Lynchburg, Roanoke, Lexington, Hot Springs, Troutville, Staunton, Waynesboro, Monterey, and throughout the district, meeting with and helping the residents. Not only did Bob Goodlatte listen to the governmental policy concerns of Sixth District citizens, he also helped unsnarl the often tangled web of federal regulations as they affected individuals and businesses.

In 1980 Bob founded his own private law practice in Roanoke. Two years later he became a partner in the law firm of Bird, Kinder, & Huffman where he worked until his election to Congress in 1992.

Bob has long been active in his community. He served as the President of the Civitan Club of Roanoke from 1989 until 1990 and he has been an active member since 1985. That organization is a major sponsor of Special Olympics and helps the handicapped and less privileged in the community.

From 1989 until the present, Bob has been a member of the Building Better Boards Advisory Council, an affiliate of the United Way of the Roanoke Valley. That council has provided assistance and guidance to the volunteer boards of local charitable organizations.

Since 1988, Bob has been an active member of the Parent Teachers Association of Fishburne Park Elementary School, the public school of his children.

Bob was elected to Congress in 1992. He won an open seat created when Democrat Congressman Jim Olin, retired after serving a decade. The campaign was his first attempt at public office.

Bob serves on the Judiciary Committee and the Agricultural Committee. His subcommittee assignments on Judiciary are: the Economic and Commercial Law Subcommittee and the Administrative Law and Governmental Relations Subcommittee. His subcommittee assignments on Agriculture are: the Livestock subcommittee and the Specialty Crops and Natural Resources Subcommittee.

The Economic and Commercial Law Subcommittee is an especially important subcommittee which deals with key business issues such as the Line Item, the Balanced Budget Amendment, anti-trust law and bankruptcy law.

The Path to Washington: Although this

is Goodlatte's first elected office, he is a longtime GOP activist, going back to his days as president of the student Republicans at Bates College in Maine. Many years later, Goodlatte was still involved in party politics as a top aide to GOP Rep. M. Caldwell Butler, and then as chairman of the 6th District Republican Party. He also headed the local Bush-for-President effort in 1988 and the local committee to reelect Republican Sen. John W. Warner in 1990.

Goodlatte had thought about running for Congress in 1986, but the arrival of his second child at the start of the campaign season kept him from entering the race. When incumbent Democrat Jim Olin chose not to seek re-election in 1992, Goodlatte decided the time was right, and he campaigned on the promise to exert "Republican leadership ... for a change."

In previous years in the district, the GOP has fought internally over its congressional nominee because of clashes between more traditional Republicans and conservative religious activists. But within weeks of his decision to run, Goodlatte had united these antagonistic elements behind him, leaving the rancor to the Democrats.

Stephen Alan Musselwhite, an insurance executive and a moderate, emerged with the Democratic nomination, but he was never able to unite the party behind him.

Although Goodlatte went out of his way during the campaign to stress his opposition to organized labor's legislative agenda, labor leaders refused to back Musselwhite, in large part because he did not back legislation to ban employers from permanently replacing striking workers.

Musselwhite also had to contend with bad publicity over letters he wrote to a judge asking for leniency for two white-collar criminals.

The 6th, which had been held by the GOP for 30 years before Olin's 1982 election, is generally described as a moderate-to-conservative district. Goodlatte believes he fits that description philosophically, and says that in his mind this means a "limited government, decentralized, not trying to solve every problem with more spending programs and with regulation."



Like so many first-year members, Goodlatte supports a balanced-budget amendment and a presidential line-item veto. Yet unlike most freshmen, Goodlatte opposed all budget plans offered on the House floor in March 1993, including a Republican substitute by John R. Kasich of Ohio that received the support of all but 41 Republicans but which Goodlatte believed did not go far enough in reducing the deficit.

Goodlatte backs term limits and was among a group of GOP members who pushed through a rule prohibiting anyone in the Republican caucus from holding any top committee post for more than six consecutive years.

Goodlatte's district is the most heavily agricultural in Virginia. It is a district in which poultry and dairy farming predominate. As a result, Goodlatte sought and received a spot on the House Agriculture Committee. He also took a seat on the Judiciary Committee.

Goodlatte says he is also interested in building up his district's economy by helping to expand the high-technology businesses in the district.

Though Goodlatte has not previously held office, he believes that his experience working for the popular Butler — who warmly endorsed him — will be a help.

Goodlatte ran Butler's district offices and gained a firsthand appreciation for the importance of constituent service. His campaign brochures noted that he "made a name for himself serving people of the 6th District" by helping citizens with a host of problems, from cutting through red tape to "finding out why a Social Security check for a senior citizen was late."

Goodlatte opposes abortion except in cases of rape, incest or when the woman's life is in danger. He has said he supports allowing research with fetal tissue, but in March 1993 he voted on the House floor against a Democraticsponsored measure to streamline the guidelines for donating tissue for such research.

On the issue of illegal drugs, Goodlatte says, "The message to criminals must be clear: If you sell drugs to our children, threaten our neighborhoods or injure innocent citizens, you'll be put behind bars for a long time. Guaranteed." Robert W. Goodlatte, R-Va.

#### Virginia 6

The 6th is home to mountains and caverns, dairy farmers and cattle ranchers, isolated towns and large cities - and quite a few Republicans.

The Shenandoah Valley, which runs most of the length of the 6th, cultivated Republicanism long before it was acceptable in other parts of Virginia. The descendants of the area's 18th-century English, German and Scots-Irish settlers feuded with the Tidewater plantation aristocracy and became GOP mavericks in state politics.

The brand of Republicanism in the rural Valley traditionally has been a moderate one; when Virginia's conservative Democrats were identified with resistance to integration in the 1960s, Valley Republicans were progressive on racial issues. The GOP lost its grip on the 6th in the 1980s partly because the state party came to be dominated by staunchly conservative suburbanites outside Washington and Richmond, and by party-switching conservative Democrats. In 1985, when there was no moderate on the Republican ticket, the Democrats running for the three top state offices all carried the 6th. In 1989, the 6th did vote Republican for governor (against black Democrat L. Douglas Wilder), but the Democratic nominees for lieutenant governor and attorney general won the 6th. Goodlatte's 1992 victory ended Democrats' decadelong control of the 6th District House seat.

Roanoke, the major population center in the 6th, has an array of industries producing furniture and electrical products. Its sizable black and union elements make it the base of Democratic strength in the 6th. Bill Clinton won Roanoke by 12 points in 1992. In 1989, Wilder won the city with 59

percent. Democrats also can succeed in towns to the north, such as Covington and Clifton Forge, and in the counties around them, Bath and Alleghany. In his 1985 bid for lieutenant governor. Wilder won these cities but lost the counties. Clinton carried all but Bath. There are chemical plants and pulpwood and paper mills in this area, but the job picture is cloudy. Unemployment in December 1992 was 22 percent in Bath County.

Democratic support in the city of Roanoke is usually surpassed by the Republican vote in Roanoke's suburbs, in Lynchburg and in most of the district's rural areas. The nuclear energy company Babcock & Wilcox is one of Lynchburg's major employers, but the city is best known as the home of evangelist Jerry Falwell, his huge Thomas Road Baptist Church and Falwell-founded Liberty University (10,500 students). Goodlatte won 59 percent in Lynchburg in 1992.

Outside metropolitan Roanoke and Lynchburg, the district depends mainly on dairy farming, livestock and poultry. Rockingham County ranks third in the country in turkeys sold. Tourism enhances the local economy, with visitors traveling to Shenandoah National Park, George Washington National Forest and numerous caverns that dot the valley. Staunton boasts two museums of local notables: One is the house where Woodrow Wilson was born; the other celebrates The Statler Brothers, a country music group.
