Webber Employs Aid of Texas Conservative for Farm Meetings< OKLAHOMA CITY (AP) Democrat Dan Webber and Republican Frank

Lucas talked agriculture and crime as they entered the third-to-last weekend of the 6th District congressional race.

A conservative U.S. House Democrat came to Oklahoma to help Webber on Friday, while Senate Minority Leader Bob Dole stops in Oklahoma City today to support Lucas.

Webber flew to Enid and Elk City on Friday with U.S. Rep. Charles Stenholm, a Texan and senior member of the House Agriculture Committee.

Webber said he and Stenholm drew about 20 people in Enid at an open meeting on the farm bill, trade issues and other concerns.

Lucas, a state representative and Cheyenne rancher, frequently has contrasted his rural background with Webber's years in Washington as an aide to Sen. David Boren, D-Okla.

But Webber, an Okarche native, said he thoroughly understands the lead role agriculture takes in the economy of most 6th District counties.

From tuday's NEWSLIR -

At the state Capitol, Lucas held a news conference to propose additions to the federal crime bill that the House passed this week.

He backed building of regional prisons and mandating that states toughen their sentencing laws to get their criminals in the prisons.

`Three strikes and you're out'' for convictions on violent crimes is too generous by ``at least one strike,'' Lucas said. ``There's no reason to give a two-time rapist or mugger a third chance.''

Lucas proposed tightening the federal appeals process and enacting an enforceable death penalty; making courts consider police's ``good faith'' in evidence gathering; and restoring planned cuts to the Justice Department.

He called the current crime bill a good first step but still reflective of ``the liberal, pro-criminal, anti-victim attitude of the House majority.''

The 6th District election is May 10.

Regarding Vance Air Force Base, Lucas plans to fight for the local facility, as well as a mora-torium on further defense cuts until situations oversess solidify.

The representative said he has been receiving some com-ments from Enid citizenry that English did not "key in" on Vance as much as he did agriculture in the district. After hearing

about the history of English's part in a letter-writing campaign to save Vance, Lucas said he was not being critical of the former Congressman, but that he did plan to be a "constant bloodhound" concerning the base closure list.

Keeping facilities such as Vance and Tinker are vital to the nation's defense as long as American involvement in the skirmishes overseas continue, he said.

He added that he has a "hard time with the country being in-volved (in Bosnia) in the first place," calling the internal con-flict an "800-year tribal war." "In places like Bosnia, where

we are not wanted by the locals - I don't know how we can do anything productive here," Lucas / said.

And, despite a probable lack of ability to dispatch any nuclear weaponry, thus minimizing any domestic American concern, Lucas said the U.S. soldiers on the front line were in danger. The most effective way to deal with North Korea is through the Communist Chinese, he said.

Improved relations with that country, which is also a major consumer of American wheat, would help the agriculture industry as well, he added. Lucas guestioned President Clinton's handling of Chinese relations.

"I can't question the president on his day-to-day activities but he scares me to death," Lucas said.

Continued from Page A-1 said health care cannot fall into the hands of the government, and while federal leaders can provide reinforcement in the war against crime, it can only truly be fought by the state legislature.

Lucas said he will stand behind a national law for quicker enforcement of capital punishment and a change in welfare codes to provide a better system of crime prevention.

The Republican's views on other issues included:

His background as a "Western Okle" is more favorable than Webber's recent Washington stint, creating an comparison of "carpetbagger versus one of us."

Belief that his voting record stands on its own and that Democratic party supporters have taken some of his state votes out of context. Also, while he has missed some votes throughout the campaign, he always makes sure "they are covered."

■ Voter turnout at the polls should be better in areas where he is supported than those strict Democratic regions, even with the additional question of the state lottery tacked on by Gov. David Walters, a Democrat.

Despite a larger Democratic voter percentage, there are enough "swing votes" in the 6th District to allow him to carry the election.

U.S. Sen. David Boren's adamant support of Webber has caused some "adverse backlash" on his opponent's campaign.

If elected, Lucas said he will maintain his home in Cheyenne under the intention of traveling home every weekend to be with his family and conduct meetings with his constituents.

While he said he could not legally promise that he will establish an office in Enid, he added that he could not see how the second largest metropolitan area in the district could be without one.

Resource-wise, Lucas said, he believes it will be a struggle, but that if he comes close to Democratic figures he will win the race.

During the carly stages of the 6th District campaign, Lucas said "nobody, but nobody, gave me a snowball's chance in a very bad place of winning."

"The momentum is on my side," he said. "We're going to win."

SUBJECT: Oklahoma visit

BACKGROUND...The wheat, grain and stocker cattle enterprise accounts for 75 percent of the agriculture revenues generated in Oklahoma and most of these operations are found in the 6th Congressional district. Most of the production is in two counties--Caddo and Texas county. Caddo County in southcentral OK., has the 2nd highest peanut quota in the nation. Texas county ranks in the top ten counties nationwide for total agriculture revenues.

PRIVATE PROPERTY RIGHTS...have been well received by Oklahoma. They are especially concerned about the impact of Private Property Rights on the Endangered Species Act (which shouldn't come up this year) and wetlands. You have introduced the Private Property Rights Act of 1994, S. 2006. This bill requires the agencies conduct a Takings Impact Assessment when promulgating regulations. Your approach has been to force a vote on this issue in 1994 and this bill will provide a "foot in the door" on the issue. Senator Nickles is a co-sponsor of S. 2006 and also has his own Private Property bill.

SAFE WATER AND CLEAN WATER...require new mandatory point and non point source programs which will greatly affect grain and livestock producers. The Safe Drinking Water Act will most likely come up in the Senate next week. The most controversial provision deals with source point pollution whereas municipalities can regulate upstream farmers. You are preparing to offer a Private Property Rights amendment to that portion of the bill. The Clean Water Act may not come up this year since there is so much opposition.

CONSERVATION COMPLIANCE...plans are fully enforceable by the end of 1994. Consequently, SCS and the local conservation districts are stepping up spot checks of producer conservation plans. Problems have been rare in Oklahoma.

CANADIAN WHEAT... is a concern, but most Oklahoma wheat growers are not complaining about the imports.

PEANUTS...Under the Uruguay Round Agreement, the U.S. will reduce imports of peanut butter while providing increased access for edible peanut imports. Section 22 import quotas for peanuts will be replaced by high ad valorem tariffs, which will be reduced by the minimum of 15% in equal annual installments over 6 years beginning in 1995. U.S. procuders will likely gain, according to the ag department, because the net effect is expected to be lower peanut-equivalent imports compared to baseline projections of imports without the Uruguay Round.

EPA ENFORCEMENT OF CONFINED ANIMAL FEEDING OPERATION (CAFO) PERMITS...are being enforced by EPA Region 6 (Dallas). Oklahoma CAFO's were supposed to have their pollution prevention plans in place by February, but most requested more time. EPA recently granted an extension until June, but they communicated this extension in a very harshly-worded, legally-frightening administrative order sent to each CAFO. Needless to say, CAFO managers were angry about this heavy-handed tactic.

CORPORATE HOG FARMS...The Pig Improvement Company has recently constructed facilities in the 6th district and their large scale confinement operation have created a great deal of controversy. Frank Lucas has generally been opposed to corporate hog farms. Kansas recently passed a Corporate Hog Bill which allows counties to have Corporate hog farming. This will be a big boost for Southwest KS.

TO: SENATOR DOLE FROM: JIM WHITTINGHILL SUBJECT: OIL AND GAS

Nothing new here. West Texas Intermediate closed Thursday at \$17.15 per barrel, up 35 cents over Wednesday, but down from the \$19.75 price of one year ago. The twelve month high was \$20.60, and the low was \$13.90.

A steady price somewhere between \$20 and \$22 is needed for economic viability of most stripper oil. Natural gas prices have remained stronger than oil and fuel switching do to the environment will leave natural gas stronger in the future.

Integrated oil companies are making money on refining and chemical operations (except those with problems unique to their facilities such as accidents, weather, etc.).

WHAT EVER HAPPENED TO NATIONAL ENERGY SECURITY?

Following the two great oil shortage crises in the 1970's, a popular topic of conversation -- and government policy -- was ensuring our national energy security. For, the United States was an energy driven economy. In fact, in the 1979 crisis, at a time when we were only 35% XX?? dependent on foreign sources for our daily consumption, the loss of Iranian oil, which accounted for only 5% of that total, threw this Nation into an oil shock. Long lines and short tempers were the result.

More recently, in 1991 XX?? we put the lives of ??,000 American servicemen and women in harm's way in large part to protect our oil supplies in the Persian Gulf.

Since first being sworn into the House of Representatives in 1961, I have proudly represented an area with oil and gas production. It should come as no surprise to anyone, therefore, when they learn I have spent considerable time in attempting to increase the production of energy within the United States. Through every fad idea of the day, I have sought and supported national energy security every step the way.

Kansas is also well known as being in the heart of the bread basket, an area if the Midwest of splendid agricultural productivity. It should be of no further surprise, then, that I have also been a strong proponent of agricultural initiatives.

Today we remain every bit as much of an energy dependent economy today as ever. In fact, in 1993 we relied on imports for almost 50% of our imports as opposed to 35% in 1979.

In the face of these facts, or more accurately completely ignoring these facts, current environmental policy being supported by a seemingly odd coalition of the giant oil companies and the professional environmentalists calls for increasing our reliance on imports by another almost 15%.

Although I have been considered to be a supporter the oil industry through all my years in Congress, I do not support this policy.

On the other hand, in an effort to keep a campaign promise, the Clinton Administration has joined with farmers and an industry which turns corn into an alcohol fuel to reduce the amount of the additional 15% reliance. My treasured State of Kansas both produces corn and is home of four of these businesses which turn corn into this alcohol called ethanol. Given my long time support of American agriculture, one might expect me to support this approach as an alternative. Yet, I cannot.

support this approach as an alternative. Yet, I cannot. In part, the Clean Air Act Amendments of 1990 seek to reduce smog which plagues many of our cities in the summer months. One way to combat smog is to reduce its precursors, part of which come from the fuel which propels our automobiles. By removing certain components of gasoline and replacing them with so-called oxygenated fuels, or alcohol, all scientists are in agreement that certain clean air benefits result. However, scientists hold widely divergent views on just which benefits and by how much the air is cleaned. This is a most important fact to remember -- judgements of the clean air benefits of different oxygenates can be quantified only by scientific theory, not scientific fact. And, scientists of equal credibility believe in different theories. There is no "right" scientific way of thinking at this point.

For years, the Environmental Protection Agency held that smog was reduced by the addition of 10% ethanol to gasoline, a product most know as gasohol. Recently, a competing fuel, which is made from hydrocarbons which are recovered in the production of oil and natural gas, has become the darling of the oil industry and professional environmentalists. Methanol, when combined with butane forms a fuel additive called methyl tertiary butyl ether, or MTBE. MTBE and ethanol are direct competitors.

There are important differences in these two products other than there environmental characteristics, and we must pay attention to these differences if we are to have a policy which fits with other important policies. First, ethanol is renewable, it's made from corn; methanol and MTBE are not, they come from oil and gas wells. We are already importing oil to run our automobiles, and we will certainly need to import MTBE if we choose that option. Finally, ethanol is the alcohol which occurs in the beer, wine and spirits, while methanol is a highly toxic substance which can cause death if ingested in small quantities.

So we return to our decision. On the one hand, we have the oil companies and environmentalists insisting all of the new alcohol additives must come from MTBE, most of which will be imported and will make us even more dependent on insecure foreign sources for our transportation fuels. On the other hand, we have the Clinton Administration, farmers and the ethanol industry saying we must impose a huge new federal bureaucracy and mandate that 30% of the new market goes to ethanol.

I don't like either choice, and neither should you. On April 19, the government announced that our trade deficit had risen to a six year high. Many don't stop to look at the what goes into this trade deficit of ours. But, it's

Senate Crime Bill

The Senate crime bill contains the following provisions:

- --treat as adults those juveniles aged 13 or older who use a gun in the commission of a federal crime (Moseley-Braun amendment).
- --establish a <u>federal anti-gang statute</u> making it a criminal offense to participate in a criminal street gang or induce others to join the gang (Dole amendment)
- --establish mandatory minimum penalties for gang activity (for example: mandatory minimum of 5 years for inducing someone to join a gang; mandatory minimum increases to 10 years if the subject of the inducement is under 18 years of age) (Dole amendment)
- --\$100 million for additional federal prosecutors to prosecute gang activities (Dole amendment)
- --\$100 million for gang prevention grants (mentoring, role model, after-school athletic programs, etc.) (Dole amendment)
- --\$300 million to purchase metal detectors and surveillance cameras (manager's amendment)

NOW, WHO IS KAREN MCCUNE, YOU MAY ASK? MR. WILL EXPLAINS THAT "SHE'S NINE YEARS OLD, 47 POUNDS, AND FULL OF LIFE AND BRAVERY. SHE NEEDS BRAVERY BECAUSE SHE LIVES IN THE CABRINI-GREEN HOUSING PROJECT IN CHICAGO. SHE GOES TO THE JENNER SCHOOL, NAMED AFTER THE MAN WHO INVENTED THE SMALLPOX VACCINE. THREE GRADE-SCHOOLERS, IN THE SPAN OF ONE YEAR, WERE KILLED ACCIDENTALLY, GETTING FROM CABRINI-GREEN ACROSS THE FREE-FIRE ZONE THAT IS CHICAGO IN THOSE AREAS, INTO THE JENNER SCHOOL. KAREN SLEEPS...IN A BED NEAR A WINDOW EXCEPT WHEN THE GUNFIRE GETS TOO FIERCE, AND THEN SHE AND HER SIBLINGS GO INTO THE HALL AND HIDE."

MR. PRESIDENT, KAREN MCCUNE IS NOT A CITIZEN OF BOSNIA, OR RWANDA, OR THE GAZA STRIP. SHE IS A CHILD OF AMERICA, AND HER LIFE OF TERROR IS ONE LIVED BY THOUSANDS LIKE HER IN PUBLIC HOUSING PROJECTS THROUGHOUT THE UNITED STATES.

THE CRIMINALS WHO TERRORIZE PUBLIC HOUSING AREN'T THE VICTIMS OF SOCIETY, AS THE ROOT-CAUSE LIBERALS WOULD HAVE US

BELIEVE. THE REAL VICTIMS ARE THE LAW-ABIDING TENANTS--CHILDREN LIKE KAREN MCCUNE--WHOSE LIVES ARE SPENT DODGING BULLETS, AVOIDING THE DRUG-DEALERS, JUST HOPING TO GET THROUGH ANOTHER DAY WITHOUT INCIDENT...ALIVE.

IN AN EFFORT TO COMBAT GANG AND DRUG-RELATED VIOLENCE, THE CHICAGO HOUSING AUTHORITY RECENTLY ESTABLISHED A POLICY OF CONDUCTING WARRANTLESS APARTMENT-TO-APARTMENT SEARCHES OF C.H.A. PROJECTS. NOT SURPRISINGLY, A MAJORITY OF THE LAW-ABIDING TENANTS IN C.H.A. BUILDINGS SUPPORTED THIS POLICY.

EARLIER THIS MONTH, THE FEDERAL DISTRICT COURT IN CHICAGO GOT INVOLVED, RULING THAT THE C.H.A. SEARCH POLICY VIOLATED THE FOURTH AMENDMENT'S BAN ON UNREASONABLE SEARCHES AND SEIZURES. THE COURT THEN ENJOINED C.H.A. OFFICIALS FROM UNDERTAKING ANY ADDITIONAL SEARCHES.

TO HIS CREDIT, PRESIDENT CLINTON QUICKLY RESPONDED TO THE COURT DECISION, DIRECTING ATTORNEY GENERAL RENO AND SECRETARY OF HOUSING AND URBAN DEVELOPMENT HENRY CISNEROS TO DEVELOP MEASURES THAT WOULD BE BOTH CONSTITUTIONALLY VALID AND EFFECTIVE IN REDUCING VIOLENT CRIME IN PUBLIC HOUSING. THESE MEASURES WERE UNVEILED LAST SATURDAY, DURING THE PRESIDENT'S WEEKLY RADIO ADDRESS.

UNDER THE PRESIDENT'S NEW POLICY, PUBLIC HOUSING OFFICIALS ARE ENCOURAGED TO IMPLEMENT THE FOLLOWING ANTICRIME MEASURES:

ONE. ERECTING FENCES AROUND PUBLIC HOUSING BUILDINGS, ISSUING IDENTIFICATION CARDS TO TENANTS, AND INSTALLING METAL

DETECTORS AT BUILDING ENTRANCES;

TWO. SEARCHING THE PACKAGES AND CLOTHING OF ANYONE SEEKING TO ENTER PUBLIC HOUSING BUILDINGS AND REFUSING ENTRY TO ANYONE WHO DOES NOT SUBMIT TO INSPECTION;

THREE. CONDUCTING WEAPONS SEARCHES WITHOUT CONSENT OR A WARRANT IN COMMON AREAS, SUCH AS STAIRWELLS, AND IN VACANT APARTMENTS;

FOUR. FRISKING "SUSPICIOUS-LOOKING" INDIVIDUALS FOR WEAPONS, IF POLICE OR SECURITY PERSONNEL HAVE A REASON TO BELIEVE THAT THE INDIVIDUALS ARE INVOLVED IN CRIMINAL ACTIVITY AND ARE ARMED;

FIVE. INCLUDING CONSENT CLAUSES IN LEASE AGREEMENTS PERMITTING ROUTINE, WARRANTLESS APARTMENT-BY-APARTMENT POLICE SEARCHES FOR ILLEGAL WEAPONS OR ILLEGAL DRUGS;

AND SIX. CONDUCTING WARRANTLESS SEARCHES OF INDIVIDUAL UNITS WHERE THERE IS A JUSTIFICATION FOR A SEARCH BUT INSUFFICIENT TIME TO OBTAIN A JUDICIAL WARRANT.

MR. PRESIDENT, THIS AMENDMENT IS NOTHING MORE THAN AN ENDORSEMENT OF THE ADMINISTRATION'S NEW POLICY, AS OUTLINED IN A RECENT LETTER TO PRESIDENT CLINTON FROM ATTORNEY GENERAL RENO AND SECRETARY CISNEROS. THIS AMENDMENT DOESN'T BREAK NEW GROUND, NOR DOES IT PROPOSE ANYTHING THAT PRESIDENT CLINTON HAS NOT ALREADY ENDORSED. IT SIMPLY RECITES SOME OF THE KEY ELEMENTS OF THE NEW ADMINISTRATION POLICY, AND PUTS THE SENATE FOUR-SQUARE BEHIND THEM.

OF COURSE, THE NEW ADMINISTRATION POLICY IS A SMALL

STEP...AND WE SHOULDN'T EXPECT IT TO PUT AN END TO THE VIOLENCE AT CABRINI-GREEN, OR AT THE ROBERT TAYLOR HOMES, OR AT THE OTHER BULLET-RIDDEN PUBLIC HOUSING PROJECTS THAT LINE THE URBAN LANDSCAPE. BUT I'M PREPARED TO HOPE THAT THE POLICY, IF ACTED UPON, CAN--AND WILL--MAKE A DIFFERENCE.

OF COURSE, THERE ARE THOSE WHO ARGUE THAT THE ADMINISTRATION POLICY GOES TOO FAR, THAT IT MAY EVEN VIOLATE THE FOURTH AMENDMENT TO THE CONSTITUTION.

I HAPPEN TO DISAGREE...AND ATTORNEY GENERAL RENO, THE JUSTICE DEPARTMENT, AND THE PRESIDENT OF THE UNITED STATES HAPPEN TO DISAGREE, AS WELL.

I UNDERSTAND THAT MY DISTINGUISHED COLLEAGUE FROM MINNESOTA, SENATOR WELLSTONE, INTENDS TO OFFER A SECOND-DEGREE AMENDMENT THAT WOULD NOT ONLY WATER-DOWN MY AMENDMENT BUT WOULD ALSO REPRESENT A RETREAT FROM THE ADMINISTRATION'S OWN POLICY.

SENATOR WELLSTONE'S AMENDMENT, AS I UNDERSTAND IT, WOULD EXPLICITLY PROVIDE THAT RESIDENCY OR CONTINUED RESIDENCY IN PUBLIC HOUSING COULD NOT BE MADE CONTINGENT ON THE INCLUSION OF A CONSENT CLAUSE IN A LEASE AGREEMENT.

THE RENO-CISNEROS LETTER TO PRESIDENT CLINTON, ON THE OTHER HAND, DOES NOT MAKE EXCEPTIONS. IT DOES NOT PROHIBIT PUBLIC HOUSING OFFICIALS--OR THE TENANTS THEMSELVES--FROM MAKING RESIDENCY CONTINGENT ON THE INCLUSION OF A CONSENT CLAUSE IN A LEASE AGREEMENT.

IT SIMPLY SAYS, AND I QUOTE: "A SEARCH IS LAWFUL IF IT IS CONDUCTED PURSUANT TO UNCOERCED CONSENT. LEASES IN PUBLIC

HOUSING PROJECTS, AS ELSEWHERE, TYPICALLY INCLUDE A STANDARD CONSENT CLAUSE PERMITTING THE HOUSING AUTHORITY TO CONDUCT ROUTINE MAINTENANCE INSPECTIONS AND TO ENTER THE TENANT'S APARTMENT IN CASE OF EMERGENCY. WHERE CRIME CONDITIONS IN THE HOUSING DEVELOPMENT MAKE UNIT-BY-UNIT INSPECTIONS ESSENTIAL, SIMILAR LEASE CONSENT CLAUSES COULD BE EMPLOYED TO AUTHORIZE PERIODIC ADMINISTRATION INSPECTIONS OF TENANTS' UNITS FOR UNLICENSED OR UNAUTHORIZED FIREARMS."

THE RENO-CISNEROS LETTER GOES ON TO SAY, AND I QUOTE: "TENANT ASSOCIATIONS SHOULD BE ENCOURAGED TO ENDORSE THE ...INCLUSION OF CONSENT CLAUSES IN LEASE AGREEMENTS. A RESOLUTION BY A TENANT ASSOCIATION WOULD DEMONSTRATE WIDESPREAD SUPPORT FOR SUCH MEASURES, WHICH IS AN IMPORTANT FACTOR IN DETERMINING WHETHER TO INCLUDE SUCH A CLAUSE IN THE LEASE. IN ADDITION, A SHOWING OF WIDESPREAD TENANT SUPPORT WOULD BE HELPFUL IN RESPONDING TO CHALLENGES BY PARTICULAR TENANTS TO THE CONSTITUTIONALITY OF...CONSENT CLAUSES" UNQUOTE.

SO, MR. PRESIDENT, THE ADMINISTRATION'S POLICY IS CLEAR. AND A VOTE FOR THE WELLSTONE SECOND-DEGREE AMENDMENT IS A VOTE AGAINST THIS POLICY.

FINALLY, MR. PRESIDENT, I WANT TO GO BACK TO GEORGE WILL'S ORIGINAL QUESTION AND DIRECT IT NOT TO CONSERVATIVES, BUT TO THOSE AT THE A.C.L.U. AND THE <u>NEW YORK TIMES</u>, WHO OPPOSE SOME OF THE ADMINISTRATION POLICY'S KEY ELEMENTS, INCLUDING THE PROPOSAL TO ALLOW PUBLIC-HOUSING TENANTS TO CONSENT TO POLICE SEARCHES THROUGH THEIR LEASE AGREEMENTS.

Meagher said Reich was so angered upon receiving and studying the Dayton Tire Co. file at his Washington, D.C., office late Friday afternoon that he decided, on the spot, to personally serve the citations -----

"When we have a company that has sericus safety prob-lems, when that company flouts the law, continues to refuse to change its ways and continues to expose its work-ers' life and limb to serious hazards, we will take all necessary action - we're going to throw the book at them," Reich told a news conference later Monday.

Jesse Isbell; an executive board member with United Rubber Workers Union Local 998, said plant employees supported the court-ordered shut-down. "We're estatic," Isbell said.

"People are out there finally showing an interest in addressing our concerns that we've been trying to point out for the past 14 years."

Trevor Hoskins, vice presi-dent of public relations for Bridgestone/Firestone Inc., said, "We've not yet had an opportunity to study the citation, but we are disappointed that the Department of Labor, has taken this action."

Secrecy loses in the House

Nor the past 62 years in the U.S. - House of Representatives, a handful of entrenched congressional leaders have had nearly complete, dictatorial control over which bills move to the House floor for debate and vote. These few members of the elite leadership dominated the agenda of the U.S. House and have had the power to ensure that legislation popular at home is never debated and voted upon. This system allowed any member of Congress to campaign as if in favor of popular legislation and then, once back in Washington, privately work for its defeat. Although popular legislation may be introduced, these insiders were able to bottle up bills in committee, making sure they never saw the light of day. They could quite simply have their cake and eat it, too. House rules require that a dis-

charge petition be filed to move a "bottled-up" bill through committee and onto the House floor for a vote. To be successful, it must be signed by a majority (218) of house members. On the surface this seems to serve as an adequate check and balance. But the catch is that, until Tuesday, signatures on a discharge

Claiming they knew better, the insiders didn't work to reflect the wishes of the people who elected them. Rather, they moved their own agenda to the front of the line.

I introduced H. Res. 134 to do away with the veil of secrecy that allowed these insiders to get away with what amounts to legislative murder, H. Res. 134 is direct and straightforward in its language. Its purpose is to end the "Gag Rule" and make the signatures on a discharge petition a matter of public record. We had the support of over 227. courageous members of Congress; both Republican and Democrat, who signed on to the discharge petition necessary to move H. Res. 134 to the House floor. Thanks to the continued commitment of these members, the strength of grass roots organizations such as Ross Perot's United We Stand America and Citizens' for a Sound Economy, and such national voices as Rush Limbaugh and the editorial page of the Wall Street Journal, we were able to maintain our momentum and be successful when H. Res. 134 came to a vote by the full House Tuesday.

The congressional leadership fought our reform at every turn by twisting the arms of pliable members to side with the leadership and remove their support. The cover story they offered the defectors was that once made public, lobbyists and special interest groups would have a list from which to work. Nothing could be further from the truth. By making the signatures public, all will be on even ground — yes, for a change, even the people. Fortunately, this attempt to maintain their cloak of secrecy failed. The demand



for openness from the American neonle proved to be too big a foe.

But the fight has just begun. The leadership is not going to give up its control so easily. They are already regrouping and formulating their plan in an attempt to maintain their power. They intend their plan to look like an alternative reform. But be on the alert: Any change they propose will have as its goal reinstating their ability to move the American people's agenda to the rear of the line and their own singular interests and careers to the front.

Our reform does not change the fundamental process of the committee system. It quite simply demands that rather than hide these signatures from the American people, the system be open and a matter of public record.

Due to the overwhelming support that resulted in passage of H. Res. 134 by a vote of 384-40, we have opened the doors of Congress to let in some much needed sunshine. This is a start. We now have a real chance to be successful in making additional reforms in Congress. The members who made up the sunshine coalition that worked so hard and tirelessly to pass H. Res. 134 are sticking together and setting their sights on ten of Congress' most needed reforms. We are calling these the "Ten Rays of Sunshine."

The elitists have heard the voice of the American people's demand for openness, and they're scared. They like their cozy deals. But right now if you stop and listen, what you will hear is the sound of the will of the American people moving to the front of the line.

At noon EST today, viewers of C-Span may witness an extraordinary event. Two groups of House Members will form near the clerk's desk at the front of the chamber. One will be adding their names to a list that would end the gag rule on a procedure called the discharge petition. The other group, heavily pressured by House leaders to preserve Congress's code of secrecy, will be removing their names from the same list.

Over the Labor Day recess, angry voters prompted at least another 13 Members to agree to udd their names to Oklahoma Rep. J.m Inhofe's list calling for an end to secrecy on discharge petitions. At recess, he already

had 211 names, so this would put him well over the 218 majority he needs to force a vote on his proposal. But House leaders want to preserve the present rules, which allow them to bottle up popular legislation and then keep voters in the dark.

So leaders are calling in heavy artillery to get Members to remove their names. At one point before the recess, Rep. Inhofe was one name short of a majority, but the leaders pressured six signers to recard. While yesterday afternoon Rep. Inhoite was building further momentum, the issue today could go either way.

If the Inhofe petition succeeds, we're talking here about a revolution in the House of Representatives.

Discharge petitions work as follows: Often a committee will simply sit on a bill it knews would pass if allowed to come to a vote on the floor. The only way to free hostage bills is to convince 218 Meribers to sign a petition to "discharge" the bill from committee and force a vote. But the names on any petition are kept secret, so

Members can posture in favor of a popular bill while quietly making certain it is never voted on. And as a discharge petition nears the magic number of 218, House leaders routinely twist the arms of pliable members and force them to remove their names. The result: Committee chairmen have a stranglehold on what legislation is voted on, and both ordinary members and their constituents are disenfranchised.

Risking possible discipline for breaking the traditions of the House, Rep. Inhofe gave us his list, and last month we published the names of nonsigners. The effect was electric. We had promised the list but it took a few days to sort out; our phones lit up with calls about the delay. Members have been deluged with questions about why they were on the list. Rep. Martin Meehan, a Massachusetts Democrat, calls the interest in such inside Congressional baseball "extraordinary." He has decided to join Mr. Inhofe, rejecting the advice of Rep. Joe Moakley, the powerful Rules Committee chairman from his home state.

All the more amazing, all this took place beneath the attention of the Congressional press corps. The discharge petition movement has been covered by Roll Call, Congress's hometown paper, and one Associated Press story. The public was informed almost exclusively by us, radio talk shows such as Rush Limbaugh's, grass-roots activists linked to Ross Perot and computer bulletin boards.


Interestingly, Richard Cohen, a liberal Washington Post columnist, has just written a column saying that radio talk shows are "clearly filling a void" because their audiences believe their "values are not reflected elsewhere." Mr. Cohen says the fear of saying something that might be attacked as racist or sexist is so "acute" that the mainstream media has stopped covering some subjects, choosing "discretion over valor."

Rules Chairman Moakley is feeling the heat himself. A group of Ross Perot supporters are holding a 24hour-a-day vigil outside his Boston office and will hold a mass rally there Saturday. His aides told Roll Call that "it's almost impossible to argue against" something that is seen as openness in government.

Mr. Moakley of course understands his own power will be vasily reduced if he has to operate in daylight, so he has to come up with some arguments. So he offers the ludicrous proposition that openness would help lobbyists, who in the real world love the dark. And he complains, "The pressure groups are out there at town meetings, loud and restless, and it's impossible to make them sit through an explanation." The "pressure groups" he criticizes are the voters, understandably impatient with his explanations.

So Chairman Moakley has come up with a clever diversionary tactic, urging members to "temporarily" withdraw their names from the petition, until his committee finishes hearings on the issue later this month. It just works out that under bizarre House Rules, the timing is such that if it waits for hearings the secrecy issue can't reach the House floor until October 11, and Congress is set to adjourn October 8. If any Members claim they're removing their names temporarily, it's the equivalent of "tem-porarily" killing someone.

Voters are understandably upset at an entrenched political class seeking its own interest instead of representing theirs. Opening up the discharge petition is a small step toward openness and accountability in government, but an important one. If at noon today Congress balks, it would not be a healthy development for either the Members or the body politic.



The environment in Oklahoma is ripe for a change in the wake of Governor Walters' guilty plea on campaign violations. Jack Mildren, who had previously seen the possibility of running alone for the Democrat nomination, is now facing state Senator Bernice Shedrick. Mildren starts out as the favorite in part because he is remembered as an Oklahoma football star. Yet, tradition does not always benefit Oklahoma football heroes. The late Bud Wilkinson lost a Senate race, and he was perhaps the legend of Oklahoma legends.

Frank Keating announced that he would seek the Republican nomination for Governor on March 29. He has spent the past seven years in Washington as a federal appointee in various key positions, but before that he had served in the State House, the State Senate, and as a federal prosecutor in Tulsa. He says there is not a "soul in this race who has the kind of experience I've had." Vince Orza, the 1990 candidate, left the race to concentrate on his business. Keating has raised nearly \$400,000, and he expects to need \$2.8 million. He said he expects Governor Carroll Campbell and former HUD Secretary Jack Kemp to come to the state on his behalf.

The presence of independent Wes Watkins in the campaign will help the GOP.
