

Kirby Ensley of Sylva has announced his candidacy for the State House 52nd District: Graham, Swain, Jackson, Haywood and Madison counties, subject to the Republican Primary.

Kirby Ensley, age 40 began "Jesus' Bride" one of three men from three different counties, the third time they met each other, three years to the exact day he was no longer a Tom's snack distributor, also his birthday, in the warehouse originally planned for Tom's, located at 2 Dillardtown Road, in Sylva. "Jesus' Bride" a no cost family ministry which spiritually and physically reaches out through jail ministry to prisoners, ex-convicts and their families, also pre-marital, marital problems, separation, divorce, alcohol, drug, sexual, physical, and verbal abuse, uncontrollable behavior, school, finances, business, unwed mothers, women who are considering abortion or have had an abortion, suicides and teen pressures. OUR NATION'S PROBLEMS.

Kirby Ensley founder of Kirby Ensley Enterprises D/B/A four small businesses named after family members: Weston Ensley Snax, (which his father and mother started in 1942, a previous Peanut/Potato Chip/Candy distributorship which has served Graham, Swain, Jackson, Haywood and Madison so Ensley hopes his customers will remember him as their snacks salesman.) others Grace Unlimited Businesses, Cheryl Storage Warehouses and Virna Lisa Rentals.

Ensley has learned the hard way through his businesses, coaching local counties's high school wrestling teams and Jesus' Bride the last 8 years that our problems are not crime, jobs, education, etc., but our problem is SPIRITUAL: one word SIN and our answer is not government but one word JESUS the first law book, THE BIBLE, GOD'S HOLY WORD. (our sword). Ensley feels God has been preparing him 9 years (if elected) since he ran for the 1986 29th Senate Primary like in a mother's womb of 9 months to be a STATESMAN. Ensley was the top vote getter in Graham, Swain and Jackson, 2nd in 3 others but needed less than 1 per cent to win.

## IT IS TIME FOR COMMON SENSE GOVERNMENT

Ensley's business experience with UNFAIR Government CONTROL and UNCONTROL of bankruptcy, judicial system, CRAZY lawsuits employment system, laws needed for landlords, school waste, untrained employees, unaccountable welfare: Example at this time the Town of Sylva condemned an industrial property to put a sewer line through the middle so nothing can be built on top of it, spending tax dollars of \$2,500, not counting Town's lawyer's fee, for an appraisers to pay owner, NOTHING, ZERO! Plus they cannot even qualify for taxpayers State Economic Grant to match a taxpayers HUD Federal Grant without this one piece of low housing/income property (my mobile home park). Although they say no connection, once sewer is built, COMMON SENSE all this is being done to annex City limits for more taxes, for more zoning, for more control, for more \$341,000 town hall. Then the Sewer Projects is GIVEN to another government agency created by Town and County for another director's salary, (which the town clerk was doing) another building, (why wouldn't town hall work) then \$45,000 worth of vehicles not counting more boards and meeting rooms. Tuckasegee Water and Sewer bills customers based on units, (NOT ACTUAL GALLONS USED,) including empty spaces and buildings, even burned out trailers. How much more obvious that WE need to VOTE against this and the injustice of INCREASING property evaluation, PLUS ADDING landfill fees of \$1,100 which is more than my property taxes (I want to use not own) TO BUILD \$3.5 million courthouses PLUS recreation facilities which I support but NOT WHEN VOTERS HAS VOTED IT DOWN! Why do we have town and county taxes and six to run a town of 3,000 and 3 to run a county of 30,000? Big cities but not small towns! What unfair taxation!!!

Ensley wants to go to Raleigh to delete laws not to legislate laws. God created and ran our whole world with only one law book, His Bible. Our forefathers founded our country and wrote the Constitution of the United States of America based from His Bible. But only after many unsuccessful attempts ---SEVERAL DAYS OF PREACHING GOD'S WORD WAS CALLED BY CONGRESS, --- FINALLY, IT WAS WRITTEN IN A MATTER OF HOURS. PROOF!!!

Ensley has learned from doing jail ministry in Jackson, Swain, Macon, Haywood Counties, prisons in other states and being part of Justice Fellowship Crime Reform in our General Assembly this past year. Through Ensley's business experience, especially his trailer park: a single parent renter goes to Social Service gets first months rent up to \$375 plus fuel oil, food stamps, A.F.D.C., maybe child support and/or S.S.I., WICK, owes me three months rent minimum due to a thirty day notice law, Small Claims Court with its postponement and appeals from W.N.C. Legal Services provided by taxpayers, then they can get on HUD for free rent with no verification of previous assistance or monies owed, after quitting their job because they will make more money on welfare, plus boyfriends, children father's and ex-husband who are unemployed, staying and eating with them. They know how to work the system! REALIZATION it is not jobs, education, government etc. or as I first thought by building businesses or running for state office in 1986, to change laws. But I have realized the problem is one word SIN and the answer is one word JESUS.

I challenge before you judge me as fanatic, read the following: 30 years ago the seven most problems in our schools was talking in class, missing the trash can, throwing spit wads, etc. Today the seven most problems in our schools are our nation's violent crimes: alcohol, drugs, murder, rape etc. What happened 30 years ago was prayer and Bible was taken out of our schools. Even SAT scores have fallen off until 1981 when Christian Schools were allowed public credit.

This will be the first part of the plan of my platform:

1. If my people, which are called by my name, shall humble themselves, and pray, and seek my face, and turn from their wicked ways; then will I hear from heaven, and will forgive their sin, and will heal their land. II CHRONICLES 7:14!
2. To allow school boards to know we already have a bill that was past on July 5, 1985 by the General Assembly that reads "Chapter 6, 37 House Bill 1410: an act that permits local school boards to authorized observation of a moment of silence each day in school" ( free of guidance and influence.) I encourage you to contact your local school board, schools and churches to allow students this freedom.
3. Bible Studies Program in all schools for curriculum credit such as the community started 3 years ago at Blue Ridge High School, PROOF the ONLY school in the state of North Carolina which did NOT have a drop out!
4. Introduce baby in womb video that is being shown in California schools
5. Plus TESTIMONY of teenager who lived through an abortion (for all Jr. & H.S.)
6. Crossfire Ministry- Jamie Johnson and Randy Shepherd (priority of sports and NO TO SEX)
7. Cut out school condoms (67% safe)
8. Cut out MTV.
9. Back to BASIC EDUCATION
10. NO MORE TAXES!
11. I will not build no more new prisons until the following is tried first.
12. I will use Prison Fellowship, founded by Chuck Colson, plan of rehabilitation,
13. Justice Fellowship which I was a part of which helped to changed the laws this past year in Raleigh (victims compensation)
14. I will use "Cannan Land" in Alabama which has a 85 to 90 percent success rate for drugs and alcohol, teaching trades and getting GED's.
15. Instead of housing non-violent prisoners in jail, they will stay at their homes at night and during the day they will build Habitat houses which will take care of our homeless problem and work on State projects.
14. And the money we are spending to house the prisoners use that money for material for Habitat, etc.
16. or to contribute to the above programs.
17. The prisons will have 12 hour shifts like in the military for cell use.
18. And fathers who will not pay child support, we will not house in county jails. (\*See #15 )
19. I am going to use programs already in existence and successful working. PROOF above and common factor CHRISTIANITY.
20. I will stop all other efforts that are not in line with these in Raleigh.
21. I also will impose a flat income only tax rate system and CUT OUT every other tax - property, gas sales etc. and get a simple system that you can file and pay your own taxes.

I challenge you now and before the primary and November if you have never read your whole Bible from Genesis to Revelation consecutively every day, starting your day and ending your day with Bible reading and prayer. Then I ask you now to do that, because otherwise how do you know that what I'm telling you is not our answer? And when you read you will see that American is in line for destruction the same as Israel. And you will see that prophecy has and is coming true. All our answer, healing, saving, and blessings is JESUS CHRIST. **VOLUNTEER SCHOOL PRAYER:** When I was in school, we saluted the flag and had time for prayer. Today, even town halls are forced to take down their manger scenes at Christmas. 

## Issues

**TAXES/TOBACCO:** I favor lower taxes, and feel that any additional tax on tobacco would be detrimental to the tobacco farmers & others dependent on the tobacco industry (resulting in a loss of thousands of jobs in the 2nd District). I will look out for the best interests of the tobacco farmer.

**HEALTH CARE:** Having served as the US Ambassador to a Communist country, I have lived under socialized medicine and I have seen the disastrous consequences of socialized medicine including lack of choice, bribery, long lines & waiting periods, and diminution of quality. Thus I am opposed to the Clintons' socialized health care plan. I prefer voluntary solutions and perhaps tax incentives for businesses (which offer the best coverage to employees).

**CONGRESSIONAL REFORM:** Because Congress has for too long been unaccountable while enriching itself and exempting itself from rules and regulations applied to the rest of us, I think term limits are needed. Additionally, I oppose any increases in salaries and pension benefits for Congressmen. And I favor reducing office expenditures as well as ending the franking of "political" mail at the public's expense.

**CRIME:** I think we need criminal control not gun control, the death penalty, and the appointment of conservative Constitutional judges who will put the interests of the victim and civilized society ahead of the criminal. There should be no parole for serious crimes.

**BALANCED BUDGET:** I favor a balanced budget. I favor cuts in wasteful federal spending programs like foreign aid, food stamps, and welfare.

EDUCATION: I favor local control where possible and school choice via vouchers to bring competition to the public school system. One of the best ways the federal government can help improve the education systems of the states is to restore much of the authority and jurisdiction to the states and local governments where it belongs Constitutionally. Secondly, incentives for excellence rather than mediocrity and conformity (as now exists) for teachers should be encouraged. And discipline in the classroom and respect for teachers should be restored; and drugs and weapons should not be allowed in schools. An emphasis must be placed on a restoration of fundamentals and basics rather than "feel-good what's happening now" learning.

Welfare payments should be reduced to the point that they don't encourage people not to work, and eventually eliminated except for the very few unable to work.

GOP Ads Decry Government Role Under Clinton Health Plan<

WASHINGTON (AP) A new Republican television ad campaign features the party's biggest congressional guns taking a swipe at President Clinton's health reforms and promising to make things better "without a big new bureaucracy."

The \$500,000 campaign promotes the idea that Republicans and Democrats, working together, can make health insurance more affordable and ensure that workers don't lose coverage when they change jobs.

"We can make health insurance affordable now without the Clinton government-run system," declare the spots read by Senate Republican Leader Bob Dole, House Minority Leader Bob Michel and nine other GOP lawmakers. "Let's do it now."

The ads gloss over the fact that Republicans, just like the Democrats, are divided on their approaches to health reform. The biggest split within the GOP is over whether all individuals should be forced to buy health insurance.

"We're not quite there yet," Dole admitted at a news conference. But he called the ads "very positive, responsible spots" that demonstrate "we're ready for prime time. We're ready to start dealing with this issue."

Rep. Newt Gingrich, R-Ga., the House minority whip, said, "We are at least as unified as the Democrats."

Haley Barbour, the Republican National Committee chairman, said they "make clear Republicans are for health care reform, but cannot support or accept the Clintons' proposal for a government-run health care system."

Polls have indicated the public thinks the Democrats are more likely than the Republicans to solve the country's health care problems.

But support for Clinton's plan has plummeted in recent months. Democrats are looking for ways to exempt small businesses from his requirement that employers buy insurance for their workers and to make his insurance-purchasing alliances voluntary. Clinton is planning a trip to Capitol Hill on Tuesday, reportedly to talk with Democrats about a possible change in strategy.

Gingrich said, "It's a major mistake for the president to come up here Tuesday on a purely partisan visit."

Barbour predicted, "By November, health care reform will be an issue that helps Republicans in the elections."

Sen. Phil Gramm, R-Texas, who would steer clear of mandates but alter insurance laws to make coverage portable and renewable, said the Republicans agree on changes that could solve 85 percent of the problem.

Other Republicans appearing in the spots are: Sens. Don Nickles of Oklahoma, Dave Durenberger of Minnesota and Trent Lott of Mississippi, and Reps. Dennis Hastert of Illinois, Bill Thomas of California, Nancy Johnson of Connecticut and Michael Bilirakis of Florida. Dole said Sen. John Chafee of Rhode Island, who wants to require individuals to buy insurance,

**REPUBLICANS LAUNCH HEALTH REFORM AD CAMPAIGN**

WASHINGTON, May 20 (Reuter) - Republicans looking for a bigger voice in the health care reform debate launched a \$500,000 television advertising campaign Friday to promote their point of view.

The ads, featuring 12 Republican Senators and Congressmen, "make clear Republicans are for health care reform but cannot support or accept the Clintons' government run health care system," Republican National Committee Chairman Haley Barbour said at a news conference.

The television ads, to appear nationally on Cable News Network and in key markets over the next month, focus on a single issue of insurance reform that would bar companies from excluding people from coverage because of pre-existing conditions.

"That's just the beginning," said Senate Republican leader Robert Dole of Kansas. "We think there are other things that we can do with Republicans and Democrats working together.

Those include allowing small business to form insurance purchasing pools, tax law changes to allow the self-employed to deduct their insurance costs and providing subsidies to help low income people buy insurance, Dole said.

"We believe that by coming together, if we can come together, then we can reach out to like-minded Democrats and have not only a good health care reform bill but one with broad ... bipartisan support, one that would pass the Senate with 75 to 80 votes," Dole said.

Lawmakers are struggling to pull together a health reform plan that can be enacted by Congress before the November mid-term elections. So far the issue has been surrounded with loud partisan bickering.

President Clinton has said he will not sign a bill that does not provide health benefits for the 39 million Americans who currently lack insurance. Republicans, who have complained that they are being shut out of the debate by Democrats who control the Congress, are seeking less sweeping changes centred around insurance market reforms.

Republicans in the television ads take a swipe at Clinton's health reform plan saying it would create "a big new bureaucracy."

# A better start

■ New Head Start legislation begins to recognize the need to do more — and sooner — to lift deprived children.

Getting kids ready for school is a popular idea, and for more than a quarter century Head Start has been a popular program. But in authorizing another five years, Congress has said the program must do more, better, earlier.

Head Start enrollment has grown 50% over the last five years — to about 750,000 this year — and President Clinton proposes money for another 90,000 or so youngsters next year. But while the program still serves less than half the eligible 3- and 4-year-olds, the rapid growth has raised concerns about quality. Experts also worry about what happens to children after they leave Head Start. And research findings about the critical importance of the first years of life have sparked fears that age 3 is too late to begin.

The bill signed Wednesday by President Clinton got overwhelming support from Congress: In the Senate, for example, only Jesse Helms voted no last week, citing cost and other programs included in the legislation. But the bill also reflected the conviction that Head Start must do a better job, for more children. For example:

■ The legislation continues the requirement that 25% of increased spending be set aside for improving quality. That is on target, though a new report from the General Accounting Office makes clear that Head Start must do more to cope with the increasing problems faced by today's children.

■ It requires that a process be established for identifying and improving weak local programs. The job that Head Start is asked to do is hard; it must be done well.

■ And the bill sets aside a small percentage of the money to increase services for families with children younger than 3.

This last — the money for children in their earliest years — is a small step on what must become a large national journey. Studies show that early, consistent and continuing assistance to low-income children and their families raises achievement and improves school results. And in recent years the research has shown clearly that what happens in children's first years has enormous impact on their behavior — and on their brains.

Nurturing children is as important as vaccinating them. *Not* nurturing them is as foolish and counterproductive as allowing them to be crippled by diseases that could be prevented by vaccination. Head Start is only part of a larger story that includes everything from school improvement to welfare reform to teen-pregnancy reduction to state and local programs like Smart Start and Success By 6. Expanding the scope of Head Start is a significant recognition of the importance of the earliest years. But with nurture, as with vaccination, the job won't be complete until every needy child is reached with the most effective support the society can muster — from birth to school to job.

# Hunt aides work on communicating better on info highway project

## Legislators say they're out of the loop

RALEIGH — State lawmakers got a tour through the state's proposed high-tech communication systems Wednesday, but some complained that the information highway looked more like a messy 170-car pileup.

Gov. Jim Hunt is trying to convince legislators that North Carolina should be the first state in the nation that links schools, community colleges, universities and state agencies across the state via telecommunications.

But lawmakers have complained that they were kept in the dark about details of the project after approving \$4 million to start it last year. Hunt is seeking \$5 million more next year.

"Members of the General Assembly need more information," Brad Wilson, Gov. Jim Hunt's lawyer, said in opening the session before the House and Senate budget-writing committees. "Clearly, we have not done a good job in providing clear, concise answers."

Legislators specifically have worried over promises made by Hunt's administration that the state will pay monthly telephone charges for the 100 sites scheduled to be connected this summer. Those charges are expected to be \$4,000 per site.

"We have been asked if the state has made any assurances, and the answer is yes," Wilson told lawmakers. "Maybe we should not

have done so, but the answer is yes."

The administration projects the network will cost the state \$142 million over the next five years, but legislators worry that agreeing to pay the monthly phone bills eventually could cost the state hundreds of millions of dollars.

"I think the question in this debate is not whether we will have the information highway in this state," said Rep. Martin Nesbitt, the co-chairman of the House Appropriations Committee. "I think that it's inevitable. . . . We're going to have one and it's going to be throughout this state."

"The purpose of this meeting is to decide what part taxpayers will play in it," said Nesbitt, D-Asheville.

The network is being built by telephone companies, which will own the system. The state, however, will be the major customer, using about 25% of the system.

Supporters have touted the benefits of long-distance classes for rural schools, but Nesbitt said any benefits from the highway must be balanced against other public school programs.

He listed the "unfinished promise" of the Basic Education Plan, additional funding for poor and small schools, increased funds for textbooks, technology for public schools that would not need the highway and school building needs that are estimated to cost \$5 billion or more.

OHIO 1: Republican candidate Steve Chabot was unopposed in the primary and will face Incumbent Democrat David Mann. Mann received 50% of the vote to narrowly defeat his opponents in the Democrat primary. The vote breakdown is as follows:

Robert McDilda	2%	1,033

OHIO 2: Republican Incumbent Rob Portman and Democrat challenger Les Mann will square-off in the November general election. Neither had primary opposition.

OHIO 3: Republican Dr. Dave Westbrook bested his opponent Robert Bent 68% to 32% to win the Republican nomination. He will meet Incumbent Democrat Tony Hall in the general.

OHIO 4: Republican Incumbent Mike Oxley overwhelmed his primary opponent James Stahl 74% to 26%. Oxley is running unopposed in November.

OHIO 5: Republican Incumbent Paul Gillmor will be challenged by Democrat Jarrod Tudor. Neither drew primary opposition.

## RESUMES OF 4 CONG. CANDIDATES ATTENDING CONVENTION

### Profile of Walter B. Jones, Jr.

Walter B. Jones, Jr. is a product of Eastern North Carolina. Born and raised in the Farmville community of Pitt County, he moved back to his hometown after college to settle his family and earn a living. Eventually, he followed his father's footsteps into public service. He simply says, "These are the people I know and the land I love."

As a native son and proud resident of Eastern North Carolina, Walter is concerned about the future of the region. He understands that working people are taxed heavily by a "federal government that's too big and spends too much." He sees how the traditional values of Eastern North Carolina families and churches are undercut by violent crime, the welfare system, and the breakdown of morality in today's culture. He knows that too many bright young people leave this area because quality jobs are hard to find.

Walter B. Jones, Jr. was born on February 10, 1943 to Walter B. and Doris (Long) Jones. He attended the Farmville public schools and Hargrave Military Academy in Virginia. After three years at North Carolina State University, he returned home to Farmville to manage his family's office supply store. Walter graduated from Atlantic Christian College in 1967 with a bachelor of arts degree in history. He was a member of the National Guard from 1966 to 1970. Walter married the former Joe Anne Whitehurst of Bethel on June 26, 1966. Joe Anne is a public school teacher in Farmville and their daughter Ashley is a junior at Meredith College.

Walter is the president of The Judson Company (energy efficiency products) and Benefit Reserves (insurance sales), two small businesses located in Farmville. He is active in numerous civic and community organizations including the Chamber of Commerce, Rotary, East Carolina University, family violence programs, advocacy for the disabled, Common Cause/North Carolina, the Council on Governmental Ethics Laws, and North Carolina Taxpayers United.

Walter's commitment to public service was shaped by the influence of his late father who represented Eastern North Carolina in the U.S. House of Representatives for 26 years (1966-1992). Walter B. Jones, Sr. also served as mayor of Farmville and as a member of the state legislature. Congressman Jones was chosen chairman of the House Merchant Marine and Fisheries Committee and was widely praised for dedication to constituent service for all citizens.

Walter B. Jones, Jr. was appointed to the N.C. House of Representatives in 1983 and subsequently re-elected by the people of Pitt and Greene counties in 1984, 1986, 1988 and 1990. During his legislative tenure he chaired two important committees: the Human Resources subcommittee on Children and Youth and the Judiciary subcommittee on Election Laws and Constitutional Amendments. He was a key figure in the 1989 coalition of Democrats and Republicans that changed the House leadership by removing the all-powerful Speaker Liston Ramsey.

When he left the General Assembly, *The Charlotte Observer* described Walter B. Jones, Jr. as "the legislature's foremost advocate of ethics and campaign-finance reform." Columnist Paul O'Conner of the N.C. Association of Afternoon Newspapers referred to him as "a one-man reform movement." *The Raleigh News and Observer* called Walter, "the General Assembly's most constant and dedicated good government proponent...He has doggedly pursued reform in lobbying, campaign finance and open state government." Walter was the sponsor of ratified bills to protect state employees from political pressure, require Raleigh lobbyists to disclose how much they spend on legislators, put a stop to false advertising in political campaigns, and help young children who had been abused or neglected.

In 1992 Walter sought the Democratic nomination for Congress in the redrawn black majority First District. He placed first in a primary field of seven candidates, carrying 17 of 28 counties in the district which sprawled from the Virginia line to almost the South Carolina border. He narrowly lost the nomination in a runoff but later explained, "It was all for the best...as the Democratic nominee, I could not have supported Bill Clinton for President in good conscience." During the fall elections, Walter supported Jim Gardner's campaign for Governor and Lauch Faircloth's campaign for the U.S. Senate.

On April 15, 1993 Walter B. Jones, Jr. became a Republican. During a press conference at state GOP headquarters, Walter was joined by his family, friends and state Republican Party leaders. "We all know that many voters in Eastern North Carolina split their tickets. Moderate and conservative Democrats have lost patience with a political party which mocks their values and takes their paychecks. The Jones family has a proud tradition of public service and loyalty to Eastern North Carolina. The Jones family tradition will continue in the Republican Party."

Jones switched his party affiliation to the Republican Party on April 15, 1993. He has worked tirelessly in Republican efforts since that time. He is running as the Republican nominee for the 3rd District Congressional seat in the 1994 campaign.

Outlook: Toss Up

If there's any seat in the country Democrats were surprised to lose in 1992, this is it. Quinn came from nowhere to beat Erie County Executive Dennis Gorski after running a grassroots, reform-oriented campaign. But he'll have no easy time defending a seat that is strongly Democratic (45 percent for Clinton; 60 percent for Dukakis).

Quinn, however, has made a strong start in office, generally voting the district (i.e., opposing NAFTA, backing family leave) and his re-election is a personal project of sorts for nearby Rep. Bill Paxon, the chairman of the National Republican Congressional Committee.

A Democratic field of three is competing for the right to challenge him: Buffalo City Council member Dave Franczyk, the party-endorsed candidate; attorney Kevin Gaughan, the 1990 candidate against Paxon; and activist Ellen Kennedy, a local social work professor who is the president of the good-government group Citizen Action.

Republicans are touting the fact that the Democratic top tier didn't enter the race, and the GOP and Kennedy note that Franczyk only represents a small portion of the city's voters in his council district. But Kennedy may be too liberal to win in November, and however it turns out, a divisive Democratic primary is only in the interests of Republicans.



State Rep. Richard Moore's outright win in the Democratic primary keeps this seat, held for 12 years by Valentine, from tilting toward the GOP this fall. Had he fallen into an expensive and contentious runoff with fellow state Rep. Bobby Ray Hall, the GOP nominee David Funderburk, would have had a chance to amass money and stay above the fray.

Moore, a 33-year-old former assistant US attorney, should be well-positioned to discuss crime and has the backing of Valentine, which was key in his primary win.

Still, Moore may not flaunt Valentine's support in the general. The 2nd went for Bush, 45 to 40 percent, in 1992 while Valentine's percentage dwindled to 54 percent after redistricting cleaved away Democrats.

Funderburk is the former Reagan Administration ambassador to Romania and unsuccessful primary contender in the 1986 Senate race, when he was supported by Sen. Jesse Helms's (R) Congressional Club. He has since distanced himself from the conservative political machine but should be strong in this district nonetheless.

Republicans think they can pick up at least two seats in North Carolina, and this is one of them.

3rd district

Incumbent: Martin Lancaster (D)

4th term (54 percent)

Outlook: Leans Democratic

Veteran Lancaster was also hurt by redistricting, and his re-election percentage dropped from 59 to 54 percent between 1990 and 1992. This fall, he'll be pilloried for his vote to support the Clinton budget by ex-state Rep. Walter Jones Jr., son of the late Merchant

For his part, Taylor could make a run for Senate or governor in 1996.

Marine and Fisheries Committee chairman.

Jones became a Republican amidst much fanfare last year, after narrowly losing the 1992 1st district Democratic primary to succeed his father, and the GOP hopes he can win this seat and encourage others to follow him into the fold.

Both avoided primaries, so this race will be slower to heat up.

5th district

Open Seat: Steve Neal (D) is retiring

Outlook: Toss Up

Again, Democrats benefit from avoiding a runoff.

State Sen. Sandy Sands (D) dispatched some top-drawer competition in the primary and is headed for a showdown with businessman and 1992 candidate Richard Burr in November.

Sands now represents about a third of the district; Burr took 46 percent of the vote from Neal last time out. Bush edged Clinton by fewer than 1,400 votes in this district on the

western half of the Carolina-Virginia border.  
Burr's free ride in the primary allowed him to raise more than \$100,000. Sands is a trial lawyer who should be able to restock his war chest in short order.

Expect an expensive and hard-hitting contest here.

Burr will have to alter his strategy from the '92 race, when he ran a classic anti-incumbent campaign.

9th district

Open Seat: Alex McMillan (R) is retiring

Outlook: **Safe Republican**

The next House Member from the Charlotte-based 9th will be decided in a May 31 runoff between former Charlotte Mayor Sue Myrick and state House Minority Leader David Balmer, the top two finishers in the GOP primary.

Balmer is young, has a record of accomplishment in the legislature, and was the strongest fundraiser in the primary, while Myrick is well-known in the region. She was a 1992 Senate contender and also runs an advertising firm.

Balmer's hopes of attracting the support of the third-place finisher, Don Reid, have been hurt by nasty exchanges between the two in that contest. The winner will face 1992 Democratic nominee Rory Blake, but the 9th gave Bush 52 percent of the vote and looks safe for Republicans.

11th district


Incumbent: Charles Taylor (R)

2nd term (55 percent)

Outlook: **Leans Republican**

Democrats saw their first candidate, state Sen. Clark Plexico, back away from the contest but are delighted with his replacement, former television reporter Maggie Lauterer.

The 11th actually became more Democratic in redistricting and has turned over in five of the six elections between 1980 and 1990. Taylor's 1992 opponent, ex-state Sen. John

Stevens (D), ran a lackluster and disappointing race for Democrats, who had touted his chances early in the cycle.

Lauterer ran strong in the primary despite it being her first appearance on the ballot. She was seen on television in virtually the entire district, hosting shows spotlighting senior citizens and illustrating the region's mountain culture.

In addition to wanting this seat back, Democrats are trying to soften Taylor up for his anticipated bid for Senate or governor in 1996. It won't be easy, but Lauterer has generated a great deal of enthusiasm among

both local and national Democrats. Clinton edged Bush here in 1992.



## The Health Security Act's Impact On NORTH CAROLINA

**JOB LOSS:** A study by two Ohio University economists for the American Legislative Exchange Council (ALEC) projects North Carolina would lose 29,400 jobs. CONSAD Research Corporation, an econometric forecasting firm, estimates that 24,685 North Carolina workers would lose their jobs, and another 636,627 would face reduced wages, hours or benefits.

**WAGES AND BENEFITS LOST:** According to the ALEC study, North Carolina workers would suffer a loss of wages and benefits of \$2.32 billion, while CONSAD estimates a drop of more than \$791 million in wages alone. The CONSAD study observes, "when business owners are faced with increased labor costs due to health care reform, they will attempt to pass the increase on to employees in the form of lower wages and fewer benefits."

**PERSONAL INCOME LOSS:** North Carolina residents would lose \$2.77 billion in personal income, concludes the ALEC study, or a loss of \$1,600 to the average family of four.

**MEDICARE IMPACT:** North Carolina hospitals would feel the strain of the \$118 billion in Medicare cuts contained in the President's proposal. An analysis by Lewin-VHI for the American Hospital Association estimates that by the year 2000 the Clinton plan would result in Medicare reimbursing North Carolina hospitals only 65 cents for every dollar in services rendered.

The study notes: *"Some communities may see their hospitals close for the wrong reasons--not because they are no longer needed, but because they are financially weak...These hospitals may be the very ones that need to remain open to assure access and coverage to underserved populations and achieve the broader goals of health care reform."*

**STATE/LOCAL REVENUE IMPACT:** According to the ALEC study, "It is argued that the Administration's health care plan is a windfall to states. There are two factors which proponents of this point of view neglect which essentially negate the validity of this argument. First, state and local governments will be paying health care taxes ('premiums') on their own employees under the Administration's plan...Second, and far more substantial, the decline in personal income discussed above means a substantial loss in state tax revenues."

Consequently, the ALEC study concludes that North Carolina would lose \$411 million annually in much needed revenue.

### It's the Mistakes, Stupid! Campaign Gaffes in N.C., Ky.

One of these days I'm going to write a book about the 32 mistakes that candidates make in political campaigns. I don't know if the number is really 32 — as opposed to 22, or 42, or whatever. But there does seem to be a finite number of mistakes that I see being made over and over again. Amazingly, there's very little in the way of new mistakes.

Over the last few weeks a promising and impressive Republican Congressional candidate in North Carolina has self-destructed and a frontrunning Democratic candidate for a special House election in Ken-

tucky has shot himself in both feet, figuratively speaking, making a lead-pipe-cinch race into a considerably more interesting contest.

In both cases, stupid mistakes are the culprits.

In North Carolina, state House Minority Leader David Balmer was locked into a tight GOP runoff with former Charlotte Mayor Sue Myrick for the open House seat of retiring Rep. Alex McMillan (R). As the district is very Republican, the GOP nomination was tantamount to victory.

Balmer, who is 32 and an investment banker (though he also has a law degree), had made the Washington rounds early on and was one of the most impressive House candidates I've seen this election cycle. Indeed, I told a number of people that I

thought that if he won the seat, he would be a good bet to make it onto the GOP Congressional leadership ladder down the road.

As the Republican leader in the North Carolina House, he had prepared a very impressive alternative budget for his caucus to present and came across as someone who easily could become a player very soon after arriving in Washington.

Though not as well-known as Myrick, who lost the 1992 Republican Senate primary to Lauch Faircloth, Balmer had raised over \$221,000 so far and had a cash-on-hand balance, according to the Charlotte Observer, that was four times higher than any other candidate in the race. He trailed Myrick by 4 points in the May 3 primary, but he was in a very good position to take the May 31 runoff.

Then the story started getting around that Balmer had embellished his resume a bit. He claimed that he had been in the top 20 percent in his law school class and had made the law review (actually, he had been in the top 20 percent for one semester), that he had played varsity soccer at the University of North Carolina (actually, it was intramural), and that he had clerked for a state Supreme Court justice (actually, it was more of an internship).

There are two tragic elements to the Balmer story: First, he had an impressive record to run on, without the embellishments. There was simply no need to do it, and I can't imagine that his fibbing pushed his candidacy one inch further than it already would have gone. Second, when he got caught, he tried to deny it and blame others rather than take the rap and try to move on. He made a bad situation significantly worse.

In Kentucky, the late Rep. Bill Natcher's (D) Congressional seat has been in Democratic hands seemingly forever, but it is very conservative; Clinton lost the district by 4 points in 1992. Natcher died after the Jan. 25 filing deadline, so Republicans were stuck with candidates who'd already filed for the seat and couldn't choose a new nominee for the special election (if they did, that

person may have won this coming Tuesday's special election but would not have been able to run in the general election in November).

As a result, Republicans seemed to be stuck without a strong candidate in what should be a good district for them. The conventional wisdom was that Democrats had a lock on the seat this year but might have a difficult time holding onto it in 1996. The Republican candidate in question is Ron Lewis, a little-known owner of a Christian bookstore who was widely seen as a stone loser.

The problem is that the heavily favored Democrat, former state Sen. Joe Prather, decided to get cute. He announced that he would take no out-of-state money, no PAC money, and no money from the Democratic party committees. While maybe he might have reason to believe he wouldn't need all of that money this year, he certainly would have in 1996. Nevertheless, he painted himself into a corner.

Next, the story broke that Prather was already shopping around for an apartment in Washington, something that is usually seen as bad luck, not to mention really bad form since the voters haven't officially crowned him Congressman. The third shoe dropped when Lewis launched an unexpected television blitz, with ads produced by the National Republican Congressional Committee. He caught Prather off-guard.

So now we have a very competitive race in Kentucky, which should be solidly in the Democratic column — at least for 1994.

Maybe next year I'll write my book. For now, the material just keeps on rolling in.



NC 09 (5/31 RUNOFF): Charlotte City Council member Don Reid (R), who finished fourth in the 5/3 primary, called for state Rep. David Balmer (R) to withdraw from the race. Reid said "Balmer's staying in the race is hurting the [GOP] and could jeopardize its hold on the traditionally safe seat." Balmer admitted last week "that he padded his resume," but he said 5/17 that he had no intention of withdrawing. Reid "said he's not being a sore loser": "I don't like to lose. But if I had lost fairly, I could accept that. I feel cheated." Reid said he was "no fan" of ex-Charlotte Mayor Sue Myrick (R), but he said he wouldn't vote for Balmer (Moore, GASTON GAZETTE, 5/18).


NC 09 RUNOFF (5/31): John Hood, VP of the John Locke Foundation, a conservative Raleigh think tank, said House Min. Leader David Balmer (R) "sent him an embellished resume in the spring of 1993 a month before Balmer says a former campaign worker doctored it." The resume says Balmer played varsity soccer at UNC-Chapel Hill and graduated in the top 20% of his class at Wake Forest Law, "neither of which is true. ... When the embellishments first became public two weeks ago, Balmer blamed primary opponent Don Reid. A day later he blamed an unnamed campaign worker while taking 'full responsibility for all actions of my campaign.'" On 5/12, posed with 12 questions on the matter, Balmer responded with the same phrase to each one -- "I've already addressed this issue and humbly taken full responsibility for it" (Morrill, CHARLOTTE OBSERVER, 5/13). OBSERVER's Robarchek, on Balmer's resume explanations: "Should that name be spelled 'Blamer'?" (5/11). While some GOPers who supported Reid or 3rd place finisher Neil Williams in the primary are backing ex-Charlotte Mayor Sue Myrick in the runoff, Williams himself is remaining neutral (OBSERVER, 5/12). The winner meets Rory Blake (D) for the seat vacated by Rep. Alex McMillan (R).
