Panels wind up work on health care bills

Four committees down, one deadlocked...That's how Congress ended up its session before leaving the nation's capital for a July 2-10 recess.

On July 2 Sen, Movnihan's Senate Finance Crite passed a health care bill, becoming the fourth and final congressional panel to complete work. The Finance bill is the only one without employer mandates...instead, creates a commission to recommend further action if 95% of Americans don't have health care coverage by 2002, Panel members were so wary of mandates that they even voted down a "hard trigger."

The fifth panel that had been working on a bill—the House Energy & Commerce Cmte—finally gave up trying last week, hopelessly deadlocked over the issue of employer mandates.

Now Dem leaders will try to meld bills to bring to the House, Sengte floors...In the House, it'll be up to the House Rules Crite (closely supervised by House leaders) to look over the bills passed by the Ways & Means and Education & Labor Crites and decide what type of bill goes to the House floor, what amendments can be offered, time limits for debate, etc. That panel will get down to work soon after Congress reconvenes July 11.

Senate debate is always more free-wheeling—and Senate leaders have to deal with two very different bills—Sen. Maynihan's Finance bill and the Clinton-like plan that Sen. Kennedy's Labor Crite passed last month.

Another Senate wild card is the proposal laid out June 30 by GOP Sens. Bob Dole and Bob Packwood. The Nat'l Restaurant Assn supports the Dole-Packwood plan, which is similar in many ways to the Rowland-Bilirakis bill in the House.

Grassroots action needed

As we mentioned, members of Congress are back home July 2-10... An extremely critical time for restaurateurs to make contact.

The Nat'l Restaurant Assn believes some of the most important grasspole action is needed in states represented by moderate Senate Democrats, including the following: Ala.: Shelby, Heflin; Colo.: Nighthorse Campbell; Conn.: Lieberman; Georgia: Nunn; Ky.: Ford; Lauisiana: Johnston; Neb.; Exon; N. Dakota: Dorgan; S. Carolina: Hollings.

If you are in one of these states, we urge you to call your Senator's office immediately or try to set up a meeting while your Senator is home. Your message: "Employer mandates are a tax on jobs. Please support the incremental changes Senator Dole has proposed."

Town mtg scheduled for over 130 sites

Restaurateurs will gather at over 130 sites around the U.S. the morning of Tues., July 12 for the "Restaurant Industry Town Meeting on Health Care."

The July 12 special will be transmitted live via satellite from Hospitality Television (HTV) headquarters in Lauisville, KY. Nat'l Restaurant Assn president Herman Cain will address a studio and satellite audience on the impact of employer mandates; outline alternative proposals in Congress that the restaurant industry supports; and tell

restaurateurs what they can do to influence the health care debate's outcome.

The timing couldn't be better...the Town Meeting comes one day after Congress reconvenes in Washington, DC, following its July 4th recess—just as Congress's Democratic leaders begin trying to get health care bills through both the House and Senate before Congress's August recess.

Assn runs new ad on "triggers"

The Nat'l Restaurant Assn is airing a new TV ad July 5, 6, 7...30-second spot specifically denounces delayed employer mandates, also known as "triggers."

The trigger approach would set goals for insurance coverage by a certain date...if these goals weren't met, employer mandates would either kick in automatically (an option known as a "hard trigger") or Congress would be required to reconsider imposing a mandate (a "soft trigger").

The Nat'l Restaurant Assn opposes any approach that relies on mandates and

believes meaningful health care reform is possible without mandates.

The ad features a seven-year old girl and her artwork to illustrate in the simplest terms possible business's concern over the trigger approach. "Today's word is 'Trigger,'" narrates the girl in the ad. "Trigger' means Congress can pass a health care bill now, but they can push off all the bad stuff 'til later."

The ad will air in selected cities in Connecticut, Maine, Massachusetts, Missouri, New York, Pennsylvania, South Carolina, South Dakota, Washington, DC, Washington

State, and West Virginia.

Press conference in Montana

Big Sky Caalition gets hig results...A Montana coalition held a June 28 press conference June 28 to announce their opposition to employer mandates.

The group, made up of the Montana Restaurant Assn. auto dealers, innkeepers, contractors, and other retailers, was trying to send a message to Sen. Max Baucus (D).

Apparently Baucus was listening. Two days later, Baucus, who sits on the influential Senate Finance Crite, voted to drop a "hard trigger" from that committee's health care proposal.
