MEANWHILE, REP. DURWAFD G. HALL, R-MO., IN A SPEECH PREPARED FOR
IVERY ONNTHE HOUSE FLOOR, SAID, "AN IMPARTIAL INVESTIGATION IS DELIVERY ONNTHE HOUSE FLOOR, SAID, "AN IMPARTIAL INVESTIGATION IS
DESPERATELY NEEDLD."

"EXPERIENCE HAS SHOWN THAT IT CANNOT BE EXPECTED FROM EITHER THE
DEMOCRAT-CONTROLLED LEGISLATIVE BRANCH OR THE DEMOCRAT-LED ADMINISTRATION," THE GOP LAWMAKER SAID.

HALL SAID, "I BELIEVE A SPECIAL ASSISTANT TO THE ATTORNEY GENERAL
SHOULD BE APPOINTED TO CARRY OUT SUCH AN INVESTIGATION WITH THE POWER
TO IMPANEL A FEDERAL GRAND JURY. AND I BELIEVE SUCH A SPECIAL ASSISTANT SHOULD BE NAMED BY AN IMPARTIAL ORGANIZATION SUCH AS THE AMERICAN BAR HALL CHARGED IN HIS SPEECH THAT "THE CONSPIRACY TO WHITEWASH THE HALL CHARGED IN HIS SPEECH THAT "THE CONSPIRACY TO WHITEWASH THE BOBBY BAKER INVESTIGATION CAN NO LONGER BE ATTRIBUTED MERELY TO THE DEMOCRAT MAJORITY IN THE OTHER BODY (THE SENATE)."

REP. BOB DOLE OF KANSAS, CHAIRMAN OF A HOUSE REPUBLICAN GROUP INVESTIGATING THE BAKER CASE ON ITS OWN, DEMANDED THAT THE HOUSE ADMINISTRATION COMMITTEE SUMMON A FORMER HOUSE DISTRICT COMMITTEE CLERK FOR TESTIMONY.

DOLE SAID MCLEOD, ACCORDING TO WILLIAMS' INFORMATION, WAS WORKING WITH BAKER TO SECURE HOUSE APPROVAL OF THE D.C. STADIUM BILL WHEN IT WAS BEFORE CONGRESS.

"MCLEOD ALREADY HAS ADMITTED HE RECEIVED A \$1,500 GIFT FROM DON B. REYNOLDS, MARYLAND INSURANCE BROKER, IN RETURN FOR MCLEOD'S HELP IN GETTING THE STADIUM BILL THROUGH THE HOUSE, DOLE SAID. "HE HAS NEVER BEEN SUMMONED FOR CONGRESSIONAL QUESTIONING, HOWEVERE "IN THE LIGHT OF SENATOR WILLIAMS' CHARGES, THERE IS EVEN MORE REASON FOR THE HOUSE ADMINISTRATION COMMITTEE TO CALL MCLEOD NOW. HE OBVIOUSLY COULD PROVIDE THE COMMITTEE WITH A GREAT DEAL OF NEW INFORMATION ON THE INVOLVEMENT OF MR. JOHNSON IN THE BAKER CASE, DOLE MADE HIS COMMENTS IN A STATEMENT TO THE PRESS.
