DOLE TALKS ABOUT RECENT SUPREME COURT'S DECISION ON STATE REAPPORTIONSENT LAST THURSDAY NOON IN WAKEENEY AT LUNCHEDN

CONGRESSMAN BOB DOLE ADDRESSED STUDENTS AND FACULTY MEMBERS OF TREGO COMMUNITY HIGH SCHOOL LAST THURSDAY MORNING AT A SPECIAL ASSEMBLY MEETING. HIS TALK WAS FOLLOWED BY A CURSTION AND ANSWER PERIOD. HE GAVE THE STUDENTS A NON-POLITICAL EXPLANATIONS OF THE REAPPORTIONMENT DECISION BY THE SUPREME COURT LAST JUNE 15.

Dole SPOKE AT A NOON LUNCHEEN TO ABOUT SEVENTY PERSONS. HE BLASTED THE SUPERME COURT DECISION AS AN INITIAL STMP IN BREAKING DOWN OUR FORM OF GOVERNMENT. "THE CNE-MAN-ONE-FOTE RULING COALD CUT OUR VOTE IN WESTERN KANSAS IN HALF" HE SAID.

UNDER THE RECENT RULING, DOLE EXPLAI ED BOTH HOUSES OF THE STATE LEGISLATURE WOULD BE REAPPORTIONED ON A POPULATION BASIS ONLY, AND APPROXIMATELY 17.400 PECELE WOULD REFRESENT ONE VOTE. IN THE WESTERN PART OF KANSAS IT WILL TAKE SIX COUNTIES TO MAKE ONE VOIE, UNDER THE NEW RULING. " THIS IS A STATE POLITICAL MATTURE WHICH SHOULD BE HANDLES ON THE STATE LEVEL", DOLE ADDED.

AFTER THE JUNE 15, SUPREME COURT DECISION, DOLE INTRODUCED A RESOLUTION IN THE HOUSE FOR AN AMENDMENT OF THE CONSTITUTION WHICH WOULD RESERVE STATE LEGISLATURE APPORTIONMENT POWER TO THE STATE. CONGRESS ADJOURNED WITHOUT TAKING ANY ACTION

CONGRESSMAN DOLE SIVES VERBAL SUPPORT OF TO BARRY GOLDWATER. DOLE SAYS "HONESTY SHOULD NOT DISQUALIFY FROM SECONING PRESIDENT of the united leads
