Congressman Bob Dole (R-Kans) stated today that returns on the First District "Opinion Poll" have now been tabulated. It is significant to note that some 15,000 persons participated in the "Opinion Poll".

As the questionnaires were returned, they were tabulated on a countyby-county basis and then scored for the District percentages.

Western Kansans feel very strongly as indicated on the attached sheet that: (1) "anti-poverty funds should not be increased; (2) one House of a State Legislature should be apportioned considering factors other than population; (3) Section 14 (b) of the Taft-Hartley Act should not be repealed; (4) the House Committee on Un-American Activities should not be abolished; (5) unemployment compensation programs should not be centralized and federalized.

Dole said, "It is quite interesting to note that Western Kansas residents are almost evenly divided on four-year terms for members of the House of Representatives. Perhaps the greatest surprise throughout the tabulation process was the great number -- over 80 percent -- who feel that America's prestige in the world has declined since 1960. An extremely high percentage feel strongly against protest demonstrations with reference to our policy in Viet Nam; and, in addition, over 90 percent feel that they have not been helped by the passage of any "Great Society" program.

A great number of the participants made additional comments, and almost without exception mentioned the crisis in Viet Nam. Many others commented on the increasing powers of the federal government.

Returns of each county have been sent to the press media in the respective counties. "Anyone desiring a copy of the results in his particular county should write Congressman Dole at 243 Cannon House Office Building, Washington 25, D. C.," said Dole.

Attached hereto is a breakdown of the results of the entire District.
