

IN TESTIMONY BEFORE THE SENATE COMMITTEE ON INTERIOR, IN BEHALF OF INDIAN IOWA NATION, U.S. SEN. BOB DOLE URGED PASSAGE OF A BILL HE INTRODUCED TO AUTHORIZE PAYMENT OF THREE JUDGEMENT AWARDS BY INDIAN CLAIMS COMMISSION TO MEMBERS OF IOWA TRIBE OF KANSAS AND NEBRASKA AND OF IOWA TRIBE OF OKLAHOMA.

IN A STATEMENT FRIDAY, THE KANSAS SENATOR SAID, " IT IS A PARTICULARLY BLACK MARK IN OUR NATION'S OTHERWISE SORRY TREATMENT OF OUR INDIAN PEOPLE THAT WE SHOULD BE WAITING SIX SCORE AND MORE YEARS TO CONSIDER FUNDING THESE JUST AND REASONABLE CLAIMS. AND IT WOULD BE A FURTHER BLEMISH ON THE RECORD WERE CONGRESS NOT TO AUTHORIZE THE PAYMENT OF THESE CLAIMS WITH ALL POSSIBLE SPEED. AFTER 117 YEARŞ, IT IS TIME TO ACT."

DOLE WAS REFERRING TO AWARDS TOTALING \$5,956,413.67 REPRESENTING FUNDS FOR INDIAN LANDS CEDED UNDER TREATIES NEGOTIATED IN 1836,1838 and 1854. DOLE SAID THAT FUNDS TO PAY THESE AWARDS, WERE APPROPRIATED BY THE CONGRESS IN ACTS OF DECEMBER 26, 1968 and July 6, 1970. HE EXPLAINED THAT BOTH TRIBAL GOVERNMENTS, THE TOWAS OF KANSAS AND NEBRASKA AND THE IOWAS OF OKLAHOMA, HAVE PASSED RESOLUTIONS REQUESTING THE FUNDS
