THIS ARTICLE INFERENTIALLY COMPARED JUDGE O'CONNOR WITH FRANCIS X. MORRISSEY, A 1965 JUDICIAL NOMINEE OF SENATOR KENNEDY, WHOSE WHOLESALE LACK OF QUALIFICATIONS APPALLED THE ORGANIZED BAR, THE SENIOR FEDERAL DISTRICT JUDGE IN MASSACHUSETTS, AND EVEN THE NEW YORK TIMES.

MORRISSEY'S LEGAL TRAINING HAD CONSISTED OF ONLY THREE MONTHS
IN A LAW DEGREE FACTORY WITH ONE DEAN, ONE PROFESSOR AND NO LAW
LIBRARY; OTHERWISE, HIS QUALIFICATIONS RELATED SOLELY TO HIS
FRIENDSHIP WITH THE KENNEDY FAMILY.

JUDGE O'CONNOR, IN CONTRAST, HAS HAD AN OUTSTANDING LEGAL
CAREER. HE WAS AN HONOR STUDENT AT THE UNIVERSITY OF KANSAS LAW
SCHOOL, MEMBER OF THE LAW REVIEW, AND PRESIDENT OF HIS LEGAL
FRATERNITY. HE HAS HAD NEARLY TWENTY YEARS' EXPERIENCE IN THE KANSAS
JUDICIARY; HIS NOMINATION TO THE FEDERAL COURT RECEIVED WIDESPREAD
SUPPORT FROM KANSAS LAWYERS; HE WAS FOUND TO BE QUALIFIED FOR THE
POSITION BY THE AMERICAN BAR ASSOCIATION; AND THE CHIEF JUDGE OF THE
10TH CIRCUIT U.S. COURT OF APPEALS APPEARED PERSONALLY BEFORE THE
SENATE JUDICIARY COMMITTEE TO SHPPORT HIM. HIS NOMINATION WAS
