## ACTUALITY---AMTRACK

I HAVE CONTACTED TRANSPORTATION SECRETARY CLAUDE BRINEGAR REGARDING THE POSSIBILITY OF INCREASING AMTRACK SERVICE IN THE STATE OF KANSAS.

SECRETARY BRINEGAR INDICATED THAT HE WOULD TAKE INTO CONSIDERATION MY REQUEST FOR A KANSAS CITY--DENVER ROUTE DEVELOPED AS AN EXPERIMENTAL ROUTE UNDER THE AMTRACK IMPROVE-  
MENT ACT OF 1973. HE ALSO SUGGESTED THE UTILIZATION OF A PROVISION IN THE 1970 ACT WHICH WOULD MAKE AVAILABLE ADDITIONAL SERVICES TO THE STATE IF THE STATE AGREES TO REIMBURSE AMTRACK FOR 2/3 OF THE LOSSES INCURRED BY THE OPERATION.
