DOLE SELECTS 45 FOR ACADEMY NOMINATIONS

WASHINGTON, D.C. -- Kansas Senator Bob Dole has selected 45 young Kansans as nominees to compete for appointments to the United States Air Force Academy, Merchant Marine Academy, Military Academy, and Naval Academy.

"These young men and women have demonstrated exceptional academic preparation and outstanding leadership qualities along with their strong commitment and desire to serve our country. I am proud to recommend these outstanding young Kansans for training to serve in our nation's armed forces," said Dole.

In addition to the nominees named by Senator Dole, several other highly qualified candidates have already been offered admission through other sources. To avoid unnecessary duplication, those individuals were not included on Senator Dole's list.

Using the competitive method of nomination, Senator Dole selects a slate of ten individuals for each vacancy he intends to fill. As the final step in the process, each academy then evaluates the candidates and offers an appointment.

The nomination process begins in the fall, usually during the senior year of high school. At that time, those interested should contact Senator Dole and each academy admissions office for application materials. The deadline for submitting the completed forms is early December.
