AT LEAST \$72,775 DUE KANSAS SITS IDLE IN WASHINGTON

DOLE, KASSEBAUM MOVE TO HELP KANSAS TOWNSHIPS CLAIM REVENUE SHARING FUNDS

WASHINGTON -- Kansas Senators Bob Dole and Nancy Kassebaum are working together to make sure Kansas cities and townships file for revenue sharing payments that are now being held for them by the U.S. Department of the Treasury. The funds are available immediately, but cannot be released until the proper federal forms are filed.

A Treasury report shows that 41 state townships have not submitted the necessary data for the government to even make an estimate on how much revenue sharing they are due.

According to Senators Dole and Kassebaum, as of July 5, many Kansas towns and townships have simply not filed the proper forms under the Revenue Sharing Act, or are unaware that the funds are awaiting action.

The 129 local Kansas governments are due a minimum of \$72,775.00.

"Nancy and I will do our best to have our staffs advise each and every one of the Kansas city halls of the situation that exists," said Dole. "There's just no sense in letting this money sit idle -- it is already designated for Kansas, but, for whatever reason, it just isn't getting to us yet."

"One town is due almost \$10,000," said Senator Kassebaum. "I urge city officials to get in touch with our offices so that we can get this problem straightened out as soon as possible."
