39 SELECTED BY SEN. DOLE FOR ACADEMY NOMINATIONS

Washington, DC -- Kansas Senator Bob Dole has selected 39 young Kansans as 1987 nominees to compete for appointments to the United States Air Force Academy, Merchant Marine Academy, Military Academy and Naval Academy.

"These nominees speak well for the quality of our Kansas youth -- their academic preparation, leadership qualities and physical fitness are exemplary," Dole said.

Using the competitive method of nomination, Sen. Dole selects a slate of ten individuals for each vacancy he intends to fill. As the final step in the process, each academy then evaluates the candidates and offers an appointment.

Admission representatives are now contacting successful candidates. Notification will continue through the middle of April.

A few candidates were offered an appointment after receiving a prior nomination from another office. To avoid unnecessary duplication, those individuals are not included on Sen. Dole's list.

The nomination process begins in the fall, usually during the senior year of high school. At that time, those interested in a possible academy appointment, should contact Senator Dole and each academy admissions office for application materials. The deadline for submitting the completed forms is early December.
