## DOLE CHARITABLE CONTRIBUTIONS TOP \$700,000

Kansas Charities Get Lion's Share,  
New Financial Disclosure Records Show: \$34,500 in 1990

Washington - Donations to charities - most of them in Kansas - from Senate Republican Leader Bob Dole (R-KS) have now topped the \$700,000 mark during the past 10 years, according to official financial disclosure records released today.

Senator Dole has a longtime practice of diverting speaking fees to charitable organizations. For 1990, Dole reported that he had given \$47,700 to charity, \$34,500 of which went to Kansas charities.

For the 10 year period 1981 - 1990, Senator Dole has donated \$711,364.88 to charity, a figure that represents 64% of all speaking fees offered to the Senator during that time.
