Senator Bob Dole's 1988 presidential campaign and the Federal Election Commission have reached a Conciliation Agreement ending all remaining legal disputes, Dole's office announced. The agreement comes five years and four months after Senator Dole officially withdrew from the 1988 race.

Under the agreement, the 1988 campaign committee has agreed to refund \$104,000 in contributions -- many as small as \$1.00 -- that the FEC contends were either excessive or prohibited. Those contributions represent about one half of one percent of the approximately \$17.8 million raised by the campaign from more than 100,000 contributors. Despite strongly disputing many of the FEC's claims, the campaign committee has also agreed to pay a penalty of \$100,000 in an effort to bring the matter to a close.

Much of the penalty stems from exceeding, in Iowa and New Hampshire, spending limits imposed on candidates who accept federal Presidential Election Campaign Funds.

"It's ironic that the FEC has already changed many of the rules on which they based this penalty against the campaign committee," Senator Dole said. "We've learned a lot about dealing with federal agencies, and this bureaucratic process is the best example yet of why we don't need public financing of congressional campaigns.
