SUBJECT: Talking Points for Paul Fay Group

I spole wilth Paul Fay this morning about your 2:00 p.m. event with Paul Fay's group. You are scheduled for an informal 10 minute talk before a group of 20-25 representatives from the financial services sector. Mr. Fay asked that you mention the bills -- affecting the banking, securities and insurance industries -- which will likely pass this Congress.

He also asked that you provide your insight into the Presidential race. I would suggest that you focus most of your comments on the Presidential race.

Mr. Fay asked that you remain for questions and answers.

Talking Points:

- I. Repeal of Glass-Steagall:
- o Final passage of a comprehensive banking bill is unlikely this year. The bill appears to have stalled in the House because of the large differences between the House Banking Committee's version of the bill and the version reported out of the Energy and Commerce Committee.
- Senator Proxmire has not given up yet. He is doing everything in his power to get a bill passed before he retires.
- o Proxmire is circulating a new proposal which would add a watered down version of the so-called "consumer protection" provisions in the St Germain bill to the Proxmire bill that passed the Senate in March. There are so many objections to these consumer protection provisions that I don't think this new package would even pass the Senate.
- There no longer appears to be a constituency for even the Senate-passed version of the bill. Almost every group affected by this legislation would prefer no bill to <u>either</u> of the Banking bills that are floating around the Hill.
- II. The Savings and Loan Industry
- The thrift industry has been covered in every major newspaper in the country over the past few weeks. In Washington, we have seen a lot of partisan finger-pointing.

- We will not have time to deal with the thrift industy's problems in 1988. What we <u>can</u> do is appoint a National Commission to study the problems in the thrift and banking industries, and I think we will.
- o In my view, the thrift industry's problems should be a top agenda item for the next Congress and the next President.
- III. Technical Corrections bill
- Congress should pass a Technical Corrections this year, but it will be difficult to do anything more than a stripped down bill. I hope that we can at least pass the true technical corrections and the diesel fuel tax exemption for farmers and others.

IV. Dole Suggestions

 In my view, what we ought to do is pack up our bags, go home, and get a Republican majority elected in the Senate. So that President Bush will have a friendly place to go in the 101st Congress.
