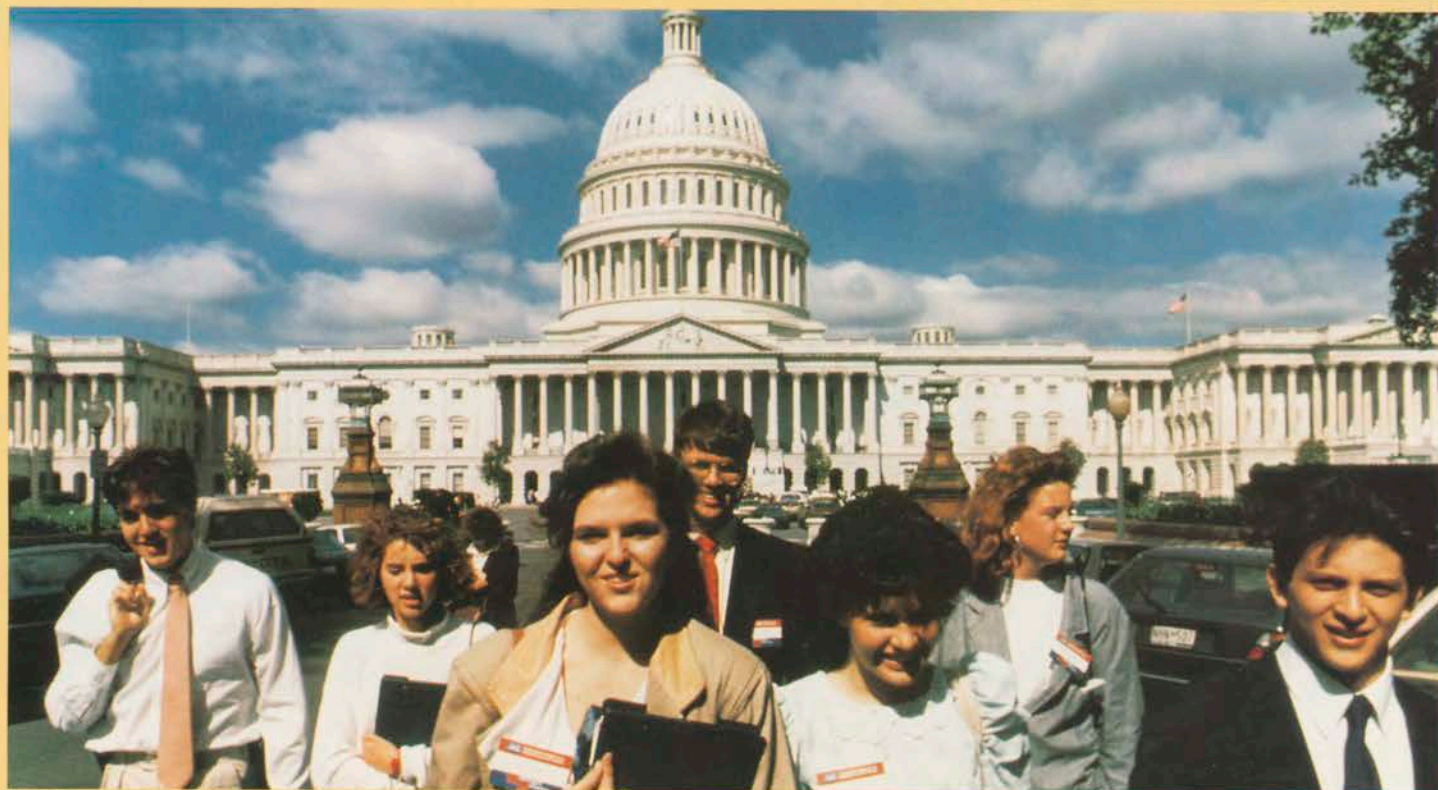
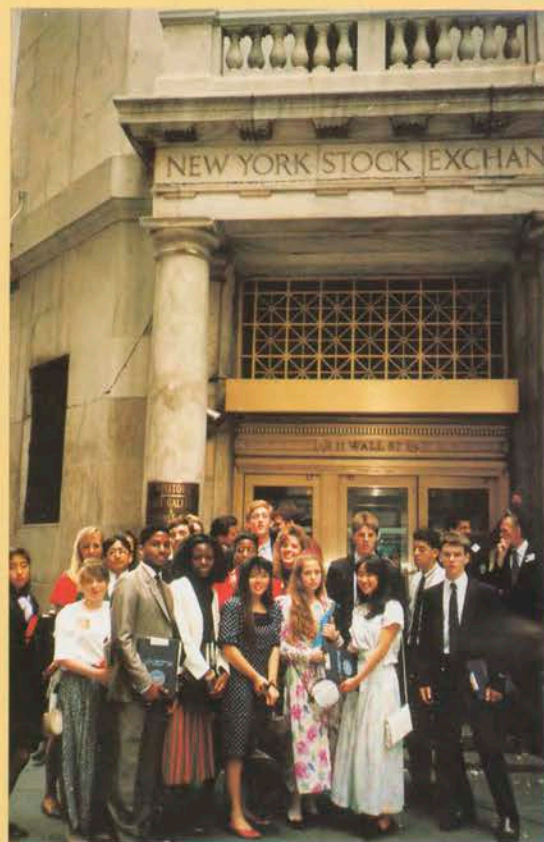

**T**he Congressional Seminar is the nationally acclaimed citizenship education program for secondary school students presented from January through June each year in Washington, D.C.

Now celebrating its 23rd anniversary, the Congressional Seminar offers a fully supervised, professionally administered, university-based program of insight and instruction into American national government, and in particular, the concerns and activities of the United States Congress.

Through the years, many thousands of young Americans have participated in Washington Workshops seminar programs. Whatever a student's career objective—political science, law, journalism, the arts, medicine, etc.—the Congressional Seminar offers a unique overview of the politics and personalities of Washington. From the seminar's constant exchange of questions and answers, students have an opportunity to personally express to government leaders and opinion makers their concerns and feelings about America, and, in turn, receive answers reflecting the highest level of public policy. From this exchange, both groups share an increased understanding, and, in a broader sense, seminar students learn from each other as new and lasting friendships are made in an atmosphere of mutual interest and exciting events.

Certainly, young Americans have a vital interest in just what is debated and passed in the Congress of today, for this legislation will fashion the policies and philosophies of tomorrow—a time when teenage Americans will assume their voting rights, and go on to adulthood and positions of leadership in an America of the 21st century.

The work of government is the work of all Americans, young and old alike, and in this work, the necessity for knowledge is paramount. For in the wise and timeless words of James Madison,

*"Knowledge will forever govern ignorance; and a people who mean to be their own governors, must arm themselves with the power which knowledge gives."*

Responding to this challenge, and bringing to citizenship education a new vitality where theory can be matched to the workings of government, the Washington Workshops Congressional Seminars were established over two decades ago, and continue today to offer invaluable and unique educational opportunities to young Americans everywhere!

## The Seminar Experience

■ **THE CONGRESS**—An important part of each one-week seminar is devoted to scheduled discussion meetings with Senators, Congressmen and Congressional aides, normally held in Congressional committee rooms on Capitol Hill, stressing a question and answer format conducive to maximum student input. Additional time is available throughout the week for students to attend House and Senate sessions and Congressional committee meetings.

■ **EXECUTIVE AND JUDICIARY**—In order to better understand the relationship of Congress to the rest of government, sessions are scheduled each week with high ranking officials of various government departments and agencies, such as White House staff, Pentagon officials, and Judiciary personnel—all of whom help to fashion the day-to-day workings of national government.

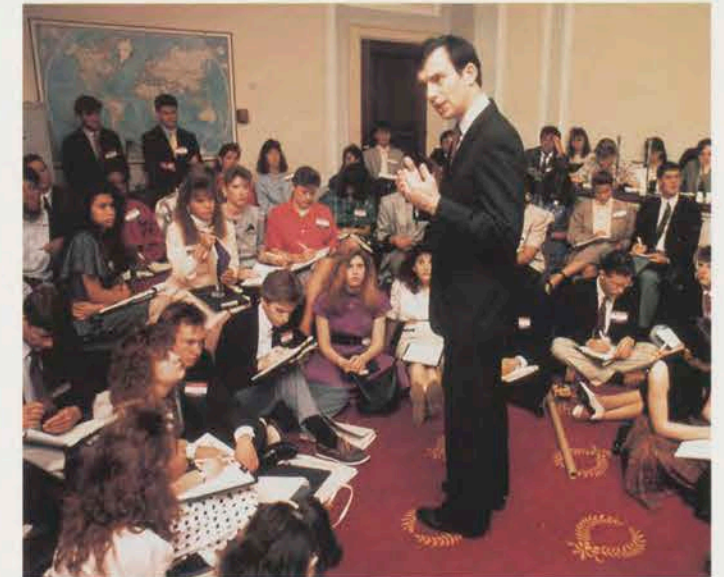
■ **MODEL CONGRESS**—The Model Congress offers an opportunity for each student to learn by role-playing the difficult task of developing national policy and writing laws. Each evening, students divide into several committees to discuss and draft legislation. On Friday the final legislation will be reported by each committee to the entire seminar group. Debate, which is governed by modified House procedures and rules, is always very spirited and great fun!

■ **INTERNATIONAL**—Each session brings an Ambassador to campus for an evening talk. These meetings provide a fine opportunity for added perspective into America's role in the international community. Also, if during a session a visiting Head of State makes an official visit to Washington, Workshops students are often invited to attend the impressive welcoming ceremonies on the White House South Lawn.

■ **ACADEMIC OVERVIEW**—To provide an in-depth look at current domestic and international issues before the Congress, the Congressional Seminar hosts a series of special lectures throughout the week by leading professors from Georgetown University. These talks also provide an excellent opportunity to clear up questions students may have on the wide-ranging discussions of the day.

■ **CAREER ORIENTATION**—Washington, D.C. as a world center provides a rich resource of professional talent in fields as wide ranging as public policy, law, the arts, journalism, economic analysis, and international relations. To help students better understand the career potentials associated with these endeavors, The Washington Workshops has traditionally sought to include members from these fields as an integral part of the day and evening program.

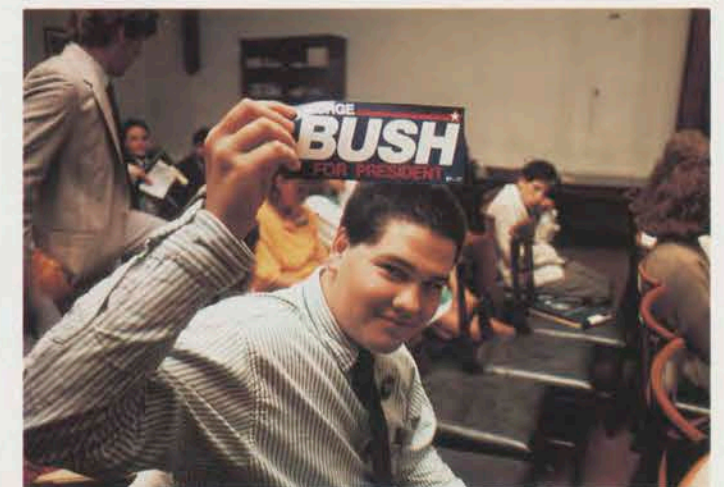
■ **INDIVIDUAL INITIATIVE**—Throughout the seminar, individual initiative is the rule. With no formal class assignments, any line of legitimate interest and student debate is in order, and the professional staff maintains an objective and non-partisan contact that will never stifle reasoned and mature student inquiry. The Congressional Seminar, while fashioned by a competent and dedicated organization, still remains in final analysis what the students make of it.

## University Residence

As compared with other student programs in our nation's capital, the Washington Workshops stands alone in making university campus residence—and not hotel living—an integral and important aspect of the Workshops experience.

All 1990 Congressional Seminar sessions will be based at either Marymount University in suburban Virginia, or on the campuses of Georgetown University or American University located in northwest Washington.

For the January through April sessions, Georgetown University or American University's conference complex will be the home base of the Congressional Seminar. These academic centers provide an exceptional environment amidst safe and secure surroundings in residential northwest Washington. The facilities are among the finest available; double occupancy rooms being the norm. Breakfast and dinner will be provided each day in the nearby campus dining room. In addition, the superb facilities of the Georgetown University Medical Center are literally only minutes away in the event of emergency need.

Starting in May, Congressional Seminar participants will live at Marymount University, a short ride across Washington's Potomac River, in Arlington, Virginia. This rustic, all-enclosed campus is located on the former estate of Admiral Presley M. Rixey, Surgeon General to President Theodore Roosevelt. This campus offers a relaxing living environment, complete with a large swimming pool and playing fields, all a welcome relief after long and often hot summer days on Capitol Hill. Once again, breakfast and dinner are provided in the campus dining room. Around the clock nursing care and the facilities of nearby Arlington General Hospital are available for any emergency that may arise.

The Washington Workshops is aware that many students will be a good distance away from home, many for the first time. Thus, a number of rules and campus regulations will be in effect to ensure the very safest and most responsible program possible, both on campus and throughout the Washington area. A student handbook, detailing these matters will be sent with all acceptance letters.



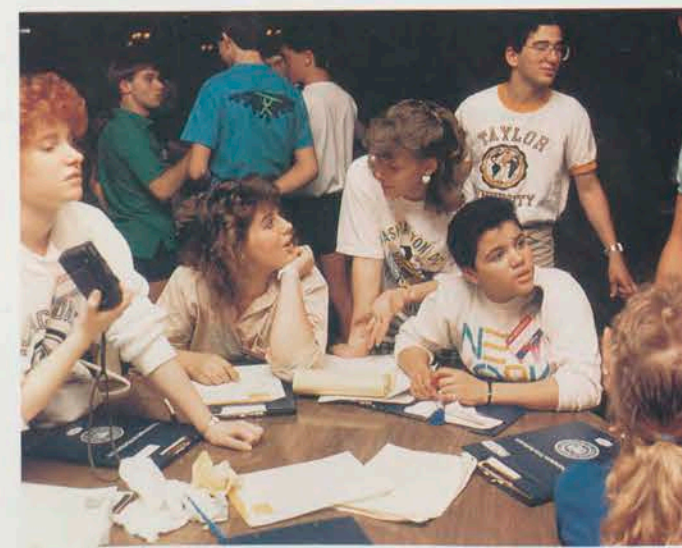

### College Admission

Past experience has shown that participation in the Congressional Seminar is of decided interest to college admissions officers who are increasingly seeking students with high motivation, personal initiative, and interest in public

affairs. The Washington Workshops Foundation presents each student with a Completion Certificate and will further verify, upon request, the student's participation in the Seminar.

### Session Size

Congressional Seminar sessions have an average enrollment of 100 students, often representing 30 or more states plus two or three foreign countries. This enrollment philosophy of reasonably-sized seminar sessions embodies one of the hallmarks of the Congressional Seminar, as it not only ensures maximum personal student participation in questioning speakers, but allows the students an opportunity to share among themselves differing perspectives, attitudes, and backgrounds.

### Student Supervision

Safety and care of the students will be of constant concern to the seminar administrators, who are in a ratio of approximately one to 20 students. The college campus maintains 24 hour security personnel. In addition, the Workshops' counselors and advisors—all of whom are college and university graduate students—reside in the campus dormitories and are with the students throughout the week. All personnel of this supervisory staff are fully experienced in the subject matter of the Workshops—most are former Seminar participants—and are constantly on hand to administer the safest and most enjoyable program. Dormitory curfews of 11:30 p.m. are in effect. Student operation of automobiles is not permitted during the course of the Seminar. Transportation for all scheduled daytime and evening activities is by special staff-supervised chartered buses.

### Extra Expenses

All tuition, room and meal charges are included in the total seminar fee, with the exception of five inexpensive lunches in the Congressional cafeterias. Also included are all transportation costs within Washington for scheduled seminar activities. Incidental expenses, such as extra food snacks, cab fare to and from airports, personal shopping and the like, should be considered as separate and extra items. Regarding insurance, regular family insurance policies usually provide full accident and health coverage for students attending programs away from home, such as The Congressional Seminar.

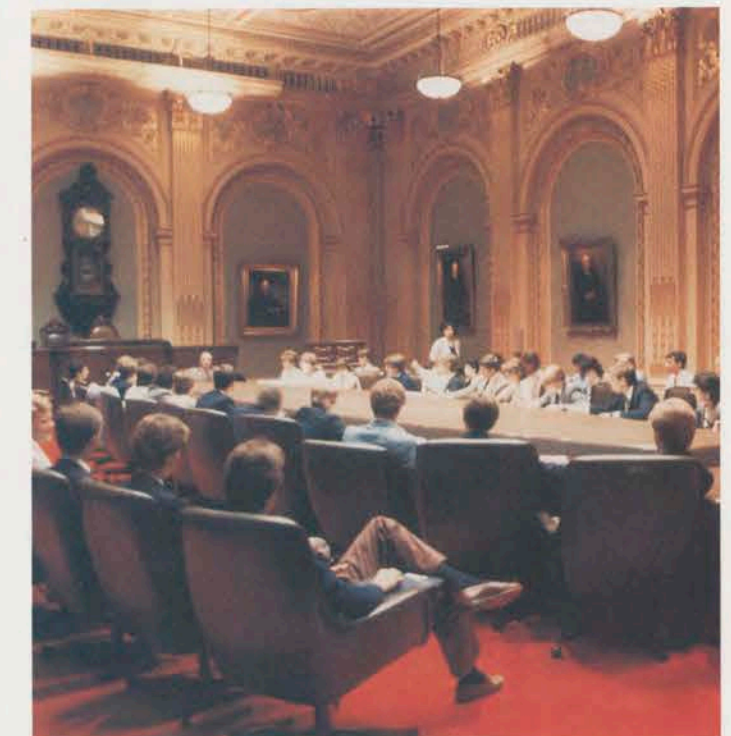
# The Wall Street Seminar

**T**he Wall Street Seminar provides an on-site introduction to the world of business and finance, offered by practitioners and academicians in the field. The give-and-take sessions with successful professionals—bankers, brokers, Fortune 500 executives, university and corporate economists, and business faculty and journalists—will offer students a feel for the range of job options available, some of the personal attributes needed for success in this volatile field, and a more comprehensive understanding as to how the financial and corporate sectors of our economy really work!

All Wall Street Seminar Sessions will be conducted on-site, in the center of the national and international business world—Wall Street and New York City. The 1990 seminars will be offered in cooperation with New York University's Stern School of Business, where early morning and evening meetings will be held each day, before leaving for lectures and discussion meetings at the centers of finance on Wall Street and surrounding areas.

## The Seminar Experience

■ **FINANCIAL MARKETS**—Central to any understanding of the American and world economy is a knowledge of the function and diversity of the stocks and commodities exchanges—the financial markets—and their essential role in corporate and the nation's growth.

■ **THE FEDERAL RESERVE & BANKING**—As "lender of last resort", The Federal Reserve provides a secure base for our banking system and thus in the final analysis, for the economy itself. In addition to a wide ranging discussion of such monetary tools as interest rates and the money supply, seminar participants will examine current banking practices brought on by the financial services revolution.

■ **INTERNATIONAL TRADE AND FINANCE**—A key theme of all 1990 sessions will be the emerging interdependence of global financial markets. There can be no real understanding of our national economy without an appreciation of the rapidly integrating world economy. The burgeoning challenge of global markets is given full consideration in every aspect of the seminar curriculum.

■ **BUSINESS ETHICS**—Beyond the demonstrated success of our enterprise system in producing an abundance of goods and services lies an array of ethical issues which must be addressed in order to ensure the continued viability of the system. The theoretical as well as practical aspects of ethics in business will be dealt with from legal, and regulatory case studies, making for spirited and lively discussion. Session analysis will include such topics as insider trading, stock fraud and price manipulation.

■ **ADVERTISING**—The importance of advertising and marketing as business tools will be examined and discussed from both the viewpoint of executives and consumers.

■ **CAREER PLANNING**—Throughout the week, seminar participants will be exposed to a variety of careers from discussion with leaders in banking, trade, marketing, and finance, thus providing valuable insight as to what the personal attributes, professional requisites, and rewards of differing personal career paths are from those in a position to know.

## The Week in New York

Each week, the academic and residential base of the Wall Street Seminar is the impressive Washington Square campus of New York University, situated about half-way between Wall Street and mid-town corporate headquarters. It is here that the seminar program begins on Sunday, at a campus lecture hall, with orientation and a briefing on the global economy and financial markets.

On subsequent mornings, after breakfast in the college dining facilities, students will either attend a series of spirited guest lectures by distinguished faculty members from New York University's Stern School of Business, or take chartered buses to the financial district. On-site visits occur at such places as the New York and American Stock Exchanges, the Commodity Exchange, corporate, brokerage, and legal firm offices, and many other professional and business sites where lively discussions and exchanges of views occur between invited speakers and seminar students.

Throughout the week's formal schedule, free time is made available for picture taking and enjoyment of some of the Big Apple's major attractions. Seminar counseling staff and administrative personnel accompany the students during all scheduled activities.

Following dinner each evening in the campus facilities, students assemble at 7:00 p.m. for a discussion lecture with a specially invited guest speaker, leaving ample time for questions and answers. Following these evening sessions, students break into teams to discuss case studies in such areas as marketing, mergers, ethics, and other contemporary business issues.

Friday afternoons are reserved each week for an interesting and enjoyable visit to the South Street Seaport complex, or to Rockefeller Center and mid-town Manhattan. There, a multitude of shops, historic exhibits, and restaurants abound. Later that afternoon, seminar students may join each other for a fine dinner in a nearby restaurant, and are then off to a Broadway musical, and as always accompanied by seminar staff. Saturday morning provides an optional visit to the Statue of Liberty followed by seminar departure.

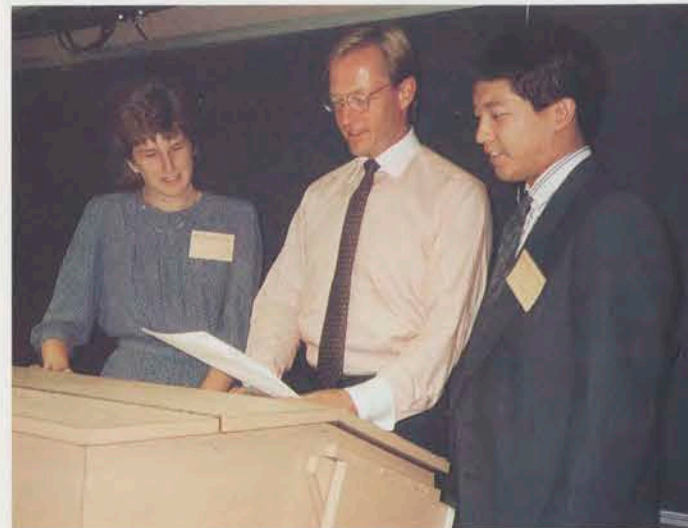

### College Admission

Past experience has shown that secondary student participation in the Wall Street Seminar is of decided interest to college admissions officers who are increasingly seeking students with high motivation, personal initiative, and interest in public issues and affairs. The Washington Workshops Foundation presents each student with a Completion Certificate and will further verify, upon request, the student's participation in the Seminar.

### Session Size

Seminar sessions have an average enrollment of 75 students. This enrollment philosophy of reasonably-sized seminar sessions embodies one of the hallmarks of all Washington Workshops Foundation programs, as it not only ensures maximum personal student participation in questioning speakers, but allows the students an opportunity to get to know each other and share among themselves differing personal perspectives, attitudes, and backgrounds.

### Student Housing and Supervision

Safety and care of the students will be of constant concern to the seminar administrators and staff, who are in a ratio of one to 20 students. Seminar residence will be in double occupancy, air conditioned rooms in the residence halls at New York University. The location is at the Washington Square campus in lower Manhattan, complete details of which are mailed with student acceptances. The Wall Street Seminar will be administered by a director and full-time staff of experienced proctors and counselors—all of whom will be college upperclassmen or university graduate students. The counseling staff will reside in the dormitories and will be with the students throughout the week. In addition, N.Y.U. maintains a full, uniformed staff of dormitory security personnel on duty 24-hours a day. Dormitory curfews of 11:30 p.m. each night are in effect. Student operation of automobiles is not permitted during the course of the seminar. Transportation for all scheduled daytime and evening activities is by special staff-supervised chartered buses.

### Student Fact Sheet

Along with program acceptance, each student will receive a Student Fact Sheet, fully describing preparation for their week in New York. The Fact Sheet includes data on airport and taxi information, mailing addresses, dormitory laundry facilities, what clothes to wear, etc. Also, full information will be provided as to the specific location of the dormitory check-in at N.Y.U. each Sunday.

### Extra Expenses

All tuition, room and meal charges are included in the total seminar fee, with the exception of five lunches and Sunday dinner. 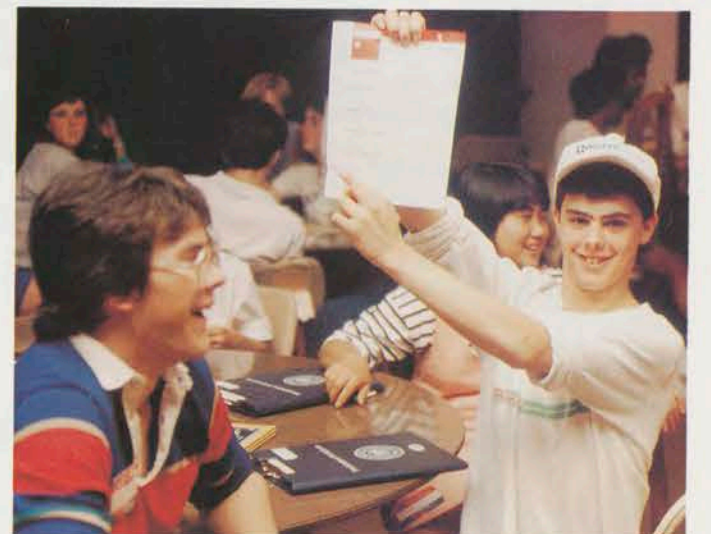



At the end of each year's series of seminars, all participants are invited to join the National Student Advisory Committee. Membership ensures mailings and announcements from the Workshops regarding new programs, reunions, and special WW affairs. Members of this committee are also invited to attend a late fall weekend meeting in the Washington, D.C. or New York area. This two-day meeting provides a splendid opportunity for extended discussions and planning for the following year's seminars.

### WW2 Internships

The Advanced Congressional Seminar—or WW2 as it has come to be called—is the annual Workshops program available to students who have first completed the regular Congressional Seminar. Offered in May, June, and July the Advanced Seminar comprises three weeks of an intern assignment in a Congressional office. These assignments are usually correlated to the student's own state and Congressional district. A short research paper on an aspect of the Legislative Process is required in order to receive the three college credits awarded by Marymount University. Using Marymount as our campus headquarters, the Advanced Seminar is the oldest extensive national high school internship program on Capitol Hill.

### Junior High-Middle School Seminar

Celebrating its 11th year, our Junior High-Middle School Washington Student Seminar will be offered to school groups. Open to a younger student level, these seminars offer a specially designed schedule and set of activities. Seminar dates for 1990 are January 28-February 3, February 25-March 3, March 3-10, April 8-14, May 6-12, May 13-19 and May 20-26.

### The Media Workshops

The Washington Workshops maintains a fraternal association with The Media Workshops Foundation in Los Angeles, California. This one-week program offers students an unprecedented behind-the-scenes look at the entertainment and media world. Students visit motion picture and television studios and newspaper facilities where they learn from leading media executives, producers, actors, directors, writers, and editors. Sessions include inside looks at Columbia Pictures, 20th Century Fox, Walt Disney Productions, CBS, Paramount Pictures and the *L.A. Times*. Other activities include watching production of *Family Ties*, *Cheers*, and *Newhart*, and learning about the media through meetings with their casts and crews.

Students stay at the scenic 410-acre UCLA campus. The 1990 program sessions extend from July through August. Additional information is available upon request by calling toll free:

## Multiple Program Enrollment

Many students chose to attend more than one seminar each year. If so, only a single \$100 application fee is required for multiple program application. If multiple seminar enrollment is desired and it includes back-to-back dates in New York and Washington, free counselor-supervised transportation on AMTRAK is provided, as well as the extra Saturday night campus room reservation between seminars.
