Dear Bob:

I would like to ask that you accept, if at all possible, the enclosed invitation of Andrew Doyle, Executive Director of the National Paint and Coatings Association (NPCA), who would like you to address the NPCA Executive Committee on Thursday, July 23rd.

As you may know, NPCA and Andy have been very supportive of many Bush Administration and GOP initiatives on which your leadership has been so immensely effective. NPCA was one of a small group of business organizations that supported the President's Clean Air Act. They are now a member of the Environmental Action Group, a trade association "sounding board" that was created to show support for Republican environmental initiatives.

NPCA strongly supports the Administration's program for civil justice reform, and has begun already a lobbying effort on this issue. NPCA also worked actively on such initiatives as: authority for the President to use force in the Persian Gulf; the budget battle against the Democratic plan; extension of fast track negotiating authority; and the President's economic recovery plan.

Your breakfast with NPCA will be at the lovely NPCA headquarters, the Alexander Graham Bell Mansion, located on Rhode Island Avenue, N.W. The historical and stately Mansion was owned by Alexander Graham Bell, later became the Russian Embassy under the Czar, and after 1933 was used as the Democratic National Committee headquarters under President Roosevelt.

NPCA is a first-rate association. I hope you will be able to schedule this event. I know that Andy and the NPCA Executive Committee would be honored to have you meet with them.



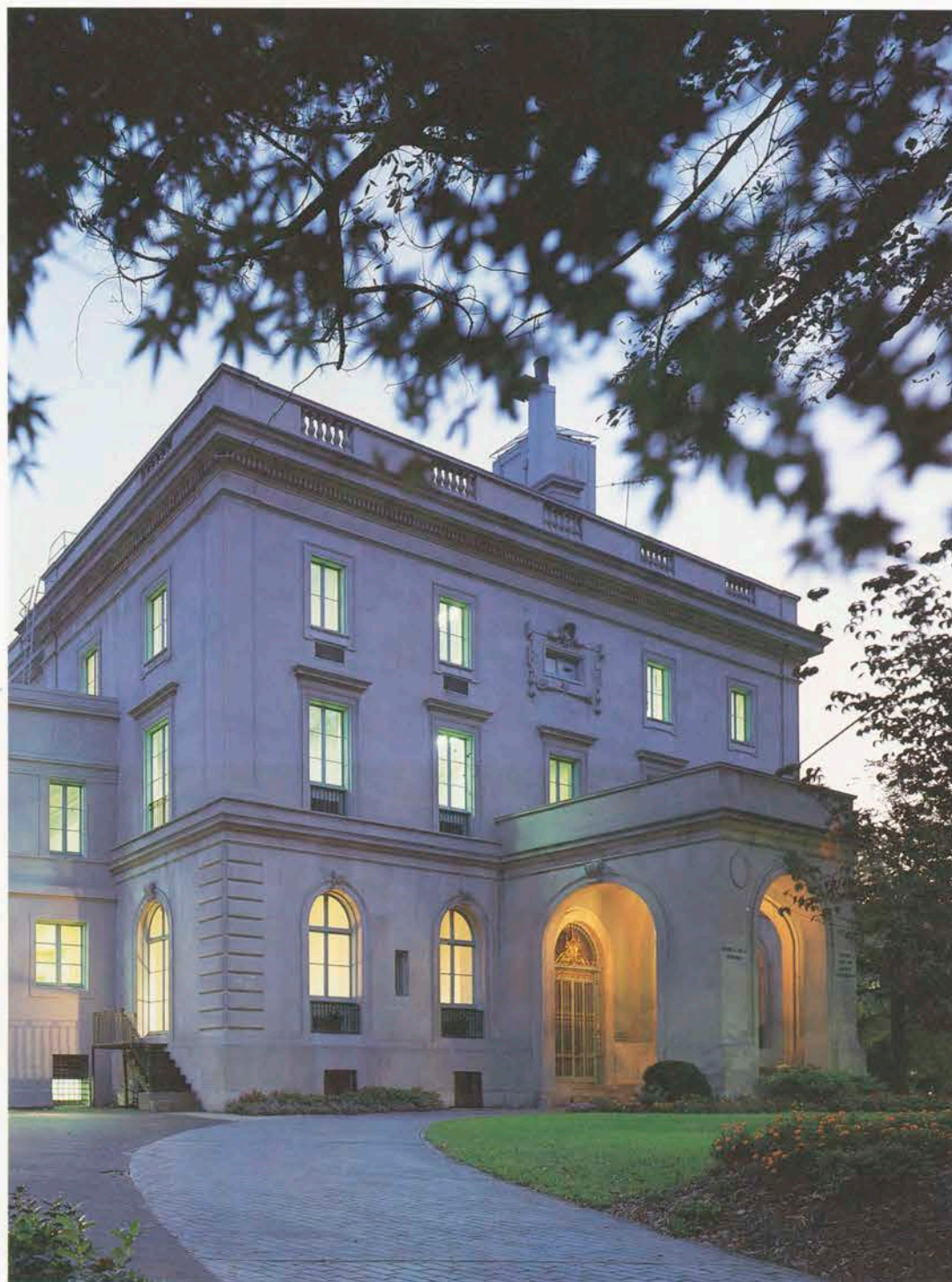
