THERE ARE A LOT OF ATTORNEYS HERE WHO ARE TRUSTING EACH OTHER TO HELP LEAD THE FIGHT AGAINST THE CLINTON AGENDA. ***I'VE TRAVELLED TO QUITE A** FEW STATES RECENTLY, AND EVERYWHERE I GO, I SENSE THE SAME THING--REPUBLICANS ARE **REVITALIZED AND RE-**ENERGIZED--THEY'RE EXCITED

ABOUT THE FUTURE, AND THEY'RE EXCITED ABOUT HOW **REPUBLICANS HAVE UNITED AROUND THE MESSAGE OF "CUT** SPENDING FIRST." ***THE MESSAGE THAT THE** VOTERS SENT LAST NOVEMBER WAS THAT IT WAS TIME FOR **GOVERNMENT TO LIVE WITHIN** ITS MEANS...THAT IT WAS TIME TO GET SERIOUS ABOUT THE
