



1992 RECIPIENTS

HONORABLE LLOYD BENTSEN

United States Senate, (D) Texas

Since 1971, Lloyd Bentsen has served as a member of the United States Senate representing the State of Texas. During this time, the Senator served as Chairman of the Senate Finance Committee and as Vice Chairman of the Joint Committee on Taxation. He is a member of the Senate Commerce, Science and Transportation Committee as well as the Joint Economic Committee. In 1988, Senator Bentsen was the Democratic Party nominee for Vice President of the United States.

Senator Bentsen received a law degree from the University of Texas School of Law in 1942. Upon Graduation, he enlisted in the Army Air Forces, and earned the rank of Major as a B-24 pilot and Squadron Commander. He was promoted to Colonel in the Air Force Reserve before completing his military service.

After World War II, Senator Bentsen served as County Judge of Hildago County, and then as a Member of Congress. In 1954, after three significant terms in the U.S. House of Representatives, he entered upon a much respected business career in Houston, before beginning his services in the U. S. Senate.

HONORABLE D. ALLAN BROMLEY

*Assistant to the President for Science and Technology and
Director of the Office of Science and Technology Policy*

Allan Bromley serves as the President's Chief Science and Technology Policy Advisor. He is presently on leave from Yale University, where he is founder and Director of the A.W. Wright Nuclear Structural Laboratory and Henry Ford II Professor of Physics.

Dr. Bromley received his B.S. with highest honors and M.S. in 1948 and 1950, respectively, in the Faculty of Engineering at Queens University, Ontario, Canada. He received his Ph.D. from the University of Rochester in 1952. He has been awarded twenty honorary degrees from universities around the world.

For more than two decades, Dr. Bromley has been a leader in the field of science policy. He served as chairman of the National Academy's Physics Survey in the early 1970's and as president of both the American Association for the Advancement of Science and the International Union of Pure and Applied Physics.

Dr. Bromley served as a member of the White House Science Council throughout the Reagan Administration and as a member of the National Science Board.

HONORABLE LOUIS W. SULLIVAN, M.D.

Secretary of Health and Human Services

Louis Sullivan was sworn in as Secretary of Health and Human Services in March of 1989. As Department head, Dr. Sullivan oversees the federal agency responsible for the major health, welfare, food and drug safety, medical research and income security programs serving the American people.

Dr. Sullivan received his B.S. from Morehouse College in 1954. He went on to earn his medical degree from Boston University in 1958. His internship and medical residency were at New York-Cornell Medical Center.

In 1966, he became co-director of hematology at Boston University Medical Center, and founded the Boston University Hematology Service at Boston City Hospital. Dr. Sullivan was also project director of the Boston Sickle Cell Center and Director of Hematology at Boston City Hospital. In 1975, Dr. Sullivan returned to Morehouse College as professor of biology and medicine, subsequently founding Morehouse Medical School.

Dr. Sullivan was the founding president of the Association of Minority Health Professions Schools, and was vice chairman of the Commission on Health and Human Services of the Southern Regional Education Board. Dr. Sullivan has received numerous awards for his outstanding service to the black community, as well as the community at-large.

1993 RECIPIENTS

The Honorable Ronald H. Brown *Secretary of Commerce*

Ron Brown was sworn in as Secretary of Commerce as the number one business and trade official of our country. Prior to his appointment, Mr. Brown was elected Chairman of the Democratic National Committee in 1988 and presented Bill Clinton with the most successful Democratic National Convention in a generation. Mr. Brown, who began his service to the Democratic Party in 1971 as a Mt. Vernon, New York District Leader, served as the DNC's Chief Counsel and Deputy Chair, and Chaired the Task Force on Voter Rights and Voter Participation.

Following a four year Army tour in Germany and Korea, Brown began a twelve year career with the National Urban League. In 1981 Brown became a partner in the Washington, D.C. law firm Patton, Boggs and Blow. He is a member of the New York Bar, the District of Columbia Bar and the U.S. Supreme Court Bar.

The Honorable Robert J. Dole *United States Senate, (R) Kansas*

Robert Dole has represented the state of Kansas in the Congress for more than 30 years. He has served as Senate Majority Leader and ten years as Minority Leader, which is his present position. Senator Dole is a respected policy leader with superb legislative skill. During his political career he has been Chairman of the Senate Finance Committee, a two-time candidate for President, his party's nominee for Vice President, a four-term member of the House of Representatives, the Chairman of the Republican Party, a state legislator and a county attorney. He is a member of the Senate Children's Caucus, Senate Caucus on North American Trade, Senate Caucus on the Family, Senate Human Rights Caucus and others.

During the second World War, Dole was a platoon leader in the Tenth Mountain Division in Italy where he was gravely wounded on the battlefield. His decorations include two Purple Hearts and a Bronze Star with an Oakleaf Cluster. Senator Dole created the Dole Foundation to support hiring the disabled.

The Honorable John D. Rockefeller IV *United States Senate, (D) West Virginia*

Jay Rockefeller is widely respected for service to this Nation as a policy leader, as an advocate for children and of health care reform. He has been serving the people of West Virginia for more than 25 years and has been a member of the U.S. Senate since 1984. During his time in the Senate, Rockefeller has served on the Finance, Commerce, and Science and Transportation Committees. In addition, Senator Rockefeller is Chairman of the Senate Steel Caucus and the National Commission on Children. He also serves on the Senate Steering Committee on Democratic Policy and is a member of the Rural Health Caucus, Drug Enforcement Caucus, Coal Caucus and others.

Prior to joining the Senate, Rockefeller was elected to a two-year term in the West Virginia House of Delegates. He then served four years as Secretary of State, three years as President of West Virginia Wesleyan College and eight years as Governor.
