KNOW THERE'S SOMETHING TO
FEAR.**

IT IS FEAR THAT CAUSES US

**TO LOCK OUR DOORS AT ALL
TIMES. IT IS FEAR THAT MAKES
PARENTS WORRY WHEN THEY
SEND THEIR CHILDREN OFF TO
SCHOOL. IT IS FEAR THAT
MAKES PEOPLE LIKE YOURSELF
COME TO A "STREET SURVIVAL"
SEMINAR.**

**IT IS A FEAR THAT EACH
AND EVERY DAY BECOMES A**

**REALITY FOR MANY AMERICANS,
AND THAT THIS PAST FEBRUARY
BECAME A REALITY FOR
TIMOTHY RILEY.**

**A 33-YEAR-OLD HUSBAND
AND FATHER OF TWO YOUNG
CHILDREN, TIMOTHY RILEY WAS
KIDNAPPED OUTSIDE HIS HOME
IN TOPEKA, AND FORCED AT
GUNPOINT INTO THE TRUNK OF**

HIS OWN CAR.

**SHORTLY AFTER THE
KIDNAPPING, MR. RILEY WAS
SHOT TO DEATH, HIS LIFELESS
BODY DUMPED ON THE SIDE OF
A HIGHWAY, JUST SOUTH OF
TOPEKA. TWO TEEN-AGERS
WERE ARRESTED IN
CONNECTION WITH THE
CARJACKING AND MURDER.**

**THE MURDER OF TIMOTHY
RILEY, LIKE ALL MURDERS, IS A
TRAGEDY. BUT ANOTHER SAD
TRAGEDY IS THE FACT THAT THE
STORY OF WHAT BEFELL
TIMOTHY RILEY PROBABLY DOES
NOT SHOCK ANYONE HERE
TODAY...NOR DOES IT SHOCK
MOST AMERICANS.**

AMERICANS HAVE BECOME

**USED TO CRIME. INSTEAD OF
OUTRAGE, FAR TOO MANY
AMERICANS NOW REACT WITH A
SHRUG...WITH AN ATTITUDE
THAT RANDOM MURDER IS
NORMAL OR ROUTINE.**

**BUT, NO MATTER HOW YOU
LOOK AT IT, THERE'S NOTHING
NORMAL ABOUT THE FACT THAT,
SOMEWHERE IN THIS COUNTRY,**

**AN AMERICAN IS MURDERED
EVERY 21 MINUTES, RAPED EVERY
5 MINUTES, ROBBED EVERY 46
SECONDS, AND ASSAULTED
EVERY 29 SECONDS.**

**TO HELP FIGHT BACK
AGAINST THIS EPIDEMIC OF
VIOLENCE, I RECENTLY
INTRODUCED A BILL CALLED
"THE NEIGHBORHOOD SECURITY**

**ACT." WE INTRODUCED THIS
BILL BARELY THREE WEEKS
AGO...SO THIS IS ONE OF MY
FIRST OPPORTUNITIES TO
DISCUSS IT WITH PEOPLE IN THE
LAW ENFORCEMENT
COMMUNITY.**

**I HAD AN OPPORTUNITY TO
GET COMMENTS FROM THE
FRATERNAL ORDER OF POLICE,**

**THE INTERNATIONAL
ASSOCIATION OF POLICE
CHIEFS, THE NATIONAL
SHERIFFS ASSOCIATION, THE
NATIONAL TROOPERS
COALITION, AND FROM
REPRESENTATIVES OF OTHER
LAW ENFORCEMENT
ORGANIZATIONS. AND I WANT
TO TAKE THIS OPPORTUNITY TO**

GET YOUR INPUT AS WELL.

LET ME ADD THAT

REPUBLICANS INTEND TO WORK

TOGETHER WITH PRESIDENT

CLINTON, WHO RECENTLY

UNVEILED HIS OWN ANTI-CRIME

PROPOSAL. AND LET'S FACE IT:

CRIME SHOULD NOT BE A

PARTISAN ISSUE. A THIEF

DOESN'T ASK YOU IF YOU'RE A

**DEMOCRAT OR A REPUBLICAN
BEFORE HE STICKS A GUN IN
YOUR RIBS.**

**THE NEIGHBORHOOD
SECURITY ACT RECOGNIZES
THAT AMERICA DESPERATELY
NEEDS A TOURNIQUET, A
SHORT-TERM PLAN TO STOP THE
BLEEDING AND RESTORE ORDER
ON OUR STREETS.**

**THE NEIGHBORHOOD
SECURITY ACT SEEKS TO
ACCOMPLISH THIS SHORT-TERM
GOAL IN THE FOLLOWING WAYS:**

**FIRST, IT PROVIDES \$2
BILLION IN FUNDING FOR THE
HIRING OF THOUSANDS OF
ADDITIONAL POLICE OFFICERS
AND FOR THE PURCHASE OF
MODERN POLICE EQUIPMENT.**

**THROUGHOUT THE 1950s,
FOR EVERY VIOLENT FELONY
THAT WAS REPORTED, THERE
WERE MORE THAN 3 POLICE
OFFICERS. TODAY, FOR EVERY
POLICE OFFICER, THERE ARE
MORE THAN 3 VIOLENT CRIMES
REPORTED. IF WE ARE TO WIN
BACK OUR SECURITY, WE MUST
REVERSE THIS DANGEROUS**

TREND.

**AND WHEN PEOPLE LIKE
YOURSELF ARE OUT IN THE
FIELD OR IN THE STATION, YOU
ARE ENTITLED TO THE MOST
MODERN EQUIPMENT
AVAILABLE.**

**SECOND, THE
NEIGHBORHOOD SECURITY ACT
PROVIDES \$3 BILLION IN**

**ADDITIONAL FUNDING FOR NEW
PRISON CONSTRUCTION.**

**WITH THE DECK STACKED
AGAINST YOU BOTH ON THE
STREET AND IN THE
COURTROOM, BEING A POLICE
OFFICER IS, NO DOUBT, ONE OF
THE TOUGHEST JOBS IN
AMERICA. AND I CAN ONLY
IMAGINE HOW DISCOURAGING IT**

**MUST BE FOR YOU TO ARREST
SOMEONE AND GO THROUGH
THE PROCESS OF A LENGTHY
TRIAL, ONLY TO SEE THE
CRIMINAL SOON OUT ON THE
STREETS BECAUSE OF A
SHORTAGE IN PRISON SPACE.**

**THAT'S NOT FAIR TO
YOU...AND IT'S NOT FAIR TO THE
AMERICAN PEOPLE.**

**WE CAN'T EXPECT THE
POLICE TO PUT THEIR LIVES ON
THE LINE IN MAKING ARRESTS,
IF WE'RE NOT WILLING TO
ENSURE THAT THOSE WHO ARE
ARRESTED AND CONVICTED
SERVE SOME REAL TIME.**

**AND ONE OF THE SIMPLE
TRUTHS OF THE CRIMINAL
JUSTICE SYSTEM IS THAT**

**INCARCERATION WORKS. OUR
COMMUNITIES ARE SAFER--AND
OUR LAW ENFORCEMENT
OFFICERS ARE SAFER--WHEN
THE CRIMINALS ARE BEHIND
BARS.**

**THAT'S A MESSAGE THE
FEDERAL GOVERNMENT BEGAN
TO UNDERSTAND IN THE 1980'S,
WHEN WE INSTITUTED PRE-**

**TRIAL DETENTION, AND
ELIMINATED PAROLE AND
PROBATION. UNDER TODAY'S
FEDERAL SYSTEM, A VIOLENT
FELON, ONCE APPREHENDED,
CAN REMAIN BEHIND BARS
FROM THE MOMENT OF ARREST
UNTIL HIS FULL SENTENCE HAS
BEEN SERVED.**

UNFORTUNATELY--AND

**TRAGICALLY--THIS IS DEFINITELY
NOT THE CASE IN MANY OF OUR
STATES, AS YOU WELL KNOW.**

**TO KEEP VIOLENT
CRIMINALS BEHIND BARS, MY
LEGISLATION WOULD CREATE
TEN NEW REGIONAL PRISONS.
AND THE STATES WOULD BE
ALLOWED TO SEND THEIR STATE
PRISONERS TO THESE PRISONS-**

-BUT ONLY IF THE STATES
REFORM THEIR OWN CRIMINAL
JUSTICE SYSTEMS BY ADOPTING
A "TRUTH IN SENTENCING" LAW,
WHEREBY CONVICTED
CRIMINALS MUST SERVE AT
LEAST 85% OF THEIR SENTENCE.

TO BE ABLE TO USE THESE
NEW REGIONAL PRISONS,
STATES WILL ALSO HAVE TO

**ADOPT MANDATORY MINIMUM
SENTENCES FOR GUN
OFFENSES AND VIOLENT CRIMES
AND PROVIDE FOR THE PRE-
TRIAL DETENTION OF THE MOST
VIOLENT OFFENDERS.**

**BY INCREASING PRISON
SPACE, AND BY PROVIDING
INCENTIVES FOR STATES TO PUT
THAT SPACE TO USE, THE**

**AMERICAN CRIMINAL JUSTICE
SYSTEM CAN RETURN TO ITS
BASIC OBJECTIVE OF
PROTECTING THE INNOCENT
AND PUNISHING THE GUILTY.**

**AND THERE CAN BE NO
DOUBT THAT AN INCREASING
NUMBER OF THE GUILTY WHO
NEED TO BE PUNISHED, AND
THE VICTIMS WHO NEED TO BE**

**PROTECTED, ARE YOUNG
AMERICANS.**

**INDEED, ATTORNEY
GENERAL JANET RENO SAYS
YOUTH VIOLENCE IS "THE
GREATEST SINGLE CRIME
PROBLEM IN AMERICA TODAY."
FROM 1987 TO 1991, THE
NUMBER OF TEENAGERS
ARRESTED FOR MURDER IN**

**AMERICA INCREASED BY AN
ASTOUNDING 85%. AND
TEENAGERS AREN'T JUST
CRIMINALS, THEY'RE VICTIMS,
AS WELL. ACCORDING TO THE
FBI, MORE THAN 2,200 MURDER
VICTIMS IN 1991 WERE UNDER
18--AN AVERAGE OF MORE THAN
SIX YOUNG PEOPLE KILLED PER
DAY. THE JUSTICE DEPARTMENT**

**ESTIMATES THAT EACH YEAR,
NEARLY A MILLION YOUNG
PEOPLE BETWEEN 12 AND 19
ARE RAPED, ROBBED OR
ASSAULTED, OFTEN BY THEIR
PEERS, AND OFTEN WHILE AT
SCHOOL.**

**TO HELP COMBAT THIS
EPIDEMIC, THE NEIGHBORHOOD
SECURITY ACT ESTABLISHES**

**FEDERAL SAFE SCHOOL
DISTRICTS. IN A SAFE SCHOOL
DISTRICT, ANY JUVENILE 16
YEARS OF AGE OR OLDER WHO
USES OR CARRIES A GUN IN OR
NEAR A SCHOOL WOULD BE
PROSECUTED AS AN ADULT. NO
EXCEPTIONS. IF CONVICTED OF
A GUN-RELATED CRIME, TOUGH,
NEW PENALTIES WOULD APPLY.**

AGAIN, NO EXCEPTIONS.

**SAFE SCHOOL DISTRICTS
WOULD BE ELIGIBLE FOR \$500
MILLION IN FEDERAL GRANTS TO
PURCHASE METAL DETECTORS,
CLOSED-CIRCUIT CAMERAS,
GUN HOTLINES...AND TO BEEF-
UP POLICE PATROLS IN AND
AROUND SCHOOLS.**

NO DOUBT ABOUT IT, IT'S A

**SAD DAY WHEN METAL
DETECTORS AND CLOSED-
CIRCUIT CAMERAS TAKE THE
PLACE OF BOOKS AND WRITING
PADS AS THE MOST IMPORTANT
PURCHASES A SCHOOL
ADMINISTRATOR CAN MAKE.
BUT DO WE HAVE ANY CHOICE
WHEN THE SECURITY OF OUR
CHILDREN ARE AT STAKE?**

**FOURTH, THE
NEIGHBORHOOD SECURITY ACT
REFORMS OUR CRIMINAL LAWS
TO STOP THE SEEMINGLY
ENDLESS APPEALS THAT CLOG
UP OUR COURT SYSTEM AND
DENY JUSTICE TO THE VICTIMS
OF CRIME. IN WASHINGTON, WE
CALL THIS HABEAS CORPUS
REFORM, A VERY TECHNICAL**

**SUBJECT, BUT ONE THAT IS
VITAL TO THE FAIR AND SWIFT
ADMINISTRATION OF JUSTICE.**

**AND WE'VE PROPOSED AN
ENFORCEABLE FEDERAL DEATH
PENALTY FOR NEARLY 50
OFFENSES, INCLUDING THE
MURDER OF LOCAL LAW
ENFORCEMENT OFFICIALS WHO
ARE ASSISTING A FEDERAL**

INVESTIGATION.

FIFTH, THE NEIGHBORHOOD SECURITY ACT GOES AFTER CRIMINAL YOUTH GANGS, A BIG PROBLEM IN WICHITA, BY CREATING A CORPS OF SPECIAL U.S. ATTORNEYS TO PROSECUTE GANG ACTIVITY.

AND FINALLY, UNLIKE THE OTHER CRIME BILLS CONGRESS

**HAS DEBATED IN THE PAST, THE
NEIGHBORHOOD SECURITY ACT
RECOGNIZES THAT SECURITY
INDEED CARRIES A PRICE TAG, A
PRICE TAG WE SIMPLY CAN'T
CHARGE TO THE DEFICIT.**

**OUR LEGISLATION PAYS
FOR ITSELF BY REDUCING
OVERHEAD EXPENSES ACROSS-
THE-BOARD IN THE FEDERAL**

**GOVERNMENT, AND BY
MODESTLY CUTTING THE
OVERHEAD PAYMENT RATE FOR
FEDERALLY-FUNDED UNIVERSITY
RESEARCH.**

**IF THE NEIGHBORHOOD
SECURITY ACT EVER PASSED
CONGRESS AND WAS SIGNED
INTO LAW, I TRULY BELIEVE IT
WOULD TAKE A BITE OUT OF**

**CRIME...IN THE SHORT-TERM,
THAT IS.**

**FOR, WHEN ALL IS SAID
AND DONE, THE BEST
DETERRENT TO CRIME IS NOT A
PRISON CELL, BUT SOMETHING
CALLED CONSCIENCE--THAT
LITTLE INNER VOICE THAT SAYS
"NO, YOU BETTER NOT TO DO
THAT--IT'S WRONG."**

**DOWN THROUGH THE AGES,
PEOPLE HAVE DEVELOPED
CONSCIENCE THROUGH THEIR
INTERACTIONS WITH SOCIAL
INSTITUTIONS LIKE THE
SCHOOLS AND THE CHURCH,
AND MOST IMPORTANTLY,
THROUGH FAMILIES AND THE
SET OF VALUES THAT FAMILIES
TRANSMIT TO THEIR CHILDREN.**

**UNFORTUNATELY, THE
AMERICAN FAMILY TODAY IS IN
TATTERS. SINCE 1960,
ILLEGITIMATE BIRTHS HAVE
INCREASED BY MORE THAN
400%. IN 1990, A STAGGERING
TWO-THIRDS OF ALL BLACK
CHILDREN, AND 25% OF ALL
WHITE CHILDREN, ENTERED THE
WORLD WITHOUT THE BENEFIT**

**OF A RESIDENT FATHER AND
MOTHER. THESE ILLEGITIMACY
RATES CONTINUE TO RISE.**

**NOT ONLY IS THERE A
CLEAR LINK BETWEEN FAMILY
STRUCTURE AND POVERTY, AS
SENATOR MOYNIHAN POINTED
OUT SOME 25 YEARS AGO, BUT
THERE IS ALSO A LINK BETWEEN
FAMILY STRUCTURE AND CRIME.**

**IT'S NO WONDER THAT 70% OF
THE JUVENILES IN STATE
REFORMATORIES TODAY COME
FROM HOMES WITHOUT
FATHERS.**

**OBVIOUSLY, GOVERNMENT
IS NOT THE NATION'S NANNY. IT
CANNOT, AND SHOULD NOT, BE
RESPONSIBLE FOR RAISING OUR
NATION'S CHILDREN. NO**

**GOVERNMENT AGENCY CAN
IMPLANT PERSONAL MORALITY,
NOR CAN A CONGRESSIONAL
COMMITTEE BUILD CHARACTER.**

**BUT IF WE'RE REALLY
SERIOUS ABOUT ADDRESSING
THE "ROOT CAUSES" OF CRIME,
WE NEED TO GO TO THE
DEEPEST ROOT OF ALL--THE
FAMILY.**

**IN THE FINAL ANALYSIS,
THE REAL HEROES IN THE WAR
AGAINST CRIME--AND IT IS A
WAR--WILL NOT BE THE
MEMBERS OF CONGRESS, BUT
THE PEOPLE THEMSELVES.
PEOPLE LIKE YOU. PEOPLE
WHO WON'T GIVE UP, WHO
HAVEN'T LOST THEIR SENSE OF
OUTRAGE AT THE HORRIBLE**

**ACTS OF VIOLENCE THAT ARE
COMMITTED EACH DAY ON THE
STREETS OF OUR COUNTRY.**

investigation, arrangements were made to utilize a delivery truck and a uniform, as an undercover detective was going to make the controlled delivery.

On April 13, 1989, at about 2:15 p.m., the delivery was made. It was established that Mr. Roesch would be willing to cooperate with the investigation. The person who had sent the "valium" to Mr. Roesch was a Mark Gould, whom Roesch and his wife had met in Florida.

DEA in Florida and the Broward County Sheriff's Office were contacted and apprised of the controlled delivery and possible continuing investigation. Barbara Bookholdt of the DEA Compliance Unit in Miami was notified of the results of the investigation and anticipated continuing investigation.

With the cooperation of Mr. Roesch, numerous recorded phone calls were placed to Mark Gould and two more packages of "valiums" were sent to Mr. Roesch via air carriers. The total amount received was in excess of 50,000 valium tablets.

Detectives Morrissey and Isnardi then flew to Miami, Florida, where they were assisted by Diversion Investigator Barbara Bookholdt and Special Agent Terry Long of DEA, Miami. Detectives Morrissey and Isnardi confronted Mark Gould with the case against him and he agreed to cooperate. Agent Long set up a buy-bust and arrested Terry Loy for illegal distribution of a controlled substance. Agent Long seized another 25,000 counterfeit "valium" tablets. Defendant Loy later surrendered an additional 16,000 tablets.

As a result of the cooperation of the agencies involved and innovative investigation tactics, three persons were arrested and convicted and over 96,000 counterfeit "valium" tablets intended for the American public were seized. Information was developed regarding the illegal manufacture of the tablets which is the subject of a continuing investigation.

The above named officers of the New Rochelle New York Police Department are presented the Association's **SPECIAL AWARD OF HONOR** for their outstanding drug investigations.

In November 1988, the Special Investigations Unit of the New Rochelle Police Department began an undercover narcotics operation that would last for approximately seven months. This operation was dubbed "OPERATION CRACK-DOWN" and was designed to attack New Rochelle's increasing crack cocaine problem head on.

In order to assure its success and to protect the integrity of this operation, reporting Sergeant was aware that heavy pressure against both users and the sellers of crack cocaine would have to be maintained throughout this investigation in a way that would not interfere with the operation. To accomplish this, reporting Sergeant assigned Detectives Dooley, Marshall, Correia and Lemma to this investigation. In addition, various other operations such as buy bust, surveillance bust and search warrants were conducted, in order to satisfy the need of maintaining the pressure on the streets and to aid in procuring identification of the various sellers, many of whom were from outside of New Rochelle, but were operating in this city. These other operations were carefully planned, coordinated and executed so as not to jeopardize the primary operation.

Detectives Dooley, Marshall, Correia and Lemma were often required to

change tours and work additional hours without compensation in order to satisfy the needs of this investigation. Despite this added burden the aforementioned detectives did conduct an exceptional investigation that resulted in the indictment of seventy-five drug dealers for multiple sales of crack cocaine, and felony warrants for forty-nine other dealers of crack cocaine. In addition to the aforementioned indictments and warrants, Detectives Dooley, Marshall, Correia and Lemma did maintain pressure on the streets, averaging approximately thirty arrests per month throughout this investigation.

On 15 June 1989, members of the Special Investigations Unit, with the assistance of the General Investigations Unit, Property Theft Unit and the Youth Division of the City of New Rochelle Police Department, and the Westchester County Drug Enforcement Task Force, conducted a pre-dawn sweep that resulted in the arrest of eighty percent of the drug dealers sought in "Operation Crack-Down 89."

In conclusion, reporting Sergeant recommends that Detectives Dooley, Marshall, Correia and Lemma be given a special award of honor for having made an outstanding contribution in the area of drug enforcement, i.e., the arrest and conviction of over one hundred crack cocaine dealers in "Operation Crack-Down 89," the results of which are still being experienced in the reduction of related crimes. It should be noted that not only was this the largest undercover narcotics

Remember the controversy surrounding Ice-T and his album "Cop Killer," which Time-Warner produced? As Brent Staples points out, rap music, with its glorification of violence, can be very destructive to young people.

The Politics of Gangster Rap

The most dangerous myth facing African-Americans today is that middle-class life is counterfeit and that only poverty and suffering, and the rage that attends them, are real.

Anyone who doubts the power of this myth need only think back to the Clarence Thomas confirmation hearings, and how Judge Thomas's status as "a sharecropper's grandson" was put forth as a qualification for the Supreme Court. The poverty fetish is also dangerous; anyone who doubts this might recall Edmund Perry, the black Exeter graduate who was shot to death by an undercover cop in Morningside Heights. At Exeter, Edmund had played the swaggering tough without risk. At home, in the streets of New York, the role reared up and killed him.

Tom Wolfe's essay "Radical Chic," published in 1970, is still the best window into the notion that a magical nobility is somehow conferred on the dispossessed. The essay lampoons the party thrown by the conductor Leonard Bernstein for a group of Black Panthers at which the Panthers were fawned over by New York's elite.

It was there, Mr. Wolfe wrote, that "a Park Avenue matron first articulated the great recurrent emotion of Radical Chic: 'These are no civil rights *Negroes* wearing gray suits three sizes too big — these are *real men*.'" The central tenet of radical chic is that urban primitivism is romantic and that middle-classness is passé.

A generation has passed since Park Avenue swooned for the Panthers. The black middle class is larger than ever, but its influence is much diminished in the inner city. The ghetto, once a palatable mix of the middle class, the mildly poor and the very poor, is now made up of the very poor alone. Adolescent murder and pregnancy are endemic; more black men go to jail than to college.

And then there's gangster rap.

For those who haven't caught up, gangster rap is that wildly successful music in which all women are "bitches" and "whores" and young men kill each other for sport. It's hard-core, and bristles with guns. Hear a band called Onyx, recently number one on the charts, urging its

listeners to "Throw ya gunz in the air/ And pop-pop like ya just don't care." Hear the rapper called Dr. Dre: "Rat, tat, tat, tat/ Never hesitate to put a nigger on his back."

Hear The Beatnuts, in an ode to the machine pistol: "It ain't nothing you should laugh to/ I'll shoot your moms if I have to." These lyrics go out to an audience of young black men who are being murdered at five times the national average.

The rappers claim variously that they are "telling it like it is," or "reporting what we see in the streets," or "creating characters" that listeners misinterpret. The most effective rejoinder comes from Mike Davis's "City of Quartz," a history of Los Angeles, where gangster rap was born. "In supposedly stripping bare the reality of the streets, 'telling it like it is,'" Mr. Davis writes, "they also offer an uncritical mirror to fantasy power trips of violence, sexism and greed."

Rappers, take note: The key phrase is "uncritical mirror." The music "plays" at rape and murder in a way that celebrates them.

The final irony is that some gangster rappers are middle-class guys posing as inner-city killers. A rapper from Onyx recently took offense when accused of middle-class origins: "That's bull, I'm a real [expletive deleted]." Onyx's Suave told Frank Owen of New York Newsday: "I've been seeing people get shot all of my life."

Here, by way of Suave, is the problem simply put: In the streets, middle-class normalcy for blacks is portrayed as an inferior state of being. The news and entertainment industries are often in complicity with this. That's bad news because cultural ideology is powerful, especially in the lives of the young. It determines how we see them, how they see themselves and, to a large extent, what they aspire to become.

When middle-class blacks fabricate violent urban pasts, they pay homage to murder. When record company executives pose for pictures with gun-toting rappers, and when they push that murderous music, they trade in blood.

THE MESSAGE OF 'I HAVE A DREAM'

I have a dream that my four little children one day will live in a nation where they will not be judged by the color of their skin, but by the content of their character."

It was 30 years ago tomorrow that Martin Luther King Jr. uttered these famous words from the shadow of the Lincoln Memorial. The progress that much of the black population has made since that late summer day in 1963, when a quarter-million strong gathered for the now-fabled March on Washington, truly is an American success story.

Surely, the multitude that descended upon the nation's capital to hear King and other civil rights leaders could not have imagined that, in the ensuing three decades, the black middle class would nearly quadruple in size.

But it has. In 1993, nearly half of all black families will bring home more than \$25,000. Of these upwardly mobile black families, one in three will earn more than \$50,000.

The exponential growth of the black middle class over the last 30 years coincides with black gains in higher education. At the time of the March on Washington, roughly a quarter-million black youngsters were enrolled in the nation's colleges and universities. In 1993, there are more than four times as many black collegians.

One of the more memorable passages in King's "I Have a Dream" speech concerned black political power. "We cannot be

satisfied," the Baptist preacher intoned, "as long as the Negro in Mississippi cannot vote and the Negro in New York believes he has nothing for which to vote."

At the time when King spoke those words, there were fewer than 300 black elected officials throughout the country. In 1993, there are more than 7,000 black office holders, including four U.S. congressmen from New York and even one from Mississippi.

Yet, despite black gains in family income, education, political clout and other important measures of progress, many if not most blacks somehow believe that, 30 years after the March on Washington, most of us have yet to overcome.

The black leadership is most responsible for promulgating this myth. For rather than celebrating the great strides of the black population since


1963, they prefer to emphasize the negative.

So they constantly remind us of the number of blacks in poverty, on the jobless rolls or collecting welfare. They persistently note the rise in black teenage pregnancies and the numbers of blacks doing jail time.

But the emphasis on pathology provides a skewed portrait of black America. The fact is most blacks are not poor, most are not jobless, most are not on welfare. Most black teenage girls don't get pregnant and most blacks do not run afoul of the law.

An obvious reason that the black leadership prefers to dwell on black pathology rather than

black progress is that it enables them to continue to make claims on American society; to insist that blacks still are owed special entitlements. Thus, we can look forward to more lamentations about the continuing plight of black

America when the civil rights leadership stages a 30th anniversary March on Washington this weekend.

But the mau-mauing by black leaders has gotten old and tired. After three decades, it's about time

they stopped blaming society for the lingering problems of the one-third of black Americans who are poor and struggling. Their efforts would bear far more fruit if they sat down and examined why two-thirds of blacks in the thriving middle class and the earnest black working class are moving forward, and figure out how to bring along the one-third of blacks who have been left behind.

It really is no mystery why some blacks have overcome and others have not. Those who have overcome have discovered that upward mobility in America has less to do with their skin color than the content of their character — their behavior. They have moved on up because they have adopted an ethic of success. They've gotten a good education. They've worked hard. They've gotten married before having children. This simple ethic almost always produces progress. The success of the black middle class over the past three decades is a testament to this.

The challenge for the black leadership is to instill in poor and struggling blacks the ethic of success that has enabled the thriving black middle class to prosper. Only then will disadvantaged blacks realize the dream that Martin Luther King Jr. spoke of 30 years ago.

SUBJECT: SPEECH TO THE "STREET SURVIVAL '93" SEMINAR

As you know, you are scheduled to speak at the "Street Survival '93" Seminar at the Wichita Marriott on Tuesday, August 31, at 9:30 a.m. The speech describes the Neighborhood Security Act. I am told that there should be between 150 and 200 people in attendance. Most of the attendees will be from states in the Midwest.

The Street Survival Seminar is a three-day event, lasting from August 31 to September 2. You are one of the first speakers.

The Seminar has been developed by Calibre Press, Inc., a company based in Northbrook, Illinois. The Seminar is designed to provide training for law enforcement professionals to deal with the dangers that they may encounter on the streets and in the courtroom. Subjects include "the proper use of force," "pat-down and search techniques," "pursuit tactics," and "how to defeat courtroom tricks lawyers use to trip you up."
