# Guarding Intellectual Property

As Uruguay Round negotiators inch slowly toward their Dec. 15 deadline, their focus remains fixed on farm trade disputes between the United States, Europe and Japan. That seemingly endless wrangle is obscuring an even more important issue for the United States: the GATT rules protecting intellectual property rights, such as trademarks and patents.

A 1988 International Trade Commission report showed how vital the issue is for U.S. manufacturers. It found that U.S. industry loses between \$43 billion to \$61 billion a year due to inadequate intellectual property protection abroad.

Earlier this year, the Business Software Association estimated that the software industry alone loses between \$10 billion and \$12 billion a year due to lax protection.

The rampant counterfeiting or pirating of U.S. intellectual property reduces potential sales and royalties. It also deters investment in new products and processes.

This issue is being hashed out in GATT's negotiating group on Trade-Related Aspects of Intellectual Property Rights (Trips). While the current draft of the Trips code provides increased protection in some areas, other provisions are seriously flawed.

The most serious deficiency of the draft code is that it allows governments to require foreign companies doing business in their territories to license their creations to local businesses. The draft code not only fails to limit this practice, it actually legitimizes it.

Under the proposed code, each country would be able to determine when to require licensing, provided the patent holder receives "adequate" compensation.

That is a threatening gap in the safety net for patent holders - all

that receive those compulsory licenses to export the resulting products.

In effect, the code would allow a government to give domestic producers the tools it needs to beat and bankrupt an American company with its own creation.

The code should strictly limit compulsory licensing to products and processes tied to national security, economic emergencies or violations of national competition laws.

The draft Trips code also is deficient on another count: failing to preserve a U.S. remedy that protects American companies against foreign piracy of their intellectual property. The remedy is provided in Section has several other important short-337, a U.S. law that allows the U.S. International Trade Commission to exclude patent-infringing exports from the American market.

In 1988, a GATT panel ruled that some elements of Section 337 violate the principle of national treatment. Despite serious questions about this decision, the United States eventually adopted the report but said it would continue to enforce Section 337 "pending enactment of legisla- cals being developed in poor coun-

> But the draft Trips code does not show signs of offering U.S. manufacturers much relief from foreign piracy. The draft code says only that administration of Section 337 would be transferred from the International Trade Commission to federal district courts.


That could pose many jurisdictional and enforcement problems for U.S. companies suing foreign defendants, including lengthy delays in obtaining relief and the limits on the remedial powers of district courts.

· It does nothing to restrain countries from deciding unilaterally that a patent has been "exhausted" internationally and no longer protects a product or process.

These shortcomings raise serious questions about whether the Trips code fulfills the original mandate of the Uruguay Round. The intention, stated in the round's Ministerial Declaration, was to address "the need to promote effective and adequate protection of intellectual property rights." The U.S. negotiating objectives included "enactment and effective enforcement by foreign countries of laws which recognize and adequately protect intellectual property . . . and provide protection against unfair competition."


Given the code's many flaws, it is difficult to say the negotiators have come anywhere near these goals.

That has not escaped the Congress: A resolution introduced by Majority Leader Richard Gephardt, urging the administration to protect the interests of intellectual property industries, has attracted more than half the members of the House of Representatives as co-sponsors.

This support should give the American negotiating team in Geneva the ammunition it needs to press for changes to the code.

Intellectual property plays a major role in the U.S. economy. To agree to ineffective protections, or to trade off safeguards in this area in return for minor gains in others, will not do U.S. companies justice.

Needed: A Better Textiles Policy

Continuing high U.S. trade deficits following six years of dollar devaluation makes this much clear: President Clinton cannot redeem his pledge to create millions of good jobs unless the United States stops its longtime policy of one-way free trade and insists on reciprocity from its economic partners.

Nowhere is this more true than in the case of the U.S. textile and apparel industries, which despite imports totaling 44% of the U.S. market still employ nearly 1.7 million Americans. Trade in these industries is governed by the Multi-Fiber Arrangement (MFA), a 20-year-old agreement designed to prevent textile and apparel market disruptions in industrialized countries.

Conventional trade wisdom holds that the MFA is simply a protectionist gimmmick that enables uncompetitive textile manufacturers to rip off American consumers. Consequently, the current Uruguay Round of world trade talks has sought to phase out the MFA and Washington essentially has agreed.

Nonetheless, the Uruguay Round's textile negotiations have been deadlocked in recent months by a long-running U.S.-European Community tariff quarrel and, above all, by a U.S.-Third World dispute over the MFA phase-out and liberalized access to developed and developing countries alike.

Yet the conventional wisdom is wrong. Due in large part to a major modernization campaign during the 1980s, U.S. companies and workers can compete in many areas, while those of India and other developing countries cannot. It's not the American market that is protected, but those of the developing countries.

India, for example, exported \$2.9 billion worth of apparel to the United States in 1991 and imported only a few million dollars worth, despite a population of 800 million.

Time, however, is running out to reform textile and apparel trade arrangements by the Uruguay Round's Dec. 15 deadline.

Consequently, instead of haggling over the length of the MFA phase-out, the United States should raise the stakes and call the developing countries' bluff. Washington should support equitable trade liberalization in these sectors by pushing a plan developed recently by textile and apparel manufacturers and workers around the world, including some developing countries. Since May, they have been urging that the MFA phase-out for exporters be linked to compliance with a "charter of principles" that would revolutionize trade in textiles and apparel.

The charter sets out eight principles designed to promote equitable competition. They are:

• The opening of industrialized-country markets reciprocally — not according to the inherently unbalanced principles of the Most Favored Nation and National Treatment endorsed by the General Agreement on Tariff and Trade (GATT) — by cutting tariffs and especially non-tariff barriers to trade.

• Effective enforcement of laws prohibiting dumping, trade-distorting subsidies and intellectual property theft by using the MFA's disputesettlement procedures — rules that do not involve a significant surrender of national sovereignty to multilateral panels where America can easily be outvoted.

 Prohibition of fraudulent trade practices, such as transshipment, designed to evade current trade rules.

 Safeguards that respond more quickly to import surges.

 Effective measures against the trade distortions inherent in non-market economies and in the practice of industrial targeting.

 Guarantees of broad worker rights such as the right to unionize; a ban on forced labor and child labor, and "minimum standards" governing wages, hours and health and safety conditions.

 Granting market access only to goods whose production meets "acceptable environmental practices."



• Genuine enforcement of these rules and rapid responses to violations.

Not only is the charter endorsed by industrial and trade union leaders from the United States, Japan and the 12 European Community countries, but by industrial associations from Mexico and Jamaica. Many of their counterparts in the rest of the Third World, moreover, have expressed support in private. The reason: All are terrified that full global trade liberalization without these rules means complete domination of world markets by China, which has by far the world's biggest, cheapest work force and a communist government determined to keep it that way.

Unlike its predecessor, the Clinton administration favors placing some charter-like conditions on the MFA phase-out for all GATT members especially regarding market access. Further, it believes an official U.S. push to link the Uruguay Round's market-access agreements to compliance with the charter could trigger dozens of official endorsements from developing countries and significantly improve the trading system.

Washington, however, is reluctant to jeopardize its year-end timetable for completing the Round. These broader questions, trade officials vow, will be taken up in the next multilateral trade round.

But like the Uruguay Round, a new trade round could take years to start — much less finish. In the meantime, with the MFA phased out and textile and apparel quotas completely eliminated, accelerated import growth is certain, along with hundreds of thousands of lost American jobs. The social disruptions caused by such job losses could dwarf the Los Angeles riots.

In addition, the administration has now identified textiles and apparel as important keys to future American competitiveness. What good will come of the millions government has spent on a new partnership program with the industries if U.S. trade policy condemns them to dramatic shrinkage in a decade or less?

Accepting artificial deadlines is never a smart negotiating tactic. President Clinton should remember that no trade agreements are better than bad trade agreements. He should push for the textile charter's principles and take whatever time is needed to do trade policy right.

# The Copernicans of Trade

HOSE OF US WHO HAVE BEEN LABELED "REVISIONISTS" over Japan are feeling like Copernicus. whose assertion that the planets revolved around the sun was proven true after years of scorn from conventional thinkers. For the past eight years, we revisionists have been called everything from naive to racist. Today, Japan's new government has confirmed virtually everything in the revisionist analysis; it has become, if anything, more revisionist than the revisionists.

When we said Japanese economic decisions are made by an "iron triangle" of the Liberal Democratic Party (LDP), the bureaucracy and businessmen, we were condemned as "Japan-bashers." Yet just recently Prime Minister Morihiro Hosokawa referred to the old system as "corrupt" and promised to "eliminate this collusive structure." When we said the keiretsu system tended to keep out foreign and new competition, academics were rolled out to criticize our lack of understanding of the unique Japanese system: the problem, it was said, was simply that foreign businessmen did not try hard enough. Now Minister of International Trade and Industry Hiroshi Kumagai says that "big business's cartel-like character is tremendous."

Contrary to the official line of the past few years. revisionism was never anti-Japanese. In fact, it was pro-Japanese. It saw that the corruption of the system was hurting ordinary Japanese, while creating dangerous tensions among Japan, the United States and Europe. Japan's new leaders had to adopt revisionist

thought in order to achieve the reforms they seek.

In this effort. Hosokawa has sold himself as an agent of change-a man outside the system who would come in and clean up the mess. If he is able to bring about political reform-which would empower younger urban and suburban voters at the expense of the older. rural voters who make up much of the LDP's traditional political base-he would bring true change. But the question is whether Hosokawa will be able to control his coalition and carry through on his promises.

Delaying tricks: Those opposed to the new direction - especially the LDP, the bureaucracy and possibly some in Hosokawa's coalition-will do everything in their power to avert the major changes in the system that his embrace of revisionism implies. After 38 years in power, the LDP cannot be expected to take defeat in July's election lying down. As Hosokawa learned early on, the LDP can be expected to use every delaying trick permitted. because political reform would severely hurt it. So far, this strategy has backfired. Early poll numbers show that Hosokawa is immensely popular. His approval rating is hovering around 75 percent, and it is the LDP that has been chasitized for its obstructionist tactics. If Hosokawa can maintain this support, there is real hope for a kinder, gentler Japan.

The key to Hosokawa's success in the international arena will be Japan's trade policy. In an interview with the Nihon Keizai Shimbun, MITI Minister Kumagai said, "Japan's markets are extremely closed in invisible ways." Such frank comments are

welcome to the ears of international businessmen. But they must be followed by action if the new government is to maintain credibility. And it is here that there is a dilemma. On the one hand, the new government has pledged to open Japan's markets; on the other hand, it has rejected the notion of setting any targets.

Such a position inevitably raises the question of how things are going to be different. How will the new government measure progress without some goals? Won't negotiations otherwise con-

tinue to be conducted in a fog of misunderstanding and recrimination? Business leaders such as Fuji Xerox president Kobayashi Yotara and Nissho-Iwai chairman Hayami Masaru seem to have understood this problem when they urged reconsideration of Japan's rejection of trade goals. As they pointed out. Japan uses goals constantly in its public and private planning. Agriculture Minister Eijiro Hata was thinking in terms of concrete goals when he called on beef importers to restrain imports. The Economic Planning Agency always sets targets for growth and for savings and investment.

Japan's trading partners are likely to judge the sincerity of pledges to open markets by whether or not there is some set of concrete goals and a way of measuring progress toward them. Certainly this will be the reaction of the Clinton administration, which has also embraced revisionism. It did so because it realized that the old approach of demanding procedural changes in Japan only led to endless argu-

ments over abstract concepts such as "fairness." I believe that a more concrete approach based on the realities of the Japanese system would be more fruitful and less emotional. This is a very positive policy, and the new president and prime minister have a real opportunity to remove the tension from the U.S.-Japan relationship.

The Clinton administration should work quietly, without threats and public posturing, to make the new framework negotiations a mechanism for setting and accomplishing mutually acceptable objectives with regard to the future of the relationship. If this proves impossible (and I don't believe it will), the U.S. administration, without accusing or blaming Japan, should set its own objectives and take whatever steps are necessary to defend U.S. economic interests and to ensure development of a vigorous American industrial structure.

The essence of revisionism, after all, always has been that America should emphasize competitiveness as its top priority, not that it should force Japan to accept particular demands. Of course if Japan wants to cooperate. America should always be willing to do so. But, more than anything else, revisionists want America to be competitive and its relations with Japan to be harmonious and mutually beneficial.





- Ehlers annually returns to the state thousands of unspent dollars from his office budget.
- The opponent, Dale Sprik, is leaning to the right on issues. However, he favors a national health care plan, does not support NAFTA, attacks PAC money but accepted \$50,000 from PACs in 1980 (labor \$\$), etc. (See attached memorandum on opposition research done by campaign).

# Vern Ehlers

In 18 years in Michigan politics, Vern Ehlers has a built a solid record of legislative accomplishment, with service as a Kent County Commissioner (1975-1983), State Representative (1983-1985) and in his current position as State Senator. Ehlers initially won his seat in the State Senate during a hard-fought special election, much like the one he now faces to replace the late Rep. Paul Henry.

With a strong reputation for accessible constituent service and legislative accomplishment, he's consistently been returned to office handily, now serving as Senate President *Pro Tempore*. As State Senator, Ehlers represents 45 percent of the 3rd Congressional District.

A physicist by training, Ehlers became interested in politics while serving as science advisor to then-Congressman Gerald R. Ford. He was named to Governor Miliken's Task Force on Environmental Problems in 1970, served on the Boards of the West Michigan Environmental Action Council from 1970-1971, and the West Michigan Environmental Protection Foundation from 1973-1974.

Ehlers has consistently been rated by the *Detroit News* as an "effective legislator," and with good reason. In 8 years in the State Senate, he has authored more than 120 Michigan Public Acts, and he has rightly gained a reputation as one of the Senate's key players on issues of health and the environment.

Ehlers was the prime mover in enactment of Michigan's "Good Samaritan" Physician Protection Act and in developing solutions to the problem of medical waste disposal. Ehlers authored legislation to establish a record of spinal cord and traumatic brain injury cases in Michigan, to reform the "Certificate Of Need" (CON) process, and to expand the role of nurse midwives, nurse anesthetists, and nurse practitioners on the Michigan Board of Nursing.

He spearheaded passage of landmark legislation to clean up toxic contamination. This measure directed the Michigan Department of Natural Resources to compile a list of hazardous waste sites and develop a schedule for their cleanup, and shifted the costs away from taxpayers and onto the responsible parties. He also authored legislation to provide private business with waste reduction assistance.

Other legislative highlights include model legislation assuring safe maintenance of underground storage tanks, progressive measures aimed at waste reduction and recycling, and the \$140 million 1988 Recreation Bond Implementation Act.

He chairs the Senate Appropriations subcommittee on Public Health and Natural Resources, and is Vice-Chair of the Natural Resources and Environmental Affairs Committee. He also serves on the Appropriations subcommittees on General Government, Higher Education and Capital Outlays, and on the Michigan Capitol Committee.

He faces a Special Election on Tuesday, December 7, 1993.

#### **BIOGRAPHICAL SUMMARY**

Vern Ehlers currently serves as the President pro tempore of the Michigan State Senate. He achieved this leadership post several years after winning a special state Senate election in 1985. Since then, he has held his seat with large Election Day victories in both 1986 and 1990.

Ehlers performed undergraduate work at Calvin College in Grand Rapids, then received his A.B. in 1956 and his Ph.D. in 1960 from the University of California at Berkeley. Both degrees are in physics. He spent six years as a Lecturer in Physics and Research Physicist at Berkeley and sixteen years as a Professor of Physics at Calvin College, where he was Chair of the Physics Department for several years.

While teaching, Ehlers continued to show a keen interest in the community. He was actively involved on community boards and councils, including serving as a science advisor to then-Congressman Gerald Ford. This was when his interest in politics first developed.

Ehlers was elected to the Kent County Board of Commissioners in 1974. He served as the board's chair from 1979 until 1982 when he was elected State Representative.

RE: YOUR TRIP TO MICHIGAN

The following is background information regarding your trip to Michigan:

#### POLITICAL ENVIRONMENT

In Michigan, the Republicans have done noticeably better in presidential, gubernatorial and even state legislative elections than we have in U.S. Senate elections. Specifically:

- -- Since 1952, we have won at the presidential level in every election except 1960 (Kennedy), 1964 (Johnson), 1968 (Humphrey), and 1992 (Clinton).
- Since 1966, we have won the governorship in every election except 1982 and 1986.
- BUT, since 1966, we have lost all 9 Senate elections except two (1966 and 1972). Worse, in those races in which we lost, our average vote has been a low 42.1%.

And in the state legislature, we now have control of the Senate and co-control of the House. Interestingly, Michigan is the largest industrial state to have Republican control of the state legislature.

The conclusion in clear: our poor Senate performance is not a Michigan problem, it is a Senate problem, and specifically a Senate *candidate* problem. If ever there were a year when we could win a Senate seat in Michigan, this is it.

#### The Democrats

Scandal-tainted incumbent Senator Don Riegle has decided not to seek re-election, so many Democratic activists are awaiting word from former Governor and current Ambassador to Canada Jim Blanchard to see if he will jump into the race. A recent AP story was headlined "Blanchard Leads Abraham, Romney, But Many Prefer Him as Ambassador." Carl Marlinga, the Macomb County Prosecutor, announced that he would run in the primary against Riegle, then reversed himself and then reversed himself again when Riegle announced his retirement. Liberal state senator Lana Pollack, who was definitely going to run against Riegle, has also announced, as has former U.S. Rep. Bill Brodhead. There is some speculation that Brodhead is simply a surrogate for Blanchard, and will drop out if Blanchard runs.

#### Incumbent GOP Governor John Engler's re-election campaign

Governor Engler is slightly favored to win re-election, but a school funding issue has created problems for what was supposed to be an easy re-election. In August 1993, Engler signed a bill abolishing property taxes as the means to finance schools. He and the State Legislature have been working together since to make up the nearly \$6 billion revenue shortfall. If he comes out looking good on this issue, re-election will be easier and with both him and the state legislative races on the ballot, the Republican turnout should be high and our nominee can ride in on their coattails.

#### ANNOUNCED REPUBLICAN CANDIDATES:

#### SPENCE ABRAHAM

Spence Abraham served as Co-Chairman of the NRCC from 1991 through 1993, where he chaired the committee's Rules Committee. He was also a candidate for the RNC Chairman position in 1993. Previously, Abraham served as Deputy Chief of Staff for Vice-President Dan Quayle in 1990-1991 and, before that, Chairman of the Michigan Republican Party from 1983 until 1991. He has also taught at Cooley Law School and founded the Federalist Society.

His principal strengths are his fundraising ability (nationwide, especially, because of his previous positions), his strong ties to the Engler and State GOP organizations, and his reputation as the one to beat.

His one major weakness is his speaking ability and ability to relate to the voters. One of the main reasons cited for Spence's loss to Haley Barbour for RNC Chair was that Spence was seen as a poor television presence.

#### RONNA ROMNEY

Ronna Romney recently announced for the Senate seat. Because of that she resigned as a talk show host for WXYT radio in Detroit, and as a regular commentator on CNN & Company. Her radio show was the top rated program in its time slot (9-11 p.m.) and was on the same station as Rush Limbaugh is in the afternoon. Prior to that, she was a political analyst for WXYZ-TV in Detroit. She has co-authored two books, <u>Momentum: Women in American Politics Now</u>, and <u>Giving Time a Chance</u>. She obtained her B.A. from Michigan State University in 1967, and from '69-'70, she taught at the Hartwell School in Lincoln, Massachusetts. Ronna served as Michigan's Republican National Committeewoman for eight years, until 1992.

Her strengths are her name ID from her Detroit radio program (58% statewide, 78% in metro Detroit), the Romney name (although her former father-in-law, George Romney, has endorsed Spence Abraham),

the intangible "interesting" factor: Romney has great potential to be an interesting candidate, attracting a lot of earned media attention.

Her principal weakness is fundraising. Her potential fundraising "base" is the same as Abraham's, and he has gotten to them first.

#### 3rd CONGRESSIONAL DISTRICT PROFILE

#### ECONOMIC ANALYSIS

The district is diverse in that it includes the metropolitan base of Grand Rapids as well as some of the most productive farmland in the state. Grand Rapids is considered to be the birthplace of the furniture industry. Steelcase is the area's largest employer. General Motors, Meijers and Amway are also among major employers in the community.

Significant growth in Kent County is spurring growth in nearby Ionia and Barry Counties as well. While the 1990 U.S. Census showed little growth in Michigan as a whole, Kent County marked an 11% increase in population.

#### POLITICAL ANALYSIS

The 3rd Congressional District is considered a safe Republican seat. While the district has recently changed with reapportionment, former Congressman Paul Henry won easily with 61% of the vote in 1992.

Statewide Republican candidates have also done well within the 3rd Congressional District. Governor John Engler led the district with 65% of the vote in 1990 and President Bush carried 64% of the vote in 1988. Board of education races over the past decade also show the district is decidedly Republican, including a 64% MRBD in 1990 and a 63% MRBD in 1988. Even in 1986, when Democrat James Blanchard scored a landslide victory over Republican Bill Lucas in the Governor's race at the top of the ticket, the MRBD was a solid 56%.

#### 3rd CONGRESSIONAL DISTRICT Primary Election - November 2

Vern Ehlers faces seven other primary election opponents: including a current State Representative, a deputy Director in the Michigan Department of Commerce, and the Kent County Republican Party Chairman.

Recent evidence shows Vern Ehlers as a strong front-runner, with the state Representative running a distant second. The other two candidates, although they may run viable campaigns, lack sufficient name identification from the gate to make a serious effort in such a short primary election cycle unless they expend large amounts of money.

Vern Ehlers will be the next Michigan congressman because he has many advantages over his competitors. Consider that:

• Vern Ehlers is a proven winner. He has served as a public servant within the congressional district for nearly twenty years and has never lost a partisan election.

• Vern Ehlers is a proven winner in special elections. His first term in the Michigan Senate came after an intense special election campaign in 1985.

• Vern Ehlers is the strongest candidate out of the gate. His current Senate district covers 40%

of the 3rd Congressional District. No other candidate has such a large base from which to work. This is crucial given the short campaign cycle.

• Vern Ehlers has the support of a majority of the current elected officials. That kind of grass roots support is a key element to winning a special election.

Vern Ehlers will run an aggressive campaign in all areas of the 3rd Congressional District. The campaign will work to secure his base in Grand Rapids and the surrounding communities where he has been so successful in the past, and it will branch out to the surrounding areas, including Ionia and Barry Counties, where he already has a strong showing of support.

The campaign will employ aggressive direct mail and sign programs as well as intensive efforts in the field. The same campaign machine that has gotten Vern Ehlers elected to the legislature for more than a decade will be leading his way to Congress: including the same campaign manager and the same finance chairs. More than 50 unsolicited volunteers have already contacted the campaign and there are many more volunteers available. This very strong campaign organization will prove to be the determining factor is a short campaign cycle.

#### Important Laws Sponsored By Senator Ehlers (Excerpted from the 120 Public Acts Sponsored by Senator Ehlers)

#### **Emergency Telephone Service Act (911)**

Senator Ehlers sponsored the Emergency Telephone Service Enabling Act to allow the establishment of emergency dispatch services that are accessible 24 hours a day to the public by dialing 9-1-1. Callers reach a public safety center equipped to answer emergency calls and dispatch emergency services, or transfer or relay emergency calls to other public agencies. This automated system also immediately displays the address of the caller.

#### Newborn Screening Program

Since March 1987, all health care officials are required to test newborn infants for sickle cell anemia, galactosemia, hypothyroidism, maple syrup urine disease, biotinidase deficiency, and other treatable but otherwise handicapping conditions. Test results are immediately reported to the parents of children who have the disease.

#### Agent Orange Commission and Information Resource Center

In June of 1987, Senator Ehlers helped create the Agent Orange Commission and Agent Orange Information Resource Center within the Department of Public Health. Duties of the commission and resource center include reviewing literature of herbicide compounds, publicizing the department's information program for Vietnam veterans exposed to Agent Orange and other herbicides, maintaining a registry, and providing information on agent orange research.

#### **Recycling Makes Cents Office Paper Recovery Act**

This act required that by March 1989, all state departments and agencies, and legislative and judicial offices must implement a paper recycling system for wastepaper products. The Recycling Makes Cents Office Paper Recovery Act provided for the expansion of any existing recycling programs; set up an aggressive program to locate and develop markets for recyclable waste paper products; and developed an education program for state employees. By the year 2000, 85% of all state waste paper must be recycled.

Senator Ehlers also amended other acts to require an increase in the amount of recycled paper purchased by the state.

## **Environmental Technology and Waste Management**

In 1987, Senator Ehlers created the Environmental Technology Act establishing the Environmental Technology Board within the Department of Commerce to investigate setting up an Environmental Technology Institute to conduct research and develop waste management technologies.

Senator Ehlers also passed legislation to establish the Hazardous Waste Policy Committee within the Department of Natural Resources and created the Waste Reduction Assistance Act, which established several waste reduction programs and grants. The programs provide information, education, technical assistance, and funding to facilitate a reduction in the amount of waste generated by the state.

In 1990, the Waste Management Act was amended by Ehlers to require landfill owners and operators to establish a perpetual care fund for landfill closure, monitoring, and maintenance. Other amendments prohibit landfill operators from accepting the disposal of contaminated medical waste.

Senator Ehlers also helped create and amend laws to regulate the disposal of lead acid batteries, prescribe procedures for the storage, decontamination, and disposal of medical waste, and prohibit the disposal of used oil into drainage systems, sewers, and water.

#### **Barrier Free Construction Zoning**

Senator Ehlers' amendment to the Downtown Development Authority Act helped plan, propose, and implement changes to public facilities to make them barrier-free.

#### **Recreation Bond Fund**

In 1988, Senator Ehlers sponsored several acts to create a \$140 million recreational bond to provide grants and loans to construct, expand, or develop recreational facilities at state parks and local government public recreational projects, and to redevelop abandoned industrial sites for recreational facilities.

## Michigan Underground Storage Tank Acts

Effective August 1989, laws established by Senator Ehlers provided for the cleanup and prevention of environmental contamination resulting from releases of refined petroleum products from underground storage tank systems. This has protected our drinking water from contamination.

#### Public Health and Safety

Senator Ehlers sponsored an act to amend the Public Health Code to require the Department of Public Health to establish a registry to record cases of spinal cord and traumatic brain injuries that occur in the state.

During his tenure as Chairman of the Health Policy Committee, Senator Ehlers played a key role in the development and ultimate passage of the Michigan Clean Indoor Air Act and several other pieces of legislation to reduce the use of tobacco. The Michigan Health Initiative, which is designed to promote health through work-site wellness programs was also passed during his tenure as chairman. In addition, many of the state's laws and regulations to prevent the spread of HIV and to provide medical services to HIV patients were adopted during this time.

#### Improving the Effectiveness and Efficiency of State Government

Senator Ehlers has contributed to the redefinition of the state's welfare system to empower citizens with education and incentives to move off the welfare roles and to become productive members of our society. Currently, Senator Ehlers is working with the Governor and the Republican Caucus to develop a plan to reform and finance the state's education system.

Candidate: Dale R. Sprik, age 55; married, 5 children; one grandchild

Occupation: Attorney, specializing in plaintiff's personal injury cases.

Previous Political Experience: Local McGovern Coordinator 1972, Opposed Republican Harold Sawyer for the 5th District seat in both 1978 and 1980. Sprik was defeated both times. In 1978 by 1,200 votes and in 1980 by over 8,000.

Military Experience: Sprik served in the U.S. Army from 1956 through 1958. He was stationed in New York State and Heidelberg Germany.

Personal Finances: Sprik's net worth is estimated at 1.4 million dollars. As an attorney he made \$308,300.00 in 1992. Sprik also owns a 157 acre ranch just outside of Grand Rapids where he is raising American Bison. The farm, however, is primarily a hobby and reports only modest income.

Campaign Finances: Sprik's Campaign spending through the pre-primary filing deadline was \$26,128.34. However, post primary spending has exceeded \$200,000.00 through Nov 13 and is expected to surpass \$500,000.00 before the election is finished.

Positioning: Dale Sprik is pretending to be a conservative.

Sprik has given very generic answers to most issues thus far. He wants to reform Congress, cut spending, create jobs, etc. Sprik is anti-abortion and has been throughout his political career. He favors a national health care plan but is careful not to link himself to the Clinton plan. He favors an alternate Clinton plan that takes some of the burden off the small business man. Sprik does not support the Brady Bill but was linked to an anti-handgun lobby during his previous campaigns. Sprik's front-line issues to this point have been congressional reform and social security. He has hammered on congressional perks, travel and mailing in particular, and has said he will cut the congressional budget by 10 percent. Sprik favors a "hands off" approach to social security believing that the money has been earned and should not be tampered with in any way. He has also made PAC contributions a major issue, accusing State Senator Ehlers of pandering to special interest groups. Sprik has said he will not take any PAC money in this campaign although he did accept over \$50,000.00 from PAC's in his 1980 campaign, those monies coming primarily from labor groups. He says he will support campaign finance reform to curb special interest contributions. Sprik opposed the NAFTA agreement in its current form, his concern being that Mexico would not have to adhere to the labor and environmental laws that the United States is subjected to. He wanted to see the option of more intense trade sanctions in the event that agreements were not maintained.

In essence, all his positions and answers have been very generic and idealistic. When he has been pushed for specifics Sprik tries to turn the issue on his opponent hoping that they will

make a mistake that he in turn can attack thus giving the appearance that he has a better grasp on the details of an issue.

Analysis: Sprik is a "stealth-like" candidate.

Sprik is trying to distance himself from both the Democratic party and Bill Clinton. He has maintained a moderate to conservative stance on most of the issues, claiming that he is a trustworthy life-long native of west Michigan who will go to Washington to tackle the corrupt political establishment. His premier campaign slogan has been "For the People for a Change," (haven't we heard that somewhere before)? Sprik is adept at being a political chameleon. He poses for his adds wearing a cowboy hat and jeans looking out over his buffalo ranch when in actuality he is a low-income personal injury attorney. Our hope is that the voters of the 3rd District are not fooled by his conservative facade.

Throughout this campaign, as well as his previous ones, Sprik has done his best to drag his opponents down to his level. Television and print adds have already begun, attacking State Senator Ehlers and his record. Sprik has said that he "ain't going to be Bob Dole's boy in Washington or Bill Clinton's boy in Congress." Sprik says he will go to Congress as a man of the people who will answer to no one but the constituents of the 3rd district.

Perhaps the most important thing to note is that Sprik has nothing to loose. He has no political experience so his only chance for victory is to try and drag his opponent down to his level, and he will do <u>anything</u> to achieve that end. Sprik proposes the idea of fresh honest leadership-vs-stagnant career politicians who are simply trying to line their own pockets at the expense of the taxpayers. He is a "career candidate" who firmly believes that this third time will be a charm, and unless he is taken seriously, it will be.

## Enlers ahead in 3rd District, new poll shows

By Ted Roelofs The Grand Rapids Press

GOP state Sen. Vernon Ehlers enjoys a commanding lead in his campaign for the 3rd Congressional District seat, a poll of 400 prospective voters shows.

The poll, conducted by the Lansing firm EPIC-MRA, found that Ehlers was supported by 57.5 percent of likely voters compared to 27.5 percent for Democrat Dale Sprik and less than 1 percent for independent Dawn Krupp. Fourteen percent were undecided.

EPIC-MRA, an independent marketing/polling firm, paid for the poll itself. It has conducted political surveys statewide in recent years, and conducted a poll for the 3rd Congressional District primary.

But the survey, conducted Sunday and released Tuesday, two weeks before the Dec. 7 election, didn't bring a concession speech from Sprik.

"That does not reflect what I believe is happening," Sprik said. "We know that momentum is building in our campaign, especially in the last three or four days.

"All we care about is being ahead on Election Day and not too much before. We've got two weeks to go and we know we're going to be there," he added. Ehlers said he was "encour-

Ehlers said he was "encouraged" by the results but warned of overconfidence.

"It certainly looks very encouraging. At the same time, my biggest fear throughout the campaign has been complacency on the part of voters," he said.

Ehlers said he is concerned that supporters will decide to stay home on election day because they assume the race is already decided.

"This is a December election and people are thinking about Christmas and shopping, and I have no idea what effect that will have on the election but it is likely to reduce turnout," Ehlers said.

Despite the poll, Ehlers said he is taking Sprik's campaign "very seriously."

"He is a very determined campaigner, and I am taking it very

seriously and urging all my supporters to take it seriously."

Ed Sarpolus, a partner in EPIC-MRA, said the polling results suggest the race "is Ehlers' to lose."

Perhaps more troubling for Sprik, Sarpolus said, is the fact that Sprik's "unfavorable" ratings are considerably higher than Ehlers.

"Sprik obviously has some baggage," Sarpolus said. Ehlers was given a 66 percent favorable rating by respondents, and a 12.5 percent unfavorable rating. Sprik, a partner in the law firm of Sprik and Andersen, had a favorable rating of 41 percent, but an unfavorable mark of 33.8 percent, the poll found.

Sprik has already spent more than \$200,000 of his own money on the campaign, pouring much of that into television, print and radio advertising. Much of it

mittee contributions in past campaigns. It is the most aggressive Democratic West Michigan congressional campaign since the unsuccessful 1984 effort by Democratic lawyer Gary McInerney.

Ehlers also reminded supporters that Sprik came within 1 percent of beating Republican Harold Sawyer in 1978, and ran a close race in 1980. "Sprik maintained that he moved

"Sprik maintained that he moved first to establish name recognition with voters and is now beginning to define himself on the issues.

Among voters who identified themselves as "pro-life," Ehlers was supported by 68.5 percent and Sprik 19.9 percent. Among "prochoice" voters, Ehlers was supported by 46 percent and Sprik 36 percent. Both Ehlers and Sprik oppose abortion except where the mother's life is endangered.

The poll numbers changed considerably when voters were informed that Krupp is a member of United We Stand America, the grassroots political organization started by Texas billionaire Ross Perot.

When that factor was introduced, Ehlers got 51.9 percent support, Sprik, 22.3 percent and Krupp 11.5 percent. Within the group who identified themselves as Perot voters, Ehlers got 30.5 percent, Sprik 15.7 percent and Krupp 32.2 percent.

Krupp was skeptical of the poll results, especially the survey which places her support at less than 1 percent.

"It depends on who gets out to the polls. I think the people who are supporting me are interested in seeing me prevail and they will get out and vote. I think the statistics will be much different on election day," Krupp said.

The poll has a margin of error of plus or minus 5 percent.

#### Early Line

On June 3, Michigan voters delivered a setback to Gov. Engler when Proposition A, a plan to revamp school financing and cut property taxes was defeated 54% to 46%. The plan called for raising state sales taxes from 4% to 6% in order to cut the gap in educational spending between rich and poor by establishing a minimum spending threshold for students. Michigan voters have defeated similar proposals ten times in the last twenty years. Gov. Engler had actively campaigned for passage and the defeat of the proposition will affect his re-election efforts. The setback has prompted the media to to place him under greater scrutiny, especially on issues of style over substance. Most recently he was criticized for excessive use of the state plane (85 occasions since taking office). His flying hatched attacks from Democrats since Engler had made former Gov. Blanchard's heavy use of the plane as a campaign issue.

The defeat of Prop. A has emboldened a number of Democrats to make campaign plans. Two who have recently expressed more than a passing interest are Joel Ferguson and Lynn Jundahl. Ferguson is an African-American businessman and the influential Chairman of the Michigan State Univ. Trustees. He is being courted to run by the same consultant team that engineered VA Gov. Wilder's and NYC mayor Dinkens' victories. Having organized Jesse Jackson's surprise MI primary victory in '88, he is no stranger to politics. State Sen. Debble Stabenow, longtime chair of the state taxation committee established a campaign committee and is pursuing an active travel state-wide schedule. Other potential Democrats include state Sen. Debbie Stabenow who established an exploratory committee at the turn of the year, former Rep Howard Wolpe and former East Lansing mayor Larry Owen.

\*13 MICHIGAN: ENGLER MAKING PROGRESS ON SCHOOL REFORM The MI House "passed a scaled-back version of charter schools" 11/29, "as lawmakers began a hectic week of debate on educational reform." Charter schools "are a centerpiece of reforms being pushed" by Gov. John Engler (R), who had "proposed a broader version" but said that he was "pleased" by the vote. Engler: "These reforms give Michigan the most extensive, expansive charter school bill in the country. The House listened to the only special interest that counts -- the best interests of our kids." Although the measure was passed with "broad support," it did not include "schools of choice, which Engler says is an essential piece of the school reform puzzle. That sets up a lengthy fight" when the House considers the rest of the package this week (Borowski, LANSING STATE JOURNAL, 11/30). The plan passed by the House "differs from Engler's mainly in that it would not establish a state authority to grant charters to nonprofit organizations or businesses." Engler had also "proposed allowing noncertified teachers in charter schools and giving them an option of not joining a union" but the House rejected that (Christoff, DETROIT FREE PRESS, 11/30). W.S. JOURNAL's Suskind writes on the bill Engler signed 8/93 to abolish property taxes as the means to finance schools, noting "now he is working furiously ... to stitch together a potpourri of levies, including a sales-tax increase ... to make up a \$6 billion revenue shortage." Suskind notes the larger implications of MI's school problems: "Converging in Michigan are two of today's most explosive populist revolts: opposition to property taxes and outrage over the performance of public schools. Voters nationwide who have been crying out to reinvent government, to throw out the old ways and start clean, would be well served to come here and watch the free fall that has resulted" (11/30). Per your request, here is some background and talking points for Senator Dole's visit.

As an overview, Rep. Talent's district does not have a Republican majority, although it is somewhat Republican-leaning. About 40% of voters claim to be Republican. In last year's Presidential election 43% voted for Clinton, 35% for Buch, and 21% for Perot. Congressman Talent's seat has turned over quite a bit in the last few years. In 1986, Republican Jack Eucehner defeated incumbent Democrat Bob Young. In 1990, Democrat Joan Kelly Horn defeated Buechner by only 54 votes. Then last year, Jim Talent defeated Horn by 2.5%.

Here are some suggested talking points for Senator Dole for use in his speech at the fundraiser for Rep. Jim Talent.

1. <u>Health Care</u> -- This is what Rep. Talent is focussing on now. In fact, on Saturday Talent is hosting a town hall meeting regarding alternatives to the Clinton Plan.

The Senator should feel free to discuss his views on the Clinton Plan as well as alternative plans. He should be aware that Rep. Talent is one of the 11 original co-sponsors of the plan sponsored by Senator Nickles and Rep. Stearns (the Consumer Choice and Personal Health Security Act). Talent is a strong opponent of the Clinton Plan, which he regards as government-run health care. He is a big fan of Health Care IRA accounts as a way to get health care costs under control. I've attached an op-ed piece by Rep. Talent that recently appeared in the St. Louis Post-Dispatch that provides a good overview of where Rep. Talent stands.

 <u>Defense</u> -- The defense industry is very important to St. Louis. St. Louis is home to McDonnell Douglas and many large defense industry firms. Moreover, McDonnell Douglas is the St. Louis area's largest employer.

The Senator might discuss the dangers of the sharp cuts in military spending called for under the Clinton budget. Rep Talent often discusses that when this latest round of cuts takes effect we may begin to see real differences in the speed of our response, the certainty of the outcome, and the level of American casualties. Talent says that the failed military effort to free the hostages in Iran under the Carter Administration, in which Americans lost their lives because of inadequate equipment, should serve as a chilling reminder of the new risks we may now face.

Senator Dole might acknowledge the role Rep. Talent has played as a member of the House Armed Services Committee to protect important programs from sharp defense cuts requested by the Clinton administration. He might specifically mention the importance of two McDonnell Douglas programs to the national interest, F-18 Hornets (Navy) and the AV-8B Harrier (Marines).

Alco, Rep Talent founded the "Hollow Forces Undate Committee", which is a caucus of members of HASC dedicated to exposing specific examples of how our forces are weakening, in hopes of reversing the trend of deep defense cuts.

3. <u>Rep. Talent's Election</u> -- Congressman Talent's victory last November is a good story. He ran a very successful grassroots campaign that overcame many hurdles. In the Primary he defeated President Bush's cousin Bert Walker despite being outspent 3 to 1 (don't mention this race because many loyal to Mr. Walker will be in attendance). In the General, Talent won against incumbent Democrat Joan Kelly Hom despite a tide against him. He defeated an incumbent in a strong year for incumbents. He defeated a woman in the "year of the woman." And he defeated a Democrat in a terrible year for Republicans statewide. Republicans were swept out of office in all key statewide seats, including Governor, Attorney General, and Secretary of State. The backdrop was the "second injury fund" scandal that ultimately led to a prison term for Republican Gubernatorial Candidate and former Attorney General Bill Webster.

Talent ran on the platform that he would "fight for the middle class", and stressed a balanced budget, term limits, and a strong detense. His campaign communicated that the incumbent had co-sponsored then voted against the balanced budget amendment, voted against the Percian Gult War, and opposed term limits. Talent ran a strong grassroots campaign that attracted roughly 2,000 volunteers. Yardsigns were everywhere. It proved that a sincere, intelligent, and capable candidate communicating basic Republican themes can generate strong popular support.

4 <u>Flood</u> -- The Senator should be aware that Rep Talent's district may have been the single hardest-hit flood area in the U.S. during last summer's floods. Two major areas were affected, largely residential communities in North St. Charles County and a growing industrial community in the city of Chesterfield in St. Louis County

All told, it would probably be best for the Senator to avoid discussing the flood. He could talk about how Congressman Talent worked closely with FEMA and the Army Corps of Engineers to ensure that the Federal response was adequate. However, beyond this it becomes tricky. Although Talent voted for all flood relief bills, he cast a vote that was widely mininterpreted and that ensued as lots of trouble. He voted against the role for the first flood relief bill because it disallowed debate regarding sources of funding. The Press and public, not being versed in the somewhat strange rules procedure of the House, broadly interpreted this as a vote against flood relief by the Congressman whose district was hardest hit. We've recovered, but as you can imagine, are not anxious about having this resurface.

- 5. <u>Avoid the Brady Bill</u> Generally, Talent believes that waiting periods do not work, and that the gun control agenda is often used by Congress to make it appear that they are taking action on crime, while avoiding more substantive measures such as reforming the criminal justice system and keeping criminals locked-up. However, this is not necessarily mainstream thinking in our district, so we'd rather the Congressman's vote not be broughtup.
- 6. <u>Avoid NAFTA</u> Although Rep. Talent is by nature a free-trader, he voted against NAFTA because of concerns about sovereignty, and the dangers of letting other countries decide whether U.S. businesses are complying with labor and environmental laws. Rep. Talent's position was sincere, and well-reasoned (see attached letter). However, many top local corporate executives (some of whom will be in attendance) were either angered by his vote or do not yet understand it. Congressman Talent continues to make good progress in patching-up these differences. In most cases his explanation is reassuring to them because none of them like government pressure to comply with regulations. Yet, we still have some work to do, and it would likely be counter-productive for the Senator to bring it up, and potentially disastrous to indicate that he supported it strongly.

7 <u>Avoid St. Louis' Bid for a Football Team</u> -- The Senator may be aware that St. Louis snatched defeat from the jaws of victory in its recent bid for an NFL team. The problem was that there were two competing investor groups who could not get their act together. There are a lot of hard feelings about this, and some members of one of the investment teams will be in attendance. Although there are some ways this could be discussed without offending them, it would take a great deal of preparation to explain this. Best if Rep. Talent discusses this and the Senator avoids it.
