As you know, I've also checked on commercial flights, and U.S. Air has a direct flight (#1437) that leaves Washington National Saturday morning at 8:59, and arrives in Ft. Lauderdale at 11:37. I've tentatively booked a seat for you in first class on this flight. I've also booked you in first-class on a return flight to Washington on Sunday (US Air 1718), leaving Ft. Lauderdale at 4:45 and arriving Washington National at 7:08 PM.

I've also called the weather service ("a real, live person") in Miami, and their long-range forecast runs only through Sunday. Saturday is forecast to be fair and cool, with highs in the low 70's and lows in the upper 40's. Sunday will be mostly clear and cool, with highs in the upper 60's (near 70) and lows in low 40's.

I also talked with Rich at the pool (Mark wasn't available); he reports an "arctic blow" expected over the weekend.

RE: UPDATE ON JACKIE MAY - PURSUIT OF A PERMANENT IMMIGRANT
VISA FOR HER FRIEND SHIMON SWISA, A NATIVE OF ISRAEL

BACKGROUND

SHIMON, A 26-YEAR-OLD ISRAELI, HAS APPLIED TO INS FOR AN EXTENSION OF HIS VISITORS VISA FOR AN ADDITIONAL 6 MONTHS.

PROFESSIONALLY, HE SERVED IN THE ISRAELI ARMY AND TRAVELED. NOW DIVORCED FROM A CALIFORNIA WOMAN, HE LOST THE OPPORTUNITY TO QUALIFY FOR A PERMANENT IMMIGRATION VISA (GREEN CARD).

WHILE IN FLORIDA, HE'S WORKED FOR KIRBY VACUUMS, A MOVING COMPANY, AND EXPECTS TO JOIN FEDERAL EXPRESS.

OPTIONS

I HAVE SPOKEN WITH JACKIE SEVERAL TIMES, WITH SHIMON, AND WITH INS IN MIAMI IN ORDER TO RESEARCH EVERY POSSIBILITY AND THE PROCEDURE.

- 0 HE DOES NOT APPEAR TO QUALIFY FOR AN IMMIGRANT VISA UNDER FAMILY OR EMPLOYMENT PREFERENCES.
- 0 THE OTHER 2 OPTIONS ARE FOR HIM TO PARTICIPATE IN A LOTTERY FOR 55,000 VISAS WHICH WILL TAKE PLACE NEXT SUMMER. (AS SOON AS THE STATE DEPARTMENT ISSUES INSTRUCTIONS, I WILL ADVISE THEM.)

OR, ONCE THEY MARRY, JACKIE CAN SUBMIT A SPOUSE PETITION.

A FIANCE CATEGORY IS NOT APPROPRIATE - IT IS FOR INDIVIDUALS WHO ARE NOT IN THE COUNTRY.

STRATEGY

- 1) HE IS WAITING FOR INS/DALLAS TO PROCESS HIS APPLICATION FOR EXTENSION OF THE VISITORS VISA. THEY PAID A PROFESSIONAL SERVICE TO HELP THEM PRIOR TO CALLING THIS TO OUR ATTENTION. ASSUMING THAT THE PROFESSIONAL IS CAPABLE, AND KNOWING THE TEMPORARY NATURE OF THAT VISA, I FEEL WE MIGHT BE COUNTERPRODUCTIVE TO INQUIRE. I'VE ADVISED JACKIE AND SHIMON THAT WE SHOULD ALLOW INS TIME TO PROCESS THAT APPLICATION.

THE GOOD NEWS IS THAT HE APPLIED BEFORE THE VISA EXPIRED. THE BAD NEWS IS THAT HE APPEARS TO HAVE ACCEPTED EMPLOYMENT, WHICH PLACES HIM IN AN OUT-OF-STATUS (ILLEGAL) POSITION. HOPEFULLY THAT WILL GO UNNOTICED.

LEGALLY, NOW THAT HE HAS EXPRESSED AN INTEREST IN REMAINING IN THE U.S., HE CANNOT QUALIFY FOR A VISITORS VISA. IE, AN APPLICANT FOR A VISITORS VISA IS SAYING, "I MERELY WANT TO BE IN THE U.S. AS A GUEST FOR PLEASURE. I HAVE NO INTEREST IN REMAINING IN THE COUNTRY."

- 2) ONCE THE EXTENSION OF HIS VISITORS/NONIMMIGRANT VISA IS APPROVED, HE CAN:
 - A) FILE FOR THE LOTTERY.
 - B) GET MARRIED. THEN JACKIE CAN PETITION FOR HER SPOUSE. I HAVE CAUTIONED THEM THAT INS IS LOOKING AT POTENTIAL FRAUDULENT MARRIAGES VERY CLOSELY.
- 3) IF THE VISA IS NOT APPROVED, HE CAN STILL TRY FOR A & B ABOVE BUT MUST PROCESS HIS FINAL PAPERS AT A U.S. CONSULATE OUTSIDE OF THE U.S. (HE ALSO RUNS THE RISK OF BEING ASKED TO LEAVE THE COUNTRY. BUT FROM A PRACTICAL POINT, THAT IS NOT A PRIORITY FOR INS.)

BOTTOM LINE

I AM SENDING THEM THE FORMS TO COMPLETE AND WILL PROVIDE A LETTER FROM YOU FOR THEM TO ADD TO THE PACKAGE. THEY MUST TAKE THE COMPLETED PAPERS AND SUPPORTING ORIGINAL DOCUMENTS IN PERSON TO THE MIAMI INS OFFICE FOR REVIEW. IF COMPLETE, INS CAN GIVE HIM A WORK PERMIT AND SCHEDULE HIM FOR AN INTERVIEW AT A FUTURE DATE.

THEY SEEM SATISFIED. JACKIE THANKS YOU FOR YOUR HELP. WE AGREED TO KEEP IN TOUCH.
