#### Race Update:

- 1. Political newcomer Bernadette Castro was recently chosen as the GOP Senate nominee over former Ambassador to France, Evan Galbraith, receiving the support of over 90% of the delegates at the state GOP convention. She is considered a rising star in the state and offers a strong contrast to Senator Daniel Patrick Moynihan.
- 2. Castro has a great deal of personal resources and has the advantage of a united state GOP. In May, Castro hired Ed Rollins as a general consultant. Recently, when asked by the media how much of her own money she would be willing to contribute to the campaign, she responded "As much as it takes." It is important to note that the gubernatorial ticket also includes a woman while there is not a woman at the top of the Democrats' slate.
- 3. Politically in New York, most observers and political activists are focused on the gubernatorial race. Polls have consistently shown Governor Mario Cuomo as very vulnerable in his re-election bid; Republican state Senator George Pataki, the party's gubernatorial nominee (who has the backing of Senator Al D'Amato), is only seven points behind in a recent hallot survey, 48% to 41%. With Governor Cuomo's numbers very weak, Moynihan will have the problem of having to distance himself from both the state and national Democrats.
- 4. The Rev. Al Sharpton will challenge Sen. Moynihan in the Democrat primary on September 13 after petitioning to get on the ballot. In order to accomplish that goal, he had to collect 15,000 valid signatures on nominating petitions during a five-week period this summer.

Dave Levy called me to discuss your appearance at his fundraising event in New York this Saturday, with 3 specific points:

- (1) He has no way of predicting how many people may show up; it could be 30, or it could be 300. The Mondello event is giving him stiff competition, since it's so near by and they draw from the same donor base. Also, his people have a tendency to not RSVP, and simply show up. Regardless of the size of the event, he wants you to know how much he appreciates what you're doing, and that he derives a very substantial boost simply by your appearing on his behalf.
- (2) Many of the people attending his event will be physicians, so comments on your health care plan would be appropriate.
- (3) A good number of those attending are Jewish, and you get "mixed reviews" from them -- he believes because the press doesn't give you a fair shake on your support for Israel. It would be beneficial for you to make some comments on this issue, perhaps leading into it by congratulating Levy for his support for Israel as a member of the Foreign Affairs Committee.

Nassau County consists of the 3rd, 4th and 5th Congressional Districts of New York. It is a very conservative area, however each one voted for Clinton in 1992 --

It is expected that both Reps. King (R) and Levy (R) will face primary opposition from 1992 opponents. The filing deadline is July 14 (yesterday). Rep. Gary Ackerman of the 5th CD has no primary opposition, however, there are three Republicans vying for the opportunity to defeat him. Yet the GOP nominated candidate for the 5th is Allen Binder who also ran in 1992 and got 45% to Ackerman's 52% (3% went to a third party candidate). The other two Republican candidates are Edward Elkowtiz and Grant Lally.

Reps. King and Levy are expected to be in attendance at the luncheon as is Allen Binder. You should probably avoid backing Binder, however, since there are other Republicans running. As you know, the NY Republican Party is quite powerful in the selection of candidates. The Executive Committee of the County meets at their own convention and nominates a candidate, to the dismay of many other GOPers who run. In fact, I recently received a call from a disgruntled Republican in NY 21 CD, Albany, who was angered by the fact that the committee selects and endorses their own candidate. His concern is that the establishment of a third party is looming which could harm the GOP.

As you also know, the nominated candidate for the 1st congressional district, a Michael Forbes, requested your presence at his evening fund-raiser in Remsenburg, NY. We have told him this will not be possible with your tight schedule. I believe Mo told you about this candidate and the many who do not think too highly of him. Besides, Forbes will likely have Republican opposition. For your information they expect 60-70 people and it will take place at the home of Ms. Diane Imbert, 10 Mallard Lane.

Issues -- the County Republican Party has indicated that this will be a highly political crowd. Your remarks should focus on the 1994 elections and the GOP successes we've had so far since Clinton's election. U.S. Senate candidate Castro and gubernatorial candidate, State Senator George Pataki, are both expected to attend.

A mention of the Chairman of the Nassau County GOP, Joseph Mondello, would be greatly appreciated by the Party. Mondello has served in that position for 11 years and is also the Republican National Committeeman for NY. He has held this position since August of 1992. (See enclosed bio for additional information on Mondello.) Mondello was an early backer of Pataki, by the way, which probably helped to ensure Pataki's nomination on the first ballot.

Another potential topic of concern to the group or the press would be the cutbacks in defense spending. Unisys, a maker of high-tech defense systems and the U.S. Merchant Marine Academy are located in the 5th district; Grumman (Northrop) Industries are the largest employers in the 3rd CD.

#### **U.S. SENATE RACE**

Cook Ratings from July 13 keep this race in the "Solid Dem" slot.

One controversy with the Castro campaign was the hiring of Political consultant Ed Rollins. The Moynihan campaign called for the dismissal of Rollins saying Moynihan "deplores the hiring of a political operative who thinks it is appropriate to slander African-America clergy order to inflate his own ego and reputation." But Castro manager Howard de Martini responded with "The real issue is not whether Ed Rollins should continue to represent Bernadette, but whether Senator Moynihan should continue to represent New Yorkers."

(NOTE: Sharpton did file for this seat).

#### **CAMPAIGN ISSUES**

- Abortion -- Sen. Pataki has moderated his pro-life position and is now under attack from both ends of the political spectrum.
- Death Penalty -- As you probably read, Gov. Cuomo has proposed that the state legislature approve a state constitutional amendment that would give voters three options for murder penalties: the death penalty, life without parole or life with the possibility of parole. In the past, Cuomo has been militantly opposed to the death penalty. However, since polling indicates that the New York electorate strongly supports the death penalty, Cuomo is trying to distance himself from his earlier position. (Those who favor the death penaly are now about 3-1 over those who oppose it -- Pollster Zogby.) See enclosed pieces on the debate.
- Cuomo commercials -- One features Cuomo's support in '84 for the nation's first mandatory seatbelt law. The other is the Roswell Park Hospital with Roswell Park IV taking about how Cuomo has saved that institution by spending state money. Number one, New Yorkers do not favor the seatbelt law and they also know that Cuomo had nothing to do with the law's passage. Secondly, people do not want to hear about how Cuomo has been spending all their hard-earned money. These are strange messages for the Cuomo ad campaign.

David A. Levy (R-Baldwin) arrived in Washington on January 5, 1993 to represent southwest Nassau County (Long Island) in the United States House of Representatives. In doing so, he succeeded Raymond J. McGrath, who retired from Congress after 12 years of service.

Congressman Levy enters the federal arena after serving with distinction in a variety of local political and governmental posts.

Among them: press secretary to a former town supervisor, counsel to his local Republican committee, executive assistant to a town supervisor and Councilman in America's most populous town, the Town of Hempstead.

Enroute to his congressional seat, Mr. Levy turned back a primary challenge by a once-popular member of the New York State Assembly and, in the general election, defeated the chief side to a well known Member of Congress from California.

A radio news reporter before entering government service, Congressman Levy was affiliated with stations WGBB (Freeport), WHN (New York City) and WINS (New York City). He covered a variety of stories in the New York and Long Island areas. He also served as counsel to the New York State Assembly and as Associate Director of Public Affairs for one of the nation's largest electric and gas utilities, the Long Island Lighting Company. In the late 1970's, he was a member of the adjunct Communications faculty at two of Long Island's institutions of higher learning.

As an attorney, he is admitted to practice before all of New York State's state courts and before the federal courts for the eastern and southern districts of New York.

A strict fiscal conservative, Mr. Levy is proud of the fact that, despite tax hikes at virtually every other level of government, taxes in his town remained frozen during his tenure as Councilman. He also takes pride in his outstanding record of service to the more than 700,000 residents of Hempstead.

As a freshman in Congress, Mr. I avy fought for — and won — appointment to two key panels: the Committee on Foreign Affairs and the Public Works and Transportation Committee. On Foreign Affairs, he has been assigned to subcommittees dealing with Europe and the Middle East and with International Operations. On the public works panel, he sought and received appointment to the Surface Transportation and Aviation Subcommittees.

With two large airports bordering his district, and tens of thousands of daily road and rail commuters, Congressman Lovy will have a substantial interest in voicing his constituents' concerns on national transportation policy.

In Congress, Mr. Levy will advocate policies to stimulate economic growth to help his recession-weary district. He will also maintain an active constituent service operation to ensure Long Island voices are heard by Washington policymakers.

SUBJECT: Middle East Information

The King Hussein-Rabin meeting for July 25 is the biggest news. There is, however, already some controversy over Clinton's proposed debt forgiveness for Jordan — up to \$1 billion. Congress has not yet been consulted, and there is concern that such forgiveness has been (or is being) offered before Jordan actually signs a comprehensive peace treaty. The other major concern is the potential deployment of American peacekeepers to the Golan Heights as part of a comprehensive Israel-Syria agreement. The conservative Likud party opposes such peacekeepers as do some conservatives in the United States (led by Frank Gaffney).

I have attached a summary of Congressman Levy's accomplishments prepared by his staff.

#### LOCAL CONCERNS

Procured military housing units in East Meadow and Garden City, insuring military presence on Long Island. Units were scheduled to close due to defense downsizing; Congressman Levy, however, was able to sway Pentagon to keep facilities open and refurbished.

Active participant in Long Island Breast Cancer study currently taking place at the National Institutes of Health. Dave Levy has urged federal researchers to utilize local volunteers for study and insure that study focused on any and all possible links to breast cancer in Nassau County.

Championed increased funding for breast and cervical cancer research. In light of high breast cancer incidence on Long Island, House passed measure authorizing \$150-million for early detection examinations.

Secured funding for Mineola grade crossing project, appropriating the final round of federal revenue for the \$50 million project to make crossings safer for pedestrians and automobile traffic.

Spoke out in strong opposition and voted against the president's tax increase package, a proposal which will have a detrimental affect on Long Island business and residents, especially senior citizens.

Worked in coalition with the New York-New Jersey Port Authority, to make air noise a primary concern of the Federal Aviation Administration at JFK.

Fought for and won approval of Hempstead's application to the Justice Department for additional police officers.

Called for congressional oversight hearings on the recent rash of arrests in connection with fake aircraft parts. Representing an area adjacent to one of the world's largest international airports, the safety concerns of this problem are enormous.

Prodded NY-NJ Port Authority to cease the practice of open-air fire training at JFK Airport. At the urging of Congressman Levy, Port Authority has agreed to implement a safer, cleaner alternative to fire training at the airport.

Worked with other members of the Long Island congressional delegation to overturn federal statistical status for Long Island. Long Island originally included in plan to clump area with New York City, Suburban New Jersey, and Eastern Pennsylvania for statistical purposes which decide eligibility for federal funding.

Advanced tax fairness plan, where federal taxes would be assessed depending on an area's cost-of-living. Levy tax plan would be boon to Long Island residents and businesses.

Obtained \$6 million in federal funds for improvements to Jericho Turnpike. Project was included in national highway system bill at the insistence of Congressman Levy.

Reached accord with federal Transportation Department head to abolish plans to re-route flights bound for Newark in an effort to relieve New Jersey of air noise. Representative Levy charged that Long Island could not bear the brunt of more jet noise.

#### DOMESTIC ISSUES

Cosponsored tough anti-crime legislation that puts the onus on the criminal and not the victim. Bill calls for stiffer penalties in relation to drug dealing and capital punishment for those accused of dealing in mass quantities. Measure also cuts back on the now seemingly endless appeal process for those criminals on death row.

Supported measure designed to prod states to toughen laws against domestic violence, provide grants for law enforcement efforts to prosecute and prevent crimes such as rape, and make interstate stalking or domestic violence a federal crime.

Voted for legislation that would prohibit companies from permanently replacing striking workers, nullifying a Supreme Court ruling allowing employers to replace workers striking for economic reasons, such as wages and benefits.

Implored president to develop an effective method for reviewing regulations which impose billions of dollars in costs to American consumers each year. Urged president to determine the most effective regulations at the lowest possible cost to businesses and consumers.

Helped develop welfare reform plan with other House Republicans which is based on reducing long-term costs by instituting mandatory work requirements for recipients.

Backed health care reform, but a less bureaucratic alternative to the president's plan. Levy supported bill focuses attention on fixing existing problems rather than redesigning the entire health care system, complete with new federal regulations and bureaucracies.

Reinforced veterans health programs by backing bill calling for a near \$1 billion increase in veterans' medical care programs. Levy also called on president to insure that the veterans' health care system not be abolished but strengthened in any health care reform proposal.

#### FOREIGN AFFAIRS

Led Republican support of passage of the North American Free Trade Agreement, designed to eliminate tariffs in the United States, Mexico, and Canada. Long Island region rated as one of the top areas in the country to benefit from the trade pact.

Met with foreign leaders to discuss initiatives to restore stability to many of the world's hotspots, most notably Somalia, Bosnia and Haiti.

Insisted president withdraw U.S. troops from Somalia following sneak attack on American forces. Levy claimed original mission in Somalia had been completed and it was definitely time to remove U.S. troops from the region.

Maintained funding levels committed to Israel as prescribed in the Camp David accord.

Participated in meetings of Israel's top government officials on the eve of the Israeli-PLO peace agreement.

Demanded that Arab nations respond to the Middle East peace developments by lifting their long-standing economic boycott of Israel.

Submitted resolution, later supported by dozens of lawmakers, urging the U.S. Board for International Broadcasting (BIB) to start transmitting Radio Free Europe in the former Yugoslavia. BIB, in initiating broadcasts in the Balkans, claimed wide Congressional support motivated decision.

Introduced legislation designed to cut-off U.S. funding to the United Nations if that body recognizes rogue-nations bent on international terrorism. Language was unanimously passed by the House.

JERUSALEM, July 13 - While attention has been focused largely on the Palestinians and the start of their self-rule, peace talks between Israel and its Arab neighbors are at a potentially decisive stage on more fronts

> than at any moment since they began three years ago.

This week Israel be-Analysis gan a new round of nego-

tiations with the Palestine Liberation Organization. In a few days it will enter a new phase in its dialogue with Jordan, and at the same time it will also welcome Secretary of State Warren Christopher, who will try to breathe fresh life into stalled talks with Syria. Wherever the Syrians go, Lebanon can be expected to follow.

In fact, some Israeli officials say these efforts will, as they develop over the next few months, determine whether Middle East peace negotiators ultimately succeed or fail. And though others caution against such do or-die forecasts, they, too, agree that the multi-track talks have reached a critical point.

One reason, they say, is the inexorable reality of Israel's political calendar:

#### A Year for Labor's Talks

Having celebrated its second anniversary today, the Labor-led Government of Prime Minister Yitzhak Rabin has two years left. That gives it perhaps another year to come to terms with the Arabs before turning its complete attention to domestic politics. And should Labor then be ousted by the rightist Likud Party, it is a fair bet that negotiations as they are now known, with Israel prepared to give up land for peace, will become a thing of the past.

For the moment, the talks commanding Israel's greatest interest are those with Jordan, which will take on a new look next week with the two sides holding their first open meetings in each other's country.

Negotiations on longstanding border and water disputes are supposed to begin on Monday in a tent set up along the border between the two countries, starting on the Israeli side A critical phase for politics as Israel's Labor Party passes a midpoint.

at a point 10 miles north of the Gulf of Agaba.

As part of this new direction. Foreign Minister Shimon Peres is scheduled next Wednesday to become the first top Israeli official to cross publicly into Jordan. Also, King Hussein told the Jordanian Parliament last Saturday that he planned to meet with Mr. Rabin, an encounter that Israeli officials say may take place in the fall.

In fact, the King is known to have met both Mr. Rabin and Mr. Peres, and other Israeli leaders, in secret sessions going back three decades. But his decision to go public - in good part to please the United States in the hope of obtaining military aid and debt writeoffs - is a significant shift, as is his readiness now to talk peace in the region itself.

Since negotiations began in October 1991, Jordan and Israel have confined their meetings to Washington.

By agreeing to bring them home, officials here say, King Hussein has signaled that he is prepared for bolder strides toward normal relations with the Israelis, without looking over his shoulder every minute to see if he is falling too far behind or getting too far ahead of Syria and other arab countries.

#### Bracing for Change

The King himself leaves no doubt that, after watching Syria and the P.L.O. each follow its own best interests in talks with Israel, he feels it is time for Jordan also to worry less about pan-Arab coordination and to look out for No. 1. He is particularly blunt about wanting to climb back into Washington's good graces after falling into disfavor for having supported Iraq in the Persian Gulf war in

"If the meeting between me and the Israeli Prime Minister is a price peace treaty ahead of Syria and other

to change the picture of this country, I will not hesitate at all and I consider it a service for my country, which is facing threats from all directions," he said in remarks to Parliament on Saturday. Significantly, his speech was broadcast live, apparently to brace his people for big changes.

Arab countries.

"Jordan has to carefully calibrate how much normalization it can pursue with Israel to make the Americans happy but without antagonizing the Syrians," said Dore Gold, a senior researcher at the Jaffee Center for Strategic Studies of Tel Aviv University.

As a way to hold the King's interest, Israel has begun dropping hints that it is willing to consider new arrangements for Muslim and Christian holy sites in Jerusalem. Those places were in Jordanian hands before they fell to Israel in the 1967 Middle East war, and Jordan still considers itself responsible for Muslim shrines.

What exactly the Israelis mean is far from clear, and in any event they insist that Jerusalem must remain completely under their sovereignty. But by raising the possibility of a new status for non-Jewish sites, officials say, Israel both offers a conciliatory gesture to Jordan and sends a message to the Palestinians that, no matter what they say, they have no monopoly on Arab interests in the holy city.

On the Palestinian track, Israel and the P.L.O. began talks this week in Cairo on how to extend self-rule beyond its first stage, Jericho and the Gaza Strip, to encompass the entire West Bank.

P.L.O. negotiators say the discussions should move briskly, with Palestinians across the occupied territories taking charge of their own lives in a broad range of civil affairs and then holding area-wide elections in the fall.

Israelis are not so sanguine. They see months of arduous work ahead, more complicated in key respects than the Gaza-Jericho deal if only because the patchwork of Arab towns and Jewish settlements across the West Bank requires weighty security, cultural and religious considerations.

If the past is a guide, the Israeli-P.L.O. discussions will be studded with four-hanky crises and mutual charges of bad-faith bargaining. But the point for now is that both sides have decided that the start of Palestinian self-government in Gaza and Jericho should be a springboard for still more action and not an excuse to pause and tote up gains and losses.

That leaves Israel's talks with Syria, or, to be more accurate, its non-talks.

#### Visit by Christopher

Without progress on that front, there can be no hope for true regional peace, but the two sides have not met face to face since February, just before the massacre of 29 Palestinians in Hebron by an Israeli settler. (Israel is also trying to negotiate a treaty with Lebanon, but the Lebanese are in effect wards of Damascus and will follow its lead.)

This weekend, Secretary of State Christopher is scheduled to arrive here in an attempt to revive the Syrian-Israeli dialogue, but neither side offers much hope for a quick breakthrough. In Damascus, a Government newspaper said bluntly this week that "Syria has nothing new" to say.

If that proves to be the case, even nonaction could become a turning point. It may raise questions about how much longer Mr. Christopher is prepared to keep coming to the region on diplomatic shuttles that go nowhere.

And while some senior Israeli officials complain that the Secretary is too timid for their taste about banging diplomatic heads together, they also worry about the consequences should he withdraw from the scene entirely.

#### Golan Heights the Key

Without an active United States role — perhaps including American peacekeepers on a demilitarized Golan Heights — there will be no Israeli peace with Syria, they argue. Lately, Mr. Rabin has gone so far as to warn of war in a few years unless agreements are reached now, pronouncements that the rightist opposition waves off as a tactic to scare the public into supporting Government policies.

As ever, the key is the Golan Heights, captured by Israel from Syria in 1967 and long considered by Israelis to be indispensable to their security. For peace, Mr. Rabin says he is willing to give up most of the heights and to withdraw Israeli forces and settlements there over several years. But first he wants Syria to spell out its peace terms. In turn, the Syrians say they want peace, but first Israel must declare its readiness to leave the Golan — all of it.

"Everybody knows exactly what the stand of the other side is and what is required," a senior Israeli official said. "But nobody wants to be the first to make the move."

The frustration over this deadlock gas begun to show.

"The gaps between Syria and ourselves are still very wide, but we were never, ever, closer to peace with Syria, ever," Deputy Foreign Minister Yossi Beilin said last week. He added, "The end of 1994, beginning of 1995 are the coming months that will make it or break it."

Joseph N. Mondello is serving in his eleventh year as Chairman of the Nassau County Republican Committee, which has long been acknowledged as one of the premier Republican county committees in the United States. He is also the Republican National Committeeman for the State of New York, the first Nassau Republican Chairman to be so honored.

Chairman Mondello has enjoyed a long and distinguished career in government and politics.

From 1979 to 1987, Chairman Mondello served as a Councilman of the Town of Hempstead, New York. In January, 1987, Mr. Mondello was appointed Hempstead Presiding Supervisor, and was successfully returned to office by wide margins in 1987, 1989, and 1991. In this capacity Mr. Mondello served as the chief executive officer of the nation's largest township and, as Vice Chairman of the Nassau County Board of Supervisors, he served as majority leader of Nassau County's legislative body.

Known as a strict fiscal conservative, one of Mr. Mondello's proudest achievements in office was his ability to steer Hempstead Town through the recession of the late 1980's and early 1990's by cutting costs, reducing the size of the town workforce, and holding the line on taxes without resorting to reductions in public services.

In April 1993, Mr. Mondello left the office of Presiding Supervisor to assume the reins of Nassau Downs as its Chairman of the Board and President.

A dean's list student at Hofstra College, Mondello earned his Bachelor of Arts Degree in 1962. After graduating, Mondello worked as a teacher in the East Meadow school system and later became a probation officer in Nassau County.

His activities as a probation officer spurred him to return to the study of law, and in 1966, Mondello entered The New England School of Law. Mondello distinguished himself during his tenure in law school; he was named to law review after his first semester (an honor rarely accorded a freshman law student) and continued to serve on law review during his entire law school career. In addition, Mondello received the New England School of Law's American Jurisprudence Award, one of the school's highest academic honors.

In 1969, Chairman Mondello graduated from law school and passed the bar examination. He then helped found the Levittown based law firm of Flaum, Imbarrato and Mondello.

Chairman Mondello utilized his legal skills as counsel to the New York State Legislature, serving the New York State Senate Majority and the New York State Assembly Majority and Minority, the State Committee on Labor, and as a former Assistant District Attorney serving in the Complaint, Felony and Trial Bureaus. He also served as a Special Agent in the U.S. Office of Naval Intelligence.

He ran and was elected to the proposed Nassau County Legislature in 1975 but, due to the fact that the electorate failed to approve a referendum setting up a legislative form of government in the County, he never served in that capacity.

Locally, Chairman Mondello is active in many civic and fraternal organizations. He's a member of the Nassau County Bar Association, the former District Attorney's Association, the Nassau Lawyers Association, the Columbia Lawyers Guild, the Criminal Justice Coordinating Council of Nassau County, New York State District Attorney's Association, and Criminal Bar Association.

He is a charter member and former orator and member of the Board of Directors, Sons of Italy, Marco Polo Lodge; Ushers Society of St. Bernards Roman Catholic Church; Epsilon Sigma Fraternity of Hofstra University; Ancient Order of Hibernians; Knights of Columbus, Holy Innocents Council; the Knights of the Holy Sepulcher; Long Island Area Development Association; the Levittown Chamber of Commerce and the Uniondale Hispanic Association.

He is a member of the Nassau County Criminal Justice Coordinating Council, the Kiwanis and Lions Clubs and the Massapequa Park Post of the American Veterans. He also served as Levittown District Chairman of the Boy Scouts of America and a coordinator of Catholic Charities.

His military record included service in the Air National Guard as an airman from 1955 to 1956, United States Army as Corporal in the infantry from 1956 to 1958, and he presently serves as a Brigadier General in the New York Guard. He is currently a member of the Reserve Officers Association.

Chairman Mondello has received a host of awards and recognitions from various civic, professional and fraternal organizations, including: The Good Scout Award for Community Service from the Nassau County Council of the Boy Scouts of America; the Law Enforcement Man of the Year Award from the Detective's Association of the Nassau County Police Department; Certificate of Merit from the Veterans of Foreign Wars of the

United States; the Youth Service Award of the Levittown Athletic Club; Community Service Recognition from the Marco Polo Lodge of the Order of Sons of Italy; Merit Award from the Hispanic Committee of Nassau County; Citation of Merit from the Grand Lodge of the State of New York, Order Sons of Italy; Certificate of Achievement from the American Committee on Italian Migration; the Frank A. Gulotta Criminal Justice Award; Certificate of Merit from the Adjunct Faculty Association of Nassau Community College; the Touch of Freedom Award from the Nassau County Conservative Committee; and he has been honored by both the Long Island Committee for Soviet Jewry and the Anti-Defamation League of B'Nai B'Rith.

Born in Brooklyn in 1938, Mondello is married to the former Linda Elizabeth Crabtree. They have three children, Joseph, Elizabeth and Lisa. They have lived in Levittown for the past 26 years.

\*15 NEW YORK: CUOMO GIVES HIS REASONING ON DEATH PENALTY ISSUE In a N.Y. DAILY NEWS op-ed, Gov. Mario Cuomo (D) gave his reason for asking voters to decide on the death penalty. Cuomo: "I have always believed ... that if the people of New York were given a real choice and a chance to consider the issue they also would conclude that imposing a death sentence is neither the best nor the only way to satisfy our thirst for justice." Cuomo refers to a recent Quinnipiac Poll which he says shows "a clear majority, 55% percent of the people, would prefer an option besides the death penalty" (7/13). Balto. SUN's Germond & Witcover write, the issue "may give Cuomo some flexibility on the controversial issue -- and ammunition to his foes who know that his consistency has been one of his strongest suits" (7/13). State Sen. George Pataki (R) "has accused Cuomo of backpedaling, when in fact Cuomo flaunted his opposition to the death penalty during his state convention speech last month" (Lombardi, N.Y. DAILY NEWS, 7/14). N.Y. DAILY NEWS' Sleeper: "He hasn't really changed his position; he just can't give up being the paterfamilias of New York" (7/14). W. POST's Cohen: "His message -- conventional liberalism -- seems out of date, quaint. But he can be very persuasive" (7/14). Cal Thomas: "When Mr. Cuomo says that capital punishment is an irreversible act of retribution, he probably is confusing retribution with revenge" (W. TIMES, 7/14). INTERVIEWED: Cuomo, interviewed by CNN's Shaw, on Pataki: "He used to be supported by Right to Life and now he's prochoice. He was a mayor who raised taxes 30%, and now he's against taxes. He used to say he was for a ban on assault weapons, but then he voted not to ban assault weapons. I know what his bosses in the Republican Party say about him. They say, the way we chose a candidate was to find somebody who calls himself a Catholic who

is also for the death penalty and for abortion" ("IP," 7/12).

RESPONSE: Pataki, interviewed by CNN's Shaw: "I think it's really sad when you have someone like Mario Cuomo that's been noted for his rhetoric that really has elevated the debate now ... talking the way he's talking about his opponent is a Catholic ... If you want to talk about flip-flop, my support for the death penalty and his opposition is something that has characterized the debate in this campaign right up until this week. ... It's simply an attempt to put the issue into 1995, to get past another election" ("IP," 7/12). \*12 NEW YORK: CUOMO SUGGESTS REFERENDUM ON DEATH PENALTY
He has vetoed 12 different death penalty bills as Gov., but
Mario Cuomo (D) yesterday proposed the legislature approve a
state constitutional amendment, "giving voters three choices for
murder penalties: the death penalty, life without parole or life
with the possibility of parole" (Lombardi/Browne, N.Y. DAILY
NEWS, 7/8). Cuomo said he thought the voters would opt for life
without parole, but said he was "willing to abide by the decision
of the people of New York on this issue." He added that it was

Both said they would sign a death penalty bill once in office (N.Y. DAILY NEWS, 7/8). NY GOP Chair Wm Powers: "Mario Cuomo is scared. He's afraid New Yorkers will send him off to Oklahoma this November." Sen. Maj. Leader Ralph Marino (R): "The people of New York want the death penalty, and Governor Cuomo is solely responsible for having denied it to them" (N.Y. TIMES 7/8).

CUOMO: "I think the Republicans will not do it. I think they're afraid to do it ... They don't want to give up the issue" (NYDN 7/8). "Don't you see the hypocrisy of it? They say this will make you safe, but for 12 years we've denied you the right to vote for it ... I'm trying to get rid of the death penalty, and I'm trying to do it constitutionally because the Constitution will live longer than I do" (N.Y. TIMES, 7/8).

THE POLLS: A DAILY NEWS poll (874 NY voters, by Louis Harris, 6/2-5) showed 74% favor the death penalty, 23% oppose. A Gallup poll (1263 NY voters, released 6/23) also found 74% support for the death penalty. But Cuomo cited a poll by Quinnipiac College in Hamden, CT, showing that when given a specific choice 44% favored life without parole and 40% favored the death penalty (N.Y. DAILY NEWS, 7/8).

#### **Early Summary**

State Senator George Pataki won "official candidate status" of the New York Republican Party on May 23. NYU Dean Herb London missed the opportunity to be placed on the ballot when he received 22% at the GOP convention, 3 points short of what conservatives said London would need to be taken seriously at the Conservative Party convention. Then, as expected, on June 6 Senator Pataki was nominated by the Conservative Party. Former Republican State Chairman Richard Rosenbaum will continue to try to obtain enough signatures to be on the primary ballot September 13.

A Putnam County state Senator, George Pataki has a history of defeating popular and powerful incumbents. His first political victory was in the Democratic city of Peekskill over the three term Democratic Mayor. He then beat the Democratic Assemblyman from his area. His most recent upset was over an incumbent Republican state Senator in a primary.

He grew up on a farm and graduated from Yale and Columbia Law School. He worked in the Legislature before he ran for Mayor of Peekskill. To this day he manages his farm and sells fruits and vegetables at a family stand in Peekskill. Over the years in the Assembly and Senate, he has been forced to spend much of his time trying to slow Democratic legislation. His connections to a New York low-tax group have, in the past, strained relations with GOP Senate Leader Ralph Marino. Marino had been a target of this group. (However, Marino had tried to recruit Senator Pataki to run for Governor in 1990.) Senator Pataki has been a favorite of fiscal conservatives, but environmentalists as well.

He has called for deep tax cuts, reduced government spending and the death penalty in this campaign. He is also pro-choice, but favors restricting Medicaid funding of abortions.

In addition to the strength at the top of the ticket, the rest of the ticket is very strong. The coup of the Republican convention was the selection of Manhattan Institute Senior Fellow Elizabeth P. McCaughey as the Lieutenant Governor candidate. She recently came to the public's attention with her scathing criticism of the Clinton Health Care Plan in the New Republic. After losing the Republican nomination for governor, NYU Dean and economist Herb London decided to join Senator Pataki as the nominee for State Comptroller.

As a Rye fireman told *The New York Times*, the state needs somebody who can "shake the tree a little." He went on to say, "we're a little too complacent. A little change is good." Cuomo aides fear this sentiment more than any other. The feeling is borne out in recent polls. A *New York Daily News* poll, from June 2-5 shows that 65% of those surveyed feel that it is time for a change. His approval rating is only 45%. Cuomo leads Senator Pataki 48% to 41%. With Libertarian nominee and radio shock jock Howard Stern included, Cuomo receives 47%, Pataki receives 40% and Stern receives 7% (margin of error +/- 3.3%). People see crime throughout New York and yearn for the return of the death penalty which Cuomo opposes. They perhaps more than anything are just tired of the misplaced priorities. As a suburban general contractor noted in the *New York Times*, you can receive many kinds of non-health related nonessential surgery on state aid, "but the average guy can't get his teeth cleaned. They pay \$3,000 a month for putting homeless people in hotels. Who's in charge? Mario wants the kudos, but he doesn't want to make the hard political decisions."

Many of the statistics continue to mount against Governor Cuomo as well. From July 1990 through September 1993 for example, New York has realized a decrease of 6.94% of its payroll jobs. This places New York 47th in the country for that period. By the 1992-1993 school year, New York students scored about 15 points below the national average on SATs. New York has one of the lowest graduation rates and one of the highest adult illiteracy rates in the nation.
