RACE UPDATE:

1. Spence Abraham won a convincing and hard fought primary campaign on August 2 against GOP activist and Detroit talk-show host Ronna Romney, 52% to 48%. With just five days to go until the election, Romney continued to hold anywhere from a four to an eight point lead in the polls. However, Abraham's strong organization -- particularly in Western Michigan -- provided him with the margin of victory.

2. Nine-term Congressman Bob Carr won a close race, beating his closest opponent by just 5,589 votes. His five opponents accumulated 497,446 votes to Carr's 158,727 Although the front-runner throughout the campaign, Carr was weakened by negative attacks by his opponents, particularly the charge that the vast majority of his campaign funds were from PACs and special interest groups.

3. This is expected to be a high energy, expensive, and most likely hard-hitting race. Abraham will tie Carr with Sen. Riegle, Bill Clinton and the national Democrats while Carr will try to paint Abraham as a far-right conservative political "insider" operative. You will be interested to know that when Clinton visited Michigan after the primary, he specifically saluted Carr for having "cast the deciding vote for our economic program last year." That direct quote appeared all over Michigan.

Abraham is working very hard to re-build his depleted campaign funds and is fully committed to prioritizing his fundraising efforts in the weeks ahead.

4. Michigan hasn't had a Republican senator since 1978 when Robert Griffin lost to Carl Levin. Statewide, Republican's fared poorly in statewide races until the surprise election of Republican Governor John Engler in 1990. Although controversial, Engler has proven to be an effective and resilient leader for both the state and the Republican Party. Indeed, the enormous rifts that resulted from the primary battles of 1988 between the party regulars and the insurgent Robertson/Christian Coalition delegates have not reappeared during this election cycle. The party appears unified and prepared for the tough re-election campaign for Governor Engler and Abraham's race for the open Senate seat.

5. President Bush attended a Michigan Republican Party fundraiser on Mackinac Island August 14, attended by both Governor Engler and Abraham. The proceeds -- approximately \$50,000 -- went to the state party for their voter turn-out program.

6. During the Republican primary, Abraham ran negative ads against Ronna Romney, calling her "socialite Ronna Romney" and accusing her of being shallow on the issues. Those ads upset a lot of women and he is going to need those votes in the general election to defeat Carr. It is likely that Carr will use this same commercial against Abraham later in the campaign to further alienate women against him.

7. Bob Carr recently received \$48,500 at a San Juan, Puerto Rico, fundraiser. Carr, who chairs the transportation appropriations subcommittee, was instrumental in the House passage of \$10 million for a mass transit project, known as El Tren Urbano, on the island. The June fundraiser was hosted by Puerto Rico Gov. Pedro Rossello. Carr is a supporter of Rossello's bid for statehood for Puerto Rico.

8. Abraham and Carr have been very active in raising money for their race, but they have done it in very different ways. Carr relies mostly on large donations from out-of-state residents and special interests while Abraham gathers most of his money from Michigan residents. Highlights of Carr's fundraising, according to a Gannett News Service analysis: Nearly one-third of his contributions this year have come from PAC's, 91% of Carr's individual contributors gave more than \$200 each and he received 61% of his large individual contributions from residents of other states during the first six months of this year.

Spence Abraham has gained 5 points in just three weeks.

There are many other factors indicating Bob Carr has a tough race ahead:

- Carr barely won the Democrat primary with only 24% of the vote. More than three quarters of all voting Democrats voted against Bob Carr.
- Early primary polls showed Carr with 22% of the Democrat vote. He finished with 24% a gain of only 2 points during the primary season.
- Spence Abraham received almost twice as many actual votes than Bob Carr in their respective primary elections (291,388 to 156,727).
- Carr was elected with only 48% of the vote in his last race for the House of Representatives.
- Carr has voted with President Clinton over 75% of the time. *The Oakland Press* reported on August 7 that Bob Carr provided the "key vote" for Clinton's record tax increase in 1993. Clinton has a 61% negative job rating in Michigan.

Spencer Abraham was born June 12, 1952 in Lansing.

Michigan to Edward and Julie Abraham. As the second generation of an immigrant family, Abraham was raised on traditional family values that have been central to shaping his life and character. Leadership...

Spence Abraham served his four-term tenure as Chairman of the Michigan Republican Party from 1983-1991. When he first arrived on the job, Abraham found that the Michigan Republican Party was in disarray. The Republican Party had lost the Governor's office, was the minority in both the State House and the State Senate and had lost ground throughout the state. In addition, the Party was in debt for nearly \$500,000. Abraham soon learned that managing the State Party was much like running the family business of years ago -- many hours of hard work and making payrolls were all a part of the job.

Abraham used his excellent leadership and organizational skills to re-design the entire State Party and to re-build itself from the grassroots up.

LANSING - U.S. Rep. Bob Carr has a rewarding link with Puerto Rico, where 43 people wrote \$1,000 checks for his Senate race in Michigan — 1,900 miles from their island.

The reason is a \$1-billion transit project known as El Tren Urbano, Puerto Rico's first urban train.

Backers of the proposed rail system helped raise \$48,500 at a San Juan fund-raiser for Carr, who was instrumental in the House passage of \$10 million for the commonwealth's project. He chairs the transportation appropriations subcommittee. 1 - 1 - mar

The June reception was hosted by Gov. Pedro Rossello, who wants Tren Urbano like former Detroit Mayor Coleman Young wanted the People Mover. In turn, Carr backs Rossello's bid for Puerto Rican statehood.

Carr's island contributors include contractors, architects, engincers and others involved in construction and real estate. Among the \$1,000 contributors was wellconnected Eduardo Molinari. whose firm is involved in designing the project and who is a close friend of Rossello's. Another 11 donors gave \$500 each.

State Scn. Lana Pollack, who trails front-runner Carr in polls for the Democratic nomination to be decided next Tuesday, says fund-raising off the U.S. mainland underscores her beefs about Carr's war chest:



Abraham, **Carr** funds show big difference

WASHINGTON - Rep. Bob Carr headed south this year to give his U.S. Senate campaign a

The Democrat picked up \$45,392 from people in Florida, each of whom donated more than \$200 by the end of June. He also got \$39,729 from Virginians and \$38.654 from Texans. But in his home base of East

Lansing, where many students live, he pocketed only \$2,752 In similarly large donations. Strange?

Hardly. In the world of money and politics, there are few real surprises. And Michigan's Senate race is not one of them. Instead, it tells a classic tale of fundralsing - membership has its privileges.

On one side is Carr, a nine-term House member who now chairs the powerful House Approprialions Committee's panel on transportation. He doles out millions of federal dollars every year for roads, bridges and highways nationwide.

On the GOP side is SpencerAbraham, who, despite his savvy political credenilais as former top aide to Vice President Dan Quayle, is running for his first elective office.

To win in November, each is diligently raising money. But, as befils their backgrounds, they're doing so in very different ways. according to a Gannett News Service computer analysis of Federal Election Commission records.

The analysis reveals that Carr relies mostly on large donations from special-interest groups and out-ofstale individuals. In contrast, Abraham gets most of his money from Michigan residents. It shows the campaigns' heavy hitters:

Special-interest groups, Nearly one-third of Carr's contributions this year have come from political action committees, or PACs, compared to 3 percent for Abraham. Wealthy Individuals. Most, 91

percent of Carr's Individual cootributors gave more than \$200 each this year. In Abraham's case, 75 percent did so. Abraham had a greater number of small contributors, who donated an average of \$59 between April and July 13. For Carr, they gave an average of \$94.

Out-of-state residents. Carr got 61 percent of bis large individual contributions from residents of other states during the first six months of this year. Abraham got 19 percent Florida and California

These findings don't surprise Josh Goldstein, project director at the Center for Responsive Politics. a nonpartison group that tracks donations. They highlight how Carr. unlike Abraham, can easily tap PAC and out-of-state money.

"He is a sitting incumbent and one of the House's 13 cardinals." Goldstein sald. A "cardinal" is someone who chairs an Appropriations subcommittee. "He's very powerful"

Goldstein said large contributors want access. "They want to be able to influence an influential member."

Some of the money raises questions about allegiance, he said. "If the money's coming from out-ofstate, obviously the contributors are not constituents."

Carr's staff argues there's nothing netarious involved, saying the lawmaker simply has friends in many places.

"People are very interested in

For Carr, and many Democratic incumbents, PACs play a sizable role.

Democrats get far more money from special-interest groups than Republicans, because they've controlled Congress for most of the last four decades, said Michael Mawbe, a legislative analyst for Common Cause.

"It's not necessarily because Republicans have richer friends," he said.

PAC money tends to increase with seniority. Majority Whip David Bonior of Michigan is a good example. PAC's account for 74 percent of the money he's raised since last year.

A good chunk of Carr's PAC donations come from transportationrelated groups, including Northwest Airlines, United Airlines and Federal Express.

Republicans, especially challengers, have less access to PAC money so it's easy for them to say they won't take much. "They by to make a virtue out of vice," Mawbe said.

The recent escape of 10 felons from a MI state prison "has turned the Republican vision of Campaign '94 on its head." Gov. John Engler (R), who "expected to stand for re-election on the strength of delivering a promised property-tax cut and presiding over an economic upsurge," has been forced to address an issue "less manageable than taxes: crime." Engler, in a speech to the MI GOP convention 8/27, "talked about building more prisons. Engler said the state needs a new \$40 million prison to house violent youths and that the most serious offenders should go to adult prisons at 19 rather than being set free. Engler: "I will not tolerate letting young thugs and murderers laugh at their victims, scoff at the law and then walk away scot-free on their 19th birthday" (Hoffman, DETROIT NEWS, 8/28). 

What is the Republican Majority Fund?

Who can contribute to this program?

The Republican Majority Fund and a brief look at history

The last time the Republicans captured both Houses of Congress was in the 1952 election sweep under President Eisenhower. Republicans had lost the White House five straight times and only in 1946 had the Republicans elected a majority in the U.S. Senate and House.

Thus, since 1930, only twice have Republicans held a majority in Congress.

The 1994 elections have the potential for the Republican Party to win a majority for only the third time in 60 years.

The keys to victory are threefold: good candidates, issues that differentiate Republicans from Democrats, and money. We have had the best candidate recruiting season ever, and the quality of our candidates this year is the highest I have seen. The 1994 elections provide the Republican Party an opportunity to make historic gains in the U.S. House and Senate as well as the potential to control a majority of governorships. Because these opportunities exceed current resources, the Republican National Committee has voted to embark on a \$12 million dollar major donor fundraising drive including corporate solicitations. A successful effort will allow the RNC to fully fund its targeted races, including more than 90 federal candidates up to their legal limit.

Individual contributions to the RNC are generally subject to an annual \$20,000 limit and corporate contributions are prohibited *but only if* they are used for federal election activity. Because the RNC has been and continues to be so successful in raising large numbers of contributions from individuals in small amounts (federal dollars), the Committee has the opportunity to legally receive individual contributions above this limit as well as corporate donations. In turn, the RNC can use these additional non-federal dollars to fund state and local campaigns to the extent permitted by the various state laws, as well as to pay for a percentage of committee operating costs.

Under Federal Election Commission rules, the Republican National Committee in 1994 can pay for up to 40% of its operating costs using these non-federal dollars (unlimited individual and corporate donations). A successful major donor/corporate fundraising effort will allow the RNC to fund the non-federal portion of its candidate and state party support programs, including voter registration and get-out-the-vote efforts, as well as 40% of committee administrative costs, giving the RNC the flexibility of using more of its federal dollars to *directly* contribute to and spend on behalf of Republican U.S. House and Senate candidates.



- a pro-family bill eliminating the marriage penalty in income tax, earned income tax credits, and social security;
- and three other bills to be reported and voted on in the first 100 days.

After a recess in April, the House Republicans will plan to introduce a 200 day proposal around May 3, 1995.




Clinton's Handling of the Economy January 1994 to July 1994



The Clinton Health Plan January 1994 to July 1994





U.S. House Seats Lost by Presidential Party Interim Elections, 1954 to 1990



Clinton Favorable/Unfavorable *Nationwide Regional Break*




Right Track/Wrong Track January 1993 to July 1994


Republicans vs. Democrats Party Best Suited to Handle America's Problems

GOP to Seek 25% More in Contributions For Elections Than Previously Planned

WASHINGTON - The Republican Party, sensing the chance for big gains in this fall's elections, will mount a drive to raise 25% more money than planned this year so that it can contribute to a growing list of candidates with chances to win.

The Republican National Committee has been expecting to raise roughly \$50 million in contributions this year, and through the first six months of 1994 had gathered in \$25 million of that, party officials said.

But party Chairman Haley Barbour said in an interview that over the next few weeks he intends to push donors to drive donations 25% higher than budgeted, arguing that 1994 has presented Republicans with far more opportunities to win elections than once thought.

Mr. Barbour indicated that the party plans to try in particular to draw more money out of big donors, who often don't contribute as heavily in years of midterm congressional elections as they do in presidential election years. Much of the money Republicans have raised so far has come from small donors, he said.

"We do have a lot of big donors who haven't contributed in levels they have in the past," Mr. Barbour said. "Now is a good time to help. This is like a presidential year."

Mr. Barbour's plans, which are likely to be discussed at the summer meeting of the Republican Party next week in Los Angeles, are just the latest indication that Republicans and Democrats alike sense the GOP has a chance to make bigger electoral gains this year than they thought just a few months ago.

Particularly in House races, many analysts now think Republicans have a chance to pick up 20 to 25 seats, and some in the GOP think a gain of 30 seats is at least possible. In off-year elections, a turnover of about 15 is more common.

Democrats currently hold a 256-178 advantage in the House. (One member is an independent.) A swing of 20 to 25 seats, while still leaving the House in Democratic control, would significantly change the political makeup of Congress.

Similarly, Republicans think they have a chance to make a significant dent in the Democrats' 56-44 advantage in the Senate.

The task of raising money at the national level for House candidates normally falls to the National Republican Congressional Committee, a group affiliated with the national party but run by GOP House members. But that committee's financial picture has been in a shambles in recent years. So the national Republican Party is in the unusual position this year of assuming the job of raising money for House races.

GOP Borrows \$5 Million, Kicks Off \$10 Million Drive

LOS ANGELES, July 22—Republicans have a chance at their best midterm election results in decades, party committee Chairman Haley Barbour said today, and they will immediately borrow \$5 million for additional spending to support congressional and gubernatorial campaigns.

Barbour announced a full-tilt fundraising drive to net \$10 million above the \$50 million already budgeted by the Republican Party for this year's elections. Most of the new money will be solicited from deep-pocket donors who have so far remained "on the sidelines," he said.

"When the dice are hot, it's time to bet the ranch," Barbour told a meeting of the Republican National Committee here.

Crowing over President Clinton's rising disapproval ratings—about half of all American voters don't like the job the president is doing, according to a recent Gallup Poll— Barbour predicted the highest number of Republicans in Congress since since 1958. To that end, he expects "80 or 90 or 90 or 100 races" to be close enough in the fall to warrant national party support. "Our opportunities exceed our resources," he said.

In the first six months of this year, the GOP raised about \$25 million, putting it about \$2 million behind schedule, according to a report to the national committee members. By comparison, the Democrats raised about \$21 million in the same period. Both parties are budgeting record amounts for a nonpresidential election year.

Barbour's bet-the-ranch gambit is expected to draw primarily on huge contributions from wealthy individuals and corporations. This "soft money" cannot be used for direct campaign expenses. Instead, Barbour said, it will go into such related activities as identifying voters, building grass-roots networks and turning out the vote on Election Day.

Some of the strongest players in' the party—including Barbour, Senate Minority Leader Robert J. Dole (R-Kan.) and House Minority Whip Newt Gingrich (R-Ga.)—will be dispatched to twist the arms of the party's richest donors.

Since taking over as chairman in 1993, Barbour has made a priority of raising more money from a broader base of contributors, and he had some successes to report, including about a quarter of a million new donors this year, most of whom gave less than \$100. Now, he said, it is "a great time and opportunity" for the "big givers" to weigh in.

Jim Whitney, a spokesman for the Democratic National Committee, said that despite Barbour's plan to up the ante, the Democrats will be closer to matching the Republicans in campaign spending than ever before. With plans to spend three times as much on direct campaigning than the Democrats have spent in any previous nonpresidential year, "we have made real progress and are at virtual parity," Whitney said.
