I HAVE NO DOUBT ABOUT THE EXCELLENCE AND SUPERIORITY OF THE AMERICAN MILITARY. AND ANY MILITARY BATTLES WILL BE SHORT ONES. BUT ACCIDENTS HAPPEN.

IF AMERICAN TROOPS ARE SENT INTO HAITI, THEN THE RESPONSE OF REPUBLICANS AND ALL AMERICANS IS CLEAR. WHILE THE TROOPS ARE IN BATTLE, WE MUST SUPPORT THEM AND WE MUST SUPPORT THE PRESIDENT.

Remarks by Governor Pete Wilson to the California Republican Party Convention

Thank you very much, Cathie. You know, it's gonna be nice, when we elect Cathie in November, to have a lieutenant governor you don't have to go in and dust off every morning.

I want to congratulate you all on choosing this wonderful city for our convention. It's a great pleasure for Gayle and me to be back home in San Diego and back with so many long-time friends and supporters.

Gayle has been just wonderful, campaigning all over the state. And it's really getting to Kathleen Brown. She's complained bitterly about Gayle -- even calling her an attack dog! But I'd have to say she's the most charming attack dog I've ever known.

Gayle's in such demand on the campaign trail these days that to have dinner with her now, I have to buy a ticket to one of her fund-raisers.

Thanks in large part to her, and thanks to the support and work that all of you have put in, this campaign has moved steadily forward and upward.

Kathleen Brown has flung more mud than anybody since Woodstock II. But it's not sticking. Her false charges just aren't sellling. The voters aren't fooled. To employ a football metaphor: When this game started, we were 23 points behind, now heading into the fourth quarter, the L.A. Times poll tells me we're 9 points ahead. I say: Let's run up the score!

This is going to be a great year for Republicans on the campaign trail. We've got a great chance -- have one of the best opportunities in years -- to win sweeping victorics in November. Californians are looking to our party for leadership, and we've got the ticket to deliver it. We have candidates running for every statewide office, who can not only win in November, but who can work as leaders and partners in making the change California needs.

Surveys have revealed that people no longer think it's smart to split their ticket. They've come to realize that ticket-splitting leads to gridlock. The voters want to vote for a ticket this fall, and this Republican ticket is the winning ticket for California.

Of course, we know the Democrats will stop at nothing to try and turn their losing campaign around. Kathleen Brown has already had most of the Clinton cabinet out to campaign for her. We've been exposed to the sheer excitement of Vice President Al Gore. First Lady Hillary Clinton was here last week and is coming back tomorrow, and I'm sure President Clinton will be out here before long. In fact, if he'll come before the election, I'll pay for his airfare.

I keep thinking of that poor Democratic candidate in Tennessee who got a call from the White House this summer asking if he wanted President Clinton to come campaign in his district. The candidate's answer was: "Only if he's coming to endorse my opponent."

The fact is, the only Clinton who won't be a millstone for the Democrats this year is Socks the Cat.

Voters are looking to the Republican Party this fall, because they know we are the party of change, the party that is addressing the real issues that affect the quality of life in California. I came home from that pleasant academic cloister, the U.S. Senate to make change. And I'm running for a second term as governor to continue fighting for the change we need to improve our jobs climate and overhaul our welfare system, to improve the quality of our schools and reclaim our streets from violent crime.

In making that change, I'm guided by fundamental principles and core values. I believe that it's time to give a break to those people who work hard, pay taxes and raise their children to obey the law.

It's time for us to teach our kids that their actions have consequences and that society must hold individuals accountable for their actions. I want California to be a state of unlimited opportunity. I want our kids to learn more -- and earn more -- than we have.

But opportunity must begin with responsibility. And the greatest responsibility is that of parent to child. It's time that parents start accepting that responsibility. Today, too many parents don't -- or can't -- and by failing to provide love, discipline and direction, consign their children to material and spiritual poverty.

Young men have no right to casually father a child and then walk away, no strings attached. So, we're cracking down on dead-beat dads, sending them a clear message: You can run, but you cannot hide from responsibility. If you lack the decency to send love to your child, you'll at least send money -- or we'll track you down and dock your pay for child support.

Teenage girls have no right to have a child out of wedlock and then expect the taxpayers to support their child. We can no longer tolerate the California epidemic of illegitimacy. We've got to stop children from having children. Not only is it unfair to taxpayers, it is unfair to the children of child-mothers. It's also unfair to society... to the potential victims of the 14-year-old predators who were the sons of 14-year-old unwed mothers.

Teenage thugs have no right to commit a crime and then expect to be coddled by the youth authority just because they're juveniles. So, last week, I signed a new law: From now on, the most dangerous juvenile criminals will be treated as adults. If you're 14 or older and do adult crime, you will be prosecuted as an adult and do adult time.

And no able-bodied adult has a right to refuse honest work and expect the taxpayers to continue supporting him on welfare. Welfare should be a safety net, not a hammock. So, we're going to set time limits and make work pay more than welfare.

But just as individuals have responsibilities, so too do governments. And one of the federal government's first responsibilities is defending our nation's borders and enforcing our nation's immigration laws. Today, it has flunked that test. Washington has lost control of our borders, but it is California that is paying the price.

In Florida, President Clinton deployed Coast Guard cutters and Navy air and sea forces -- all told, some 3,000 military personnel -- to stop illegal immigration from Cuba. But President Clinton has turned his back on California. He continues to ignore an ongoing crisis on our border of a magnitude that dwarfs the illegal immigration from Cuba.

I've made a simple, straight forward appeal to President Clinton: Secure our borders...now. It can be done. In Texas, the Border Patrol deployed Operation Hold the Line and cut illegal crossings at the border near El Paso by 75 percent.

For far too long California's demands for action in Washington have fallen on deaf ears -- not only in the White House, but in the Congress. Wc've fought for action in Washington. We've written letters, lobbied Congress, joined other states in filing lawsuits, and even run television ads demanding reform.

As I speak, Attorney General Janet Reno is giving a speech up in L.A. announcing the new action on illegal immigration that we have pressed them to take. They are desperately trying to apply bandages to the lacerated and hemorrhaging credibility of the White House and the Kathleen Brown campaign on the issue of illegal immigration. But even officials in the administration expressed disappointment in this morning's paper that these new steps aren't as bold as what's needed.

Ms. Reno, tinkering on the edges won't do it.

Anything that falls short of securing our border and providing full reimbursement for California's costs for illegal immigration, just ain't enough.

To the Clinton Administration, I say: You are shamefully in arrears. You have made Uncle Sam a dead-beat dad. You have stalled through almost another entire session of Congress without making good on what you owe California.

In the guise of verifying the number upon which we base our claims, you've commissioned the Urban Institute study. Well, though it is flawed and understates the magnitude of illegal immigration in California, the Urban Institute study does concede that the federal debt to California is at least \$1.8 billion. So pay up. Now. The Administration should sponsor a dire supplemental appropriation to pay what it owes before Congress goes home for the year.

To Californians, I say: We must not just claim reimbursement for past costs, but take action ourselves -- action we can't expect from Washington -- to put an end to continuing costs. We must end the services which steal from our taxpayers, from our schoolchildren, from our needy elderly, blind and disabled. And to do that, we must send Washington a message it can't ignore. This November we have a chance to do just that.

Sixteen years ago, Californians sent politicians the message to roll back property taxes by passing Prop. 13. This fall, we can send the message to stop illegal immigration by passing SOS.

Prop. 187, the Save Our State initiative, is the two-by-four we need to make them take notice in Washington and provoke a legal challenge that will go all the way to the Supreme Court, a legal challenge to the federal mandates that keep in place the incentives to illegal entry. It will finally force Washington to accept it responsibility for illegal immigration. That's why I support SOS and urge all of you to work for its passage on Election Day.

It's also why Kathleen Brown is so vehemently opposed: Kathleen Brown is fundamentally opposed to taking the action required to stop illegal immigration, as is the White House. They want to keep in place the services to illegals which steal from Californians. They give lip service to seeking reimbursement, but refuse to confront the need to reverse the incentives. And Kathleen Brown excuses the Clinton Administration's drift and delay on this issue.

In fact, just this week in San Francisco, Kathleen Brown actually praised President Clinton for his response to illegal immigration. She must be the only person left in America -- with the possible exception of Roger Clinton -- who thinks the Clinton presidency is a success. But that doesn't come as a surprise. Kathleen Brown has become President Clinton's chief apologist in California.

We need a governor who will be a fighter for California -- not an apologist for Bill Clinton at the expense of California. Kathleen Brown is Washington's woman in Sacramento -- not ours.

How safe would Bill Clinton be from criticism or even disagreement from a Brown Administration? As safe as a death row inmate in a Brown Administration.

Like Bill Clinton, she now talks tough on illegal immigration, but still fails to support the solutions that will really make a difference . . still fails to support an end to the services to illegals without which there will be no end to illegal immigration. And lacking the courage to do so, she seeks to discredit SOS and to vilify the vast majority of Californians who support SOS by calling them mean-spirited, racist, immigrant-bashers.

I want to know: Is she calling the 52% of Latinos who responded to the L.A. Times poll in favor of Prop. 187 racist immigrant-bashers?

All that name-calling by Kathleen Brown and Hillary Clinton -- the Employer Mandate Sisters -- seems somehow unbecoming of two election-year champions of the middle class.

But what even better demonstrates how out of touch Kathleen Brown is with middle class concerns is her response to Californians' concerns about crime. I've spent the better part of three decades fighting for tougher laws and longer sentences for dangerous thugs. Kathleen Brown, on the other hand, despite ignoring the issue for years, has had the chutzpah to portray herself as a serious crimefighter. But she had a serious lapse into candor when she told a reporter the other day about her views on crime. She said that crime would be a "so what" issue in the fall campaign. Kathleen Brown saying "so what" to crime, is like the Titanic saying "so what" to the iceberg.

So, don't be surprised on Election Day, Ms. Brown, when the voters say "so what" to your campaign. The voters want a governor who will fight crime, not someone who fudges on crime.

Of course, Kathleen Brown has an excuse for everything. She explains away her opposition to the death penalty by saying that even though she opposes the death penalty, she'll enforce the law. The funny thing is, I've heard that line before.

It was the same claim made by Jerry Brown's appointee as Chief Justice of the California Supreme Court -- Rose Bird. Rose Bird said she'd enforce the law even though she personally opposed the death penalty. But once on the court, she overturned every death penalty sentence that reached her desk -- delaying the death penalty 62 times.

Now, Kathleen Brown is offering us the same line. You might say Kathleen Brown sees the death penalty through Rose Bird-colored glasses.

Californians want a governor who's willing to stand up for what he or she believes, not one who stands on both sides of the issues.

In the past four years, people haven't agreed with every decision I've made. But that's not why they sent me to Sacramento. They sent me there because they know I'd fight for what I believe and fight like a junkyard dog to turn this state around. And that's what I've done.

We're turning California's jobs climate from a job-killer into a job-creator.

After the earthquake, we rebuilt the world's busiest freeways in record time.

With "Three Strikes," "One Strike," and our new law to try dangerous juveniles as adults, we've passed the toughest package of crime legislation in the history of California.

And we're forcing Washington to face up to the crisis of illegal immigration.

In short, we're making the change that can make California better. We're turning this state around and restoring the hope and confidence of California.

But to continue that change, we need more Republican support up in Sacramento.

Attorney General Dan Lungren is a good friend of mine, but frankly, when the Republican Constitutional officers get together for lunch next year, I want to have a few more people at the table.

And after November, we're going to have to set places for the entire ticket of Republicans on the ballot this fall. We're going to elect the whole slate of Republicans to statewide office. We're going to send Michael Huffington to fight for us in the Senate. We're going to elect more Republicans to Congress and to the state Legislature to defend California there. And we're going to restore the shine of the Golden State.

With you're hard work and support, we have the chance to make this the best Republican year in decades. For the sake of our children's future, let's get to it.

**POLITICAL HISTORY:** Republicans always dreamed of a redistricting plan that placed all the eastern Contra Costa County suburbs into a single district, since this is the only area of Republican growth in the entire San Francisco Bay Area. They got their wish from the Supreme Court masters with this newly created district in 1991, and in the process elected. Bill Baker, in 1992. Baker is different from the moderate to liberal GOP Congressmen that populated the Bay Area in significant numbers at one time, being a strong social and economic conservative. That gave him problems in his first election because of the disastrous showing of the Republican state and national ticket, which lost every Bay Area district in 1992.

**POLITICAL** ANALYSIS: A classic liberal/conservative contest in a distilct that picfers moderates. Conservative Incumbent GOP Congressman Bill Baker will face off against liberal environmentalist Ellen Schwartz. The Secretary of State at first denied Schwartz a place on the Democratic Primary ballot because she was, until July 1993, registered in the Green Party and did not reregister as a Democratic Primary ballot because she requirements. But she convinced a Sacramento judge that she meant to register as a member of an obscure radical party called Green Future and was put on the primary ballot. The good news for Baker is that more GOP voters cast ballots in the primary than Democrats; the bad news is that a perennial candidate received 23 percent against him. Baker has to get these votes back in November.

### Profile of U.S. Rep. Bill Baker's 10th Congressional District

California's Tenth Congressional District was created in 1992 as a result of dramatic population growth in the East Bay area. Comprised of most of Contra Costa County and northern Alameda County, Bill Baker carried the District with 52 percent of the vote. Republicans hold an edge in registration by about two percentage points.

The District is demographically diverse. While the fifth-wealthiest Congressional District in the Nation, much of this wealth is concentrated in the Walnut Creek-San Ramon area. Communities such as Antioch, Brentwood and Castro Valley are solidly middle class and, to a degree, blue-collar.

The principle employers are Lawrence Livermore and Sandia National Laboratories, both located in Livermore; USS-POSCO steel corporation in Pittsburg, area hospitals, schools and small businesses. Agriculture plays a declining role in the District, and is principally centered in the far western part of Contra Costa County.

Critical political issues include transportation (the I-680/24 interchange, for example, is used by 300,000 motorists each day) and infrastructure expansion; crime; job creation; and the future of the National Labs as defense budgets are reduced.

The District tends to be conservative on economic and foreign policy issues and more liberal on social matters. Rep. Baker receives high marks among constituents for his commitment to fiscal restraint, while his views on abortion (pro-life) and gun control (against the assault weapons bau) are less well received.

Rep. Baker is a fourth-generation Californian whose commitment to fiscal conservatism won him fame as one of the "Cavemen of Sacramento" during his tenure in the State Assembly. A graduate of San Jose State University and eight year veteran of the Coast Guard Reserve, he served as a budget analyst under then-Governor Ronald Reagan and later as Executive Vice-President of the Contra Costa County Taxpayers' Association. Elected in 1980 to the first of six terms in the State Assembly, he was lead Republican budget negotiator for seven years as Ways and Means Committee Whip.

In the House, he serves on the Public Works and Transportation Committee and the Science, Space and Technology Committee, each of which has direct relevance to the District (highway improvements and the Labs, specifically). Rep. Baker is a coclusirman of the House Republican Task Force on Health Reform, and at the behest of his freshmen colleagues served on the Committee on Committees for the 103rd Congress.

Bill and Joann Baker have four children, and reside in Danville.

said john Perkins, Brooks' camsurage, "we're on then top five list (of targeted races) in the state....."

A spokesman for the National Republican Congressional Committee confirmed that the group views the 36th Congressional District contest as one of the most competitive of 52 House races in California. But the spokesman, Dan Leonard, added that committee officials won't decide until the end of september how much time and money to invest in Brooks' campaign.

Democrats, meanwhile, contend that national Republicans are exaggerating their interest in the race and in the end will invest their energies in other districts across the country Brooks—who is campaigning for her first elective office beyond the Palos Verdes Peninsula—is merely a "sacrificial candidate," said Bob Mulholland, campaign adviser for the state Democratic Party.

The national GOP "will pretend they are [targeting the race], and the Republican candidate's campaign will think they are, but in the last week the candidate's campaign won't get their phone calls returned," he said.

Harman has had a much larger compaign fund than Brooks. At the end of Jude, she had a little more than \$400,000. Brooks had \$2,600 when she emerged from a bruising primary battle with former Palos Verdes Estates Councilman Ron Florance. She has raised about \$50,000 since then, Perkins said.

in cash to a candidate. The parties can provide other campaign help for a candidate, but joint expenses such as campaign mailers and advertisements cannot exceed \$29,300 in California.

Instead, candidates often depend on national personalities to boost their stature and raise individual contributions.

Some Republicans also predict that Brooks should benefit if Republican Gov. Pete Wilson does well in the South Bay in his reelection campaign.

"If Pete Wilson can carry the district by a significant margin, as long as a Republican [like Brooks] runs a decent campaign. I think the Republican can win," said Republican consultant Allan Hoffenblum, who worked for Florance in the primary.

By contrast, he said, Harman cannot depend on any Democratic coattails to help her race. Many freshman Democratic House members have tried to distance themselves from President Clinton, whose popularity has declined in much of the nation.

Harman "ran an independent campaign two years ago, and she will run an independent campaign again this year," suid her campaign spokesman. Roy Behr.

Brooks has attacked Harman for backing most of Clinton's legislative proposals, especially his budget plan that narrowly passed in the House last year. Republicons say that the plan has ended up raising taxes for the middle class.

"Those are the kinds of things voters in the district will look at," Perkins said.

Brooks "has an advantage in that she can bring in the Republican . heavyweights," Hoffenblum said. "Jane Harman has her hands tied." She is representing a political party whose President a majority disapprove of. She has to wage a maverick campaign, independent of the Democratic Party."

Harman might be doing just that. For instance, Harman is hosting a fund-raiser Friday in Marina del Rey that will include eight other congresswomen elected in 1892 but no members of the Clinton Administration.

## BTU ENERGY TAX TO COST 948 JOBS IN CALIFORNIA'S 36TH CONGRESSIONAL DISTRICT

TORRANCE, CALIFORNIA -- At least 948 jobs could be lost in California's 36th Congressional District due to Congresswoman Jane Harman's vote for President Clinton's regressive BTU energy tax according to California Republican Party Chairman, Dr. Tirso del Junco.

Dr. del Junco, citing a study released last week by the non-partisan Tax Foundation in Washington, DC, said that California could lose a total of 54,399 jobs because of the \$74 billion energy tax that was approved by Congresswoman Harman and her fellow tax and spend Democrats in the House of Representatives last Thursday.

"Besides costing 948 jobs right here in the 36th Congressional District of California, the BTU energy tax will add roughly \$400 a year to families' energy bills, " del Junco said. "Four hundred dollars may only buy two haircuts for Bill Clinton, but to the working people of California, it means a lot, especially if the BTU energy tax costs you your job," del Junco stated. He added, "apparently Congresswoman Harman was influenced more by partisan politics than by what was in the best interest of the people of her district."

The analysis referred to by Dr. del Junco was assembled by Tax Foundation Senior Economist Dr. Arthur Hall and combined the results from two economic models which have been used by the United States Department of Agriculture and American Electric Power Service Corporation to study the economic effect of the BTU energy tax.

The BTU energy tax passed by the Democrats was part of President Clinton's 1994 budget package which has been called the largest tax increase in the nation's history. The plan contains \$272 billion in new taxes, including increases in corporate income taxes and social security benefits of middle class elderly Americans. The budget does not eliminate one federal program. The two minor federal programs Clinton proposed to eliminate were rejected by the Democrat controlled committees which have jurisdiction over the programs.

The budget has a 3 to 1 ratio of tax increases to spending cuts and will add more than \$1 trillion to the deficit.

CLINTON CRIME BILL CALIFORNIA UPDATE #1

As you may know, the Clinton White House has again ginned up its taxpayer-financed public relations machine, and is deploying Cabinet members and White House staff around the country to lobby for the so-called "crime" bill that stalled in the House of Representatives last week.

Like so many elements of the Clinton agenda, this bill is much less than meets the eye. Much of what the White House has faxed to California media outlets and other partisan advocates of the bill is deceptive.

### Four Out of Five New Police Officers Won't Arrive

\*The Clinton White House says this bill funds 100,000 cops for local police forces over the next 5 years, but in fact the bill only funds 20,000. The bill provides only "seed money" to local governments for community policing.

\*California will receive only \$5,514 per police officer annually over the next 6 years, according to a Heritage Foundation analysis of the bill. Do you think your community can train, equip, and pay a police officer with only \$5,514 per year? Of course not.

\*According to the Heritage Foundation, the State of California and its local governments will have to pick up \$3.1 billion in unfunded costs for these new police officers, at a total cost of \$47,751 per cop per year.

\*The crime bill already costs each taxpayer in California \$ 193 in new federal taxes. In addition, California taxpayers will have to pay on average of \$310 each for the unfunded cost of these "free" police officers.

### CALIFORNIA UPDATE #2

Yesterday, we showed how the Clinton crime bill provides a total of \$5,514 per new police officer per year.

The total cost of each new police officer in California is \$375,013 over 6 years, according to The Heritage Foundation.

Therefore, the Clinton crime bill doesn't pay for 10,000 new police officers in California. The bill actually provides funding for only 1,378 officers per year, not the 10,000 that Clinton promised us.

As the editorial in today's Wall Street Journal shows (see below) California's not share of the crime bill amounts to -\$246 billion.

# Crime Bill Losers

President Clinton is attempting to sell his crime bill by noting how much each state will gain from its \$9 billion in earmarked funds. But consider:

The money each state gets will come of course largely from its taxpayers. But not all states will get back from this bill what they have given in federal taxes. Some states are likely to be net losers. Stephen Moore of the Cato Institute notes that California will get \$900 million in earmarked funds from the crime bill or 10% of the total earmarked funding. But California typically accounts for 14% of total federal tax payments. But 14% of the \$9 billion would be \$1.147 billion. It will therefore pay \$247 million more in taxes than it will get back in earmarked funds. Meanwhile, some states will get a net benefit from the crime bill. Arkansas is a \$37 million winner. The top 10 losing states, which proportionately will give more than they will receive, are listed below. We can't help noticing that the losers are states with the most wellknown crime problems:

### SENATOR DIANNE FEINSTEIN ACCUSED OF HYPOCRISY -"TOUGHNESS" ON ILLEGAL IMMIGRATION IS QUESTIONED

BURBANK, CALIFORNIA - Dr. Tirso del Junco, Chairmen of the California Republican Party and himself an immigrant, today blasted Dianne Feinstein for her hypocritical stance on illegal immigration, citing her record of loosening illegal immigration enforcement during her tenure as Mayor of San Francisco.

"Senator Fienstein cannot expect Californians to believe her empty rhetoric about controlling illegal immigration," Dr. del Junco stated, "considering her appalling record in San Francisco. Far from facilitating her city's efforts to solve this problem, Feinstein chose to obstruct the efforts of both the city police and the INS."

Dr. del Junco cited a San Francisco Chronicle article dated 12/28/85 stating that Mayor Dianne Feinstein signed a resolution that declared her city a sanctuary for illegal immigrants from El Salvador and Guatemala. The resolution, which was in defiance of U.S. foreign policy, stated that city employees, including police, need not report illegal immigrants from El Salvador or Guatemala or cooperate with immigration authorities in arresting such people. An INS (Immigration and Naturalization Service) official called the measure "illegal" and "irresponsible" as well as noting the thousands of dollars this would cost taxpayers in welfare benefits.

Now, realizing that illegal immigration is a hot issue, Senator Feinstein has decided to "jump on the bandwagon." According to the Congressional Record of 6/30/93, Feinstein went so far as to develop a detailed plan to stop the flow of illegal immigration. Her plan called for the hiring of more Border Control agents, increased penalties for alien smugglers, and overhauling the overwhelmed asylum process (such as the Guatemalan and Salvadoran asylum of San Francisco).

"Does Ms. Feinstein really support tough new immigration laws or does she believe that the United States is a safe haven for all Immigrants, legal or illegal ?" asked Dr. del Junco. "I guess it depends on which way the political wind is blowing at the time."

CALIFORNIA REPUBLICAN PARTY CHAIRMAN, DR. TIRSO DEL JUNCO SLAMS SENATOR BOXER'S IMMIGRATION MEASURE AS BEING A LEGISLATIVE MIRAGE

BURBANK, CALIFORNIA - Dr. Tirso del Junco, Chairman of the California Republican Party, in accordance with the Department of Immigration and Naturalization and the Pentagon, today agreed with the Justice Department's assessment of Senator Barbara Boxer's measure to use the National Guard to augment the Border Patrol as being unsubstantial and illegal.

Boxer's highly publicized provision, which was passed as a paragraph in a legislative report accompanying the 1994 Defense Funding Bill has received harsh criticism from the Pentagon because it takes away \$2 million dollars from the Pentagon's anti-drug budget. The left-wing White House itself, has not embraced the Democrat Senator's plan. One official stated, "This administration is never going to slam a Democratic Senator's idea. But if we loved it, you'd know about it. The fact that nothing seems to be happening ought to tell you something."

"Under Sen. Boxer's proposal, the only way the Governor could receive assistance from the National Guard, is if it was preceded by an approval from the Secretary of Defense." Dr. dol Junco stated, "Senator Boxer knows very well that this will never happen." In fact, in a recent <u>San Diego Union-Tribune</u> article, the Pentagon's Brian Sheridan blazed that " the Defense Secretary isn't going to approve any plan that calls for the Guard to get involved in enforcing immigration laws."

Also in question is the legality of the measure. A Defense Department official stated in the <u>San Diego Union-Tribune</u> article that the provision simply and directly does not "have the force of law."

"Why does Sen. Boxer continually squander valuable Congressional time by formulating and promoting useless measures ?" Dr. del Junco concluded. " It does the state of California no good to submit a proposal that cannot be enacted due to its ineffectiveness and illegality. Ms. Boxer is once again demonstrating her shallowness in regards to California's concerns and her ineptitude as a Senator."

Brown also challenged Wilson to take a stand on Proposition 187, a fall ballot question that would deny most state social services to illegal immigrants. Brown, who opposes Prop. 187, accused Wilson of "hypocritically exploiting our people and our fears" by "encouraging a mean-spirited and illadvised statewide initiative that will only make the problem worse." From the ad, which includes the number for the WH switchboard: "Clinton helped Florida and Texas stop immigration, but he ignores California. Governor Wilson urges you to call the president before he's here and ask him to control our border" (CHRONICLE, 9/14). Wilson began airing another ad on immigration 9/12. Partial text -- ANNCR: "300,000 illegal immigrant children in public schools, and they keep coming. The cost is \$1.5 billion a year. ... Wilson wants to use the money spent on illegals to take care of California's kids. Kathleen Brown thinks differently. In a major policy speech, Brown said, 'Jlegal immigration is wrongly seen as a cause' of problems in California" (Wilson release, 9/12).

TALKING POINTS -- GOVERNOR WILSON'S EFFORTS TO FIGHT VIOLENT CRIME

- Last December, Governor Wilson called a special session of the Legislature to focus California's lawmakers on the task of reforming California's dangerously lenient criminal justice system.
- In February, to galvanize public support for the enactment of tough, new laws, the Governor convened a statewide crime summit in Los Angeles.
- o That summit produced Governor Wilson's crime package -- 18 pieces of legislation designed to give long overdue meaning to the word "justice" in the phrase "criminal justice system." The Legislature enacted thirteen of Governor Wilson's proposals -- sweeping changes that the Los Angeles Times called "unprecedented."
- o In March, Governor Wilson became the first governor to sign a "three strikes, you're out" bill into law, which will put the worst repeat offenders away for life. As a result, California will no longer be known as a permissive, dangerously lenient state. Instead, California will gain a reputation as a state that makes career inmates out of career criminals.
- This month, Governor Wilson signed a "one-strike" law that targets sexual predators -- rapists and child molesters. The most vicious rapists and child molesters will now face 25 years to life in prison.
- c Last week, Governor Wilson signed a package of bills targeting another grave problem in California -- violent youth crime. One bill reduced to 14 the age at which violent criminals can be tried and sentenced as adults. This new law sends an important message to California's youth -- you do adult crime, you'll do adult time. The Governor also signed legislation to restrict juveniles' access to handguns, and will increase penalties for those who give and sell firearms to children.
- Last week, Governor Wilson also signed into law legislation that dramatically increases penalties for arsonists who willfully destroy homes and threaten lives.

# EPA pollution plan threatening, GAMA says

Just as Wichita prepares for Cessna Aircraft Co. to resume building piston airplanes, an Environmental Protection Agency plan to reduce air pollution in California is threatening the use of private aircraft.

At least, that's the point of view of the General Aviation Manufacturers Association — which includes as members Cessna, Beech Aircraft Corp., Learjet Inc. and scores of other small-plane suppliers — and several other general aviation groups.

The EPA has proposed levying a departure fee on private airplanes unless the planes meet zero emission standards, something that — given current engine technology — only electric vehicles can do.

GAMA, the National Business Aircraft Association, plus airline and airport groups are fighting the EPA plan. The groups claim that the EPA lacks the legal authority to charge the fees, that the EPA has no evidence that private airplanes contribute any measurable air pollution. The groups also say the agency has not charged any other transportation mode with meeting a zero-emission standard and that the standard cannot be met.

ern California to other parts of the country, hampering general aviation use at a time when the industry is working to spur a recovery in private flying.

Beech parts bargains ----Beech Aircraft Corp. is trying to make life a little easier for owners of its Beechcraft machinery by lowering its prices on spare parts.

Since the start of the year, Beech has cut prices by more than 10 percent on more than 7,400 spare parts, said Dave Jacobsen, general manager of spare parts and service at Beech.

High costs for spare parts is often cited as a factor contributing to the decline in private flying, as well as contributing to high maintenance costs.

"We want to be a leader in solving this industrywide problem," Jacobsen said. "Reducing our customers' cost of operation is one of the highest priorities at Beech." The lower-cost parts are one element in Beech's ongoing effort to improve customer support across the board. Another element is a weekly breakfast Beech sponsors for Beechcraft pilots in Wichita for training at Flight Safety International's Beech Learning Center.

At the breakfast, executives from various Beech departments get an earful about operation, maintenance and use of Beech planes from the people who fly those planes.

AWOL from Farmborough — Cessna Aircraft Co. chairman Russ Meyer stayed in Wichita last week when most other chief executives were across the Atlantic Ocean attending the biennial Farnborough International Air Show about 54 miles southwest of London.

According to company insiders, Meyer opted to stay in Wichita to play host to a Pentagon team sent to evaluate Cessna as a possible manufacturer of the Joint Primary Aircraft Training System airplane. The JPATS contract would be worth more than \$6 billion to the winner, which will have to supply 711 training planes, ground support and ground training materials.

Pentagon staff members involved in the JPATS program are to evaluate the manufacturing operations of all seven competitors, which includes Beech Aircraft Corp. Cessna's JPATs CitationJet has completed its two weeks of flight evaluations by Air Force and Navy pilots at Wright-Patterson Air Force Base near Dayton, Ohio.

That's no convention — The collection of about 80 planes crowding the ramp space at Augusta Municipal Airport are the same planes usually based in the airport hangars. So why the outdoor parking?

Augusta is repaying all the taxiways leading to the hangars on the west side of the airport. Pilots who wanted access to their planes for the past few weeks had to have the planes out of the hangars before the preparation work started.

Airport manager Nancy Moody said crews were starting to pour the new concrete late last week; once the pavement sets, the planes' owners can put the crafts back under cover.

New Beech biz - Beech Air-

craft Corp. is getting a slice of the so-called time-share airplane business but from a different source than its corporate cousin Raytheon Corporate Jets and competitor Cessna Aircraft Co.

The Jet Network Co. Ltd. is a British firm that plans to sell shares of 12 planes it agreed to buy. Called "fractional shares" sales, the purchase gives the buyer a share of the airplane's ownership and a guaranteed number of flight hours each year.

For example, a quarter share in Jet Network's plan includes 150 flight hours a year. Positioning and ferrying flights are do not count against the 150 hours. The buyer also gets the tax advantages and reduced ownership and operating costs.

Jet Network borrowed the idea from Executive Jet Aviation, which pioneered airplane time-share sales in 1987 with a program called Net-Jets. NetJets is built on Cessna Citations and Raytheon's Hawker 1900s.

Jet Network will start by selling shares of four Beechjet 400As, four Super King Air 200 turboprops, and four Hawker 800 from Raytheon Corporate Jets. Deliveries of the 12 planes could start as early as next year. No price information was available.

# When in Trouble, Don't Call the Feds

During my 30-odd years in law enforcement, I watched in wonder as one presidential administration after another promised to reduce crime and drug use in America. The wonder is that after the failures of past federal wars against poverty, crime and drugs the public still believes that Washington politicians can cure local crime problems.

In 1967, in the Johnson administration. the Safe Streets and Crime Act carried a \$50 million budget. The Great Society programs, also held up as a way of reducing crime, cost billions. Under the Nixon administration, more billions were dispensed through the Law Enforcement Assistance Act and other legislation. Crime prevention funding continued in the Reagan administration and soared during the Bush administration. However, the crime bill being considered by the Senate this week is the biggest of all. And the chances that it will significantly reduce crime are small.

Federal programs are less effective than local programs in part because they receive less scrutiny. Mandates and federal cash come down from above in the form of "free" money that a city council is unlikely to turn down, regardless of its effect. Locally funded programs, on the other hand, have to compete for funds with schools, libraries and garbage collection, and so get looked at much more closely. If something doesn't work, the money is more likely to be diverted elsewhere.

Moreover, typical federal programs are evaluated only by people with a vested interest in them. Too often, funding continues despite manifest failure. One federally funded crime program I encountered as police chief of San Jose, Calif., shows how some celebrated anticrime programs can actually increase violent crime in the name of crime prevention.

The Alternatives to Incarceration project funded college educations for prison inmates at San Jose State University during the 1970s and 1980s. Only the few people running the program were aware that the project sent a number of rapists to live at the university instead of finishing their sentences in prison.

I learned that rapists had been relocated after a series of rapes around the university led us to deploy some very brave policewomen in a decoy operation. What we found raised the hair on the back of my neck. Night after night, convicted violent felons routinely stalked women on dark streets in the vicinity of the university in downtown San Jose.

When I complained, the project director

Jenator -

said the "clients" were screened and that California had declared it an exemplary program. Actually, we later found that the program screened applicants only on the basis of academic scores. Federal rules prevented consideration of their criminal records. And California had declared the program exemplary only because it submitted quarterly reports on time.

When my complaints about the program became public, I was censured by the students and faculty and advised by my superiors in city hall to go easy. After all, this was an exemplary, federally funded program to reduce recidivism.

All of that changed a few months later when we arrested an honor student in the program for brutally torturing, raping and murdering two women near the university. He was articulate and the project had often used him to show how wonderful it was that bright people could get a college education instead of languishing in prison. Ironically, during the project's 10-year existence, not one "client" ever graduated from the university, but a number had been arrested for crimes against women.

There is no telling how many similarly disastrous experiments are lurking in the crime bill being passed in such politically inspired haste.

The worst thing about the crime bill is that it subsidizes inefficient law enforcement. In a calmer environment, questions would be asked about priorities-about the wisdom of building more prisons when 60% of those in federal prison and almost as many in state institutions are locked up for nonviolent crime. Why is adding tens of thousands of new police necessary when so many of the existing police are wasted on desk duties, nonviolent drug arrests or other work not related to serious crime? How would law enforcement leaders explain the 535,000 arrests a year for marijuana crimes when the public fear of violence is unparalleled?

The bill's method of funding the additional police is sloppy in a manner characteristic of federal allocations-the money is to come from savings from a hoped-for reduction in the federal work force. Even that questionable source provides for only two or three years of seed money. Afterward, local funding will be required or the police forces will be cut back.

Another federalizing feature of the bill is the establishment of more than 50 federal death penalties. Few experts believe that federal death penalties will deter crime. I have spoken off the record to a number of federal judges, from the most liberal to the most conservative, and they dread the passage of the crime bill. Feueral courts are already overburdened. G. ing them the incredibly time-consumir and costly responsibility of new capity punishment cases will produce a gridloc that will inevitably affect local courts.

It would be much better for the nation to think more about the drug and crim; problems and not simply throw money at them. While assault weapons should be banned, the ban shouldn't be at the price of a \$30 billion boondoggle. It would behoove the Senate to emulate the tough decision-making of local politicians who have to allocate a fixed sum of money among competing services. That process would eliminate many of the fanciful notions found in federal crime control.

### IMMIGRATION--California

### Facts

- \* The INS estimates that there are currently <u>1.4 million</u> illegal aliens now living in the State of California. California has the highest concentration of illegal aliens, 43 percent of the national total.
- \* There are currently more than 16,000 illegal aliens incarcerated in California state prisons. Incarcerating these illegal aliens costs the State of California approximately \$348 million annually.

**Note:** The crime bill signed by the President authorized \$1.8 billion over six years to reimburse States for the costs of incarcerating illegal aliens. The 1995 Commerce, State, Justice Appropriations bill provided \$130 million for this purpose.

**Note:** You may want to mention how the Democrats prevented Senate Republicans from offering an amendment that would have expedited the deportation of criminal aliens. Under the Simpson amendment, federal judges could enter deportation orders at the time of sentencing. Once the sentence is served, the criminal alien would be immediately deported without having to go through a time-consuming and expensive deportation proceeding.

\* 392,000 students, the children of illegal aliens, are currently attending California public schools (primary and secondary). The California state government estimates that the annual cost of educating the children of illegal aliens is \$2.1 billion. In a recent study, the Urban Institute had a lower estimate--\$1.3 billion.

In the 1982 <u>Plyer v. Doe</u> decision, the Supreme Court ruled that the children of illegal aliens may not be barred from public elementary and secondary schools.

### Save Our State Initiative

In November, California voters will be considering the "Save Our State" initiative. If passed, the initiative would 1) deny access to public education to the children of illegal aliens (which undoubtedly will give rise to a slew of lawsuits), 2) deny health care services (except for emergencies) to illegal aliens, 3) require state and local agencies to report illegal aliens to the INS, and 4) make it a felony under California law to produce or purchase false citizenship documents.

The initiative was authored by Alan Nelson, former

Commissioner of the Immigration and Naturalization Service during the Reagan Administration. The initiative is also closely identified with the Federation of Americans for Immigration reform ("FAIR"), the restrictionist immigration group.

The initiative has the support of the California State Republican Party, the Los Angeles County Republican Party, and many chapters of United We Stand.

At this weekend's State Party convention, Governor Wilson intends to endorse the initiative. It won't be an overwhelmingly supportive endorsement. Governor Wilson will say that the initiative is "better than doing nothing."

### Hearings

There was one hearing last June on all of the various immigration reform bills. So far, no mark-up has been scheduled on any bill, including Senator Simpson's bill.

Attached is a section-by-section analysis of Senator Simpson's immigration reform bill, which you have cosponsored. I have highlighted the most important sections. These sections include:

\* Increased penalties for alien smuggling. Increases the penalty for alien smuggling to 10 years' imprisonment (current penalty is 5 years), and authorizes the death penalty for a smuggler whose actions result in the death of an innocent victim.

\* Streamlined deportation procedures. Allows federal trial courts to issue an order of deportation during the sentencing phase of the criminal trial of an alien convicted of an "aggravated felony." This "judicial deportation" would replace the current administrative deportation procedures.

\* Increased penalties for document fraud. Increases from 5 years' imprisonment to 10 years' imprisonment the maximum penalty for fraud and misuse of immigration documents.

\* **Border fees.** Directs the Attorney General to develop a system of imposing fees at land-based border entry points. The fees will be used to hire more Border Patrol agents and finance the operation of border facilities.

\* **Use of closed military bases.** Establishes a 2-year pilot program studying the feasibility of using closed military bases to detain illegal aliens.

\* Interior repatriation pilot program. Establishes a 2-year pilot program, to be administered by the Attorney General in consultation with the Secretary of State, to examine ways to remove aliens to the interior of their country of origin (instead of right across the border in Mexico).

\* Work authorization verification. Requires the Attorney General, in consultation with the Secretary of HHS, to develop and implement a "counterfeit-resistant" <u>system</u> to verify work eligibility and eligibility for federally-funded public assistance. Note that the provision does <u>not</u> specifically authorize the creation of a "counterfeit-resistant" I.D. card.

\* Ineligibility for federal benefits. Prohibits the distribution of federally-funded welfare benefits to illegal aliens (except emergency health care, short-term disaster aid, child nutrition programs, and public health programs).

Some states will view this proposal as an attempt to shift welfare costs to them.

\* Five-year reduction in legal immigration. Reduces the annual level of legal immigration to 500,000 for each of the next five years.

# COMPREHENSIVE IMMIGRATION AND ASYLUM REFORM ACT OF 1994 TITLE I -- CRIMINAL ALIENS

### PART A --- ALIEN SMUGGLING CONTROL

Sec. 101. <u>Increased penalties for alien smuggling</u>. 1) increases the penalty for alien smuggling to 10 years (currently 5), 2) provides an <u>additional</u> penalty if the smuggler willfully subjects any alien to a substantial risk of death or serious bodily harm of 3 to 10 years, 3) allows the death penalty for a smuggler who causes death, and 4) provides a 2 to 5 year sentence if a person knowingly hires a smuggled alien.

Sec. 102. <u>Death penalty procedures</u>. Incorporates constitutionally required procedures for considering and implementing the death penalty.

Sec. 103. <u>Smuggling for commission of crimes</u>. Creates a new crime for smuggling aliens for the purpose of committing serious crimes in the U.S. The underlying smuggling penalty is enhanced by 3 to 5 years.

Sec. 104. Adding alien smuggling to RICO. Adds alien smuggling to the list of crimes which establish the basis for bringing a RICO charge. This addition will allow law enforcement officials to use RICO penalties (such as forfeiture and imprisonment) against alien smuggling organizations.

Sec. 105. <u>Expanded forfeiture for smuqqling or harboring illegal</u> <u>aliens</u>. Expands current INS authority to seize and forfeit property used in, or facilitating, the smuggling or harboring of illegal aliens. Important in cases when RICO charges (and penalties) are not available.

Sec. 106. <u>Wiretap authority for alien smuggling investigations</u>. Permits the INS, with judicial authorization, to intercept wire, electronic, and oral communications of persons involved in alien smuggling operations.

### PART B -- DEPORTATION

Sec. 111. Expansion in definition of "aggravated felony". Expands the definition of "aggravated felony" for purposes of the immigration laws. Currently the definition includes: murder, drug trafficking, trafficking in firearms or explosives, money laundering, terrorism and any crime of violence for which the sentence is 5 or more years. This section adds: firearms violations, failure to appear to answer a felony charge, demanding or receiving ransom money, unlawful conduct relating to RICO, child pornography, owning or operating a prostitution business, treason, tax evasion exceeding \$200,000 and certain immigration-related offenses including alien smuggling and sale of fraudulent documents.

Sec. 112. <u>Deportation procedures for certain criminal aliens who</u> <u>are not permanent residents</u>. Provides for the prompt deportation of any non-green card holder alien who has been convicted of an aggravated felony and who is deportable.

Eliminates the following deportation procedures for non-

permanent resident criminal aliens: (1) administrative hearing before an immigration judge, (2) administrative review by the Board of Immigration Appeals, (3) availability of current grounds of relief from deportation, and (4) federal court review on any grounds (other than mistaken identity as convicted criminal alien). The AG may not execute a final order of deportation for 14 days to allow the alien to seek the limited court review. Sec. 113. Judicial deportation. Allows <u>federal</u> trial courts to issue an order of deportation during the sentencing phase of the criminal trial of an alien convicted of an aggravated felony. This section applies to all criminal aliens, including permanent residents.

The deportation order must be requested by the government and the alien must be notified promptly of the government's intent. The government must prove that the defendant is an alien subject to deportation and that the alien has been convicted an "aggravated felony."

"Judicial deportation" would replace current administrative deportation procedures where it is sought. An appeal of the deportation order to the circuit court of appeals is retained. The Attorney General would retain her right to seek an administrative determination of deportability if the federal court denies a motion for judicial deportation.

Sec. 114. <u>Restricting defenses to deportation for certain</u> <u>criminal aliens</u>. Restricts defenses against deportation for aliens convicted of aggravated felonies. Allows only those aggravated felons who have been green card holders for at least seven years, and who have been sentenced to less than five years imprisonment, to assert a defense against deportation.

Currently, green card holders are ineligible for relief from deportation if the alien has <u>served</u> five or more years for one or more aggravated felonies. This section amends section 212(c) to make aliens who have been <u>sentenced</u> to five or more years ineligible for relief.

This standard is more relevant to judging the seriousness of an offense since dangerous criminals may be released prematurely due to prison overcrowding or other reasons unrelated to the seriousness of crime. Also, the current standard at times prevents a speedy commencement of deportation proceedings since it may be five years before it is known whether the alien has "served" 5 years.

This section also clarifies current law that aggravated felons may not request or be granted withholding of deportation. The provision is consistent with the intent of the UN Protocol to permit denial of withholding of deportation in cases of persons convicted of a "particularly serious crime."

Sec. 115. <u>Enhancing penalties for failing to depart, or</u> <u>reentering, after final order of deportation</u>. Enhances penalties for failing to depart or for reentering after a final order of deportation has been issued.

Currently, an alien who is deportable for criminal offenses, document fraud, or as a security risk is subject to criminal

penalties of up to 10 years imprisonment for failure to depart. However, there are no penalties for aliens deportable for other reasons. Subsection (a) retains the current 10 year penalty and provides for up to 4 years imprisonment for aliens who are issued deportation orders on other grounds and who fail to depart.

Subsection (b) increases the penalties for criminal aliens who reenter the U.S. after being formally deported. Currently, an alien who is convicted of a felony other than an aggravated felony and who re-enters is subject to 5 years imprisonment and a criminal fine; this subsection extends the penalties to aliens convicted of three or more misdemeanors and increases the maximum sentence to 10 years. Aggravated felons who re-enter the U.S. currently are subject to criminal fines and up to 15 years; this subsection increases the maximum sentence to 20 years. Language also is added to make it clear that any alien who stipulates to deportation during a criminal trial shall be considered to have been formally deported.

Subsection (c) would restrict a court's ability, in a criminal proceeding against a deported alien who has re-entered the U.S., to re-examine the underlying deportation order except in those cases where the alien demonstrates (1) that she has exhausted any available administrative remedies against the deportation order, (2) that the deportation proceedings improperly deprived the alien of the opportunity for judicial review, and (3) that the entry of the order of deportation was

Sec. 116. <u>Civil penalties for failure to depart</u>. Allows civil penalties to be levied against an alien who fails to depart pursuant to a deportation order.

### PART C -- MISCELLANEOUS

Sec. 121. <u>Miscellaneous and technical changes</u>. Responds to two holdings of the 9th Circuit. Subsection (a) clarifies that the Attorney General can authorize deportation proceedings to be conducted by electronic or telephonic means or, where agreed to by the parties, in the absence of the alien.

Subsection (b) clarifies that nothing in this Act or in section 242(i) (directing the AG to begin deportation proceedings as quickly as possible after a conviction) shall be construed to create a legally enforceable right or benefit for the alien.

# TITLE II --- PORT OF ENTRY INSPECTIONS

Sec. 201. <u>Restrictions on admissions fraud</u>. An alien who presents fraudulent documents, documents containing false information or who presents no documents to an asylum officer upon entry into the U.S. is excludable (can be denied admission to the U.S.), <u>unless</u> the alien can show: 1) that the fraudulent, stolen or "disappeared" documents (such as documents destroyed on the airplane) were used exclusively to leave a country from which he or she has a "credible fear of persecution," or 2) to avoid return to such a country.

Credible fear is established if: 1) it is "more probable

than not" that the alien's statements are true, and 2) there is a significant possibility, given the alien's statements and the information known by the asylum officer, that the alien can prove her eligibility as a refugee.

Aliens expressing a desire to apply for asylum will be screened by a specially trained asylum officer. If the officer determines she has a credible fear of persecution, she can then apply for asylum. All other undocumented or falsely documented aliens will be excluded.

Sec. 202. <u>Special port of entry exclusion for admissions fraud</u>. Aliens found to be specially excludable under this bill may be ordered deported. An alien may be returned only to a country in which the alien has no credible fear of persecution upon return. Sec. 203. <u>Judicial review</u>. Restricted to limited habeas corpus review. Other than limited habeas, no court can: 1) review a determination to exclude aliens under this bill, 2) review the procedures established by the Attorney General under this Title, or 3) enter declaratory or injunctive relief regarding implementation of this Title.

Sec. 204. Effective date.

### TITLE III --- PENALTIES FOR DOCUMENT FRAUD AND MISREPRESENTATION

Sec. 301. Increased penalties for document fraud. The penalties for fraud and misuse of immigration documents and governmentissued identification documents are increased from 5 years imprisonment to 10 years. The sentencing guidelines are amended to increase the minimum penalties based upon the number of fraudulent documents involved. The penalties are also increased if the documents are supplied to a terrorist, to facilitate a terrorist activity, or to persons involved in organized crime activities.

Sec. 302. <u>Penalties for failure to disclose role as preparer of</u> <u>fraudulent documents</u>. Establishes both civil and criminal penalties for failure to disclose a person's role as preparer of fraudulent documents. Criminal penalties are also established for persons who conceal that they have, for a fee, prepared or assisted in preparing a fraudulent application for asylum. Sec. 303. <u>Civil penalties for fraud, misrepresentation, and</u> <u>failure to present documents</u>. Establishes civil penalties for failing to present valid immigration documents at the time of boarding a common carrier, or to an immigration officer upon arrival at a U.S. port of entry.

### TITLE IV -- ASYLUM REFORM

Sec. 401. <u>Penalties for frivolous applications</u>. Establishes civil and criminal penalties for preparing false or frivolous applications for immigration benefits or false supporting documents.

Sec. 402. <u>Asylum and work authorization</u>. Establishes that an applicant for asylum is not automatically entitled to work authorization. The Attorney General has discretion in granting,

denying, suspending or placing conditions on work authorization.

Sec. 403. <u>Resources to address asylum backlog</u>. Provides for a 2year program of property acquisition and leasing and use of retired federal employees to process the backlog of asylum claims (as in the 1986 Act legalization program).

Sec. 404. <u>Reforms to deportation process</u>. To expedite the deportation process: removes the Spanish language requirement for the document initiating deportation proceedings, clarifies that the privilege of counsel is "at no expense or unreasonable delay to the Government," and establishes time deadlines for filing judicial appeals, briefs and reply briefs.

Sec. 405. <u>Reduction of incentive to delay proceedings</u>. Requires that permanent resident aliens undergoing deportation proceedings who assert the defense of having resided in the U.S. for seven consecutive years cannot count the time they were in deportation proceedings towards the 7-year requirement.

TITLE V -- ILLECAL IMMIGRATION AND BORDER SECURITY Sec. 501. Additional investigators. Reprograms \$8 million for one year to hire 125 additional investigators and staff to investigate potential violations of employer sanctions. Sec. 502. Funding of deportation costs. Reprograms \$10 million for one year to fund the detention and deportation of aliens from the U.S.

Sec. 503. Interior repatriation pilot program. A two-year pilot program and report to examine methods to deter multiple illegal entries, including removing aliens to the interior of their country (instead of just across the border).

### TITLE VI -- BORDER CROSSING USER FEE

Sec. 601. <u>Imposition of fees</u>. Within 6 months of enactment, fees shall be imposed at land border ports of entry for the entrant's use of border facilities and services to equal the amount necessary for maintenance and operation of facilities and services. A separate account is established to retain the fees for INS use. Moneys unused for the current fiscal year due to the imposition of these fees will be used to hire and equip 100 additional Border Patrol agents and support personnel, and for repair, maintenance or construction of structures on the border.

TITLE VII -- DETENTION OF ILLEGAL ALIENS

Sec. 701. <u>Pilot program on use of closed military bases for the</u> <u>detention of illegal aliens</u>. 2-year pilot program and report on the feasibility of using of closed military bases to detain illegal aliens.

### TITLE VIII -- PUBLIC BENEFITS ABUSE

Sec. 801. <u>Ineligibility for federal benefits</u>. Prohibits the distribution of federally-funded welfare benefits to illegal aliens (except emergency health care, short-term disaster aid, child nutrition programs and public health programs). Only

aliens lawfully in the U.S. with work authorization can qualify for unemployment benefits.

### Sec. 802. <u>Attribution of sponsor's income and resources to</u> <u>family preference aliens</u>. The income and resources of an alien's sponsor shall be deemed to be the income and resources of the alien until the alien becomes a citizen.

Sec. 803. <u>Definition of public charge</u>. Defines "public charge" (for deportation purposes) as any alien who, within 5 years after the date of entry, has received welfare benefits for more than 12 consecutive months, except for causes which arose after entry into the U.S.

TITLE IX -- WORK AUTHORIZATION VERIFICATION

Sec. 901. Work authorization verification. Requires the Attorney General with the Secretary of Health and Human Services to develop and implement a counterfeit-resistant system to verify work eligibility and federally-funded public assistance benefits eligibility for all persons.

# TITLE X -- NUMERICAL LIMITATIONS ON ADMISSION OF ALIENS INTO THE UNITED STATES

Sec. 1001. Five-year reduction in legal immigration. Reduces legal immigration from 675,000 to 500,000 for five years. The 175,000 reduction is taken proportionately as follows: 75,000 from the family immigration preferences, 45,000 from the employment immigration preferences, and 55,000 from the diversity program.

Sec. 1002. <u>Worldwide numerical limitations</u>. Removes the "pierceable cap" and replaces with a firm cap. This firm cap applies both to the reduced admissions (5-year reduction to 500,000) and the permanent 675,000 admissions limit. Sec. 1003. <u>Numerical limitation on annual admission of refuqees</u>. Limits refugee admissions to 80,000 unless Congress adopts a bill specifically authorizing a larger number.

# TITLE XI -- MISCELLANEOUS PROVISIONS

Sec. 1101. Use of legalization information for criminal prosecution purposes. Allows the Attorney General to furnish identifying information, contained in confidential legalization applications, to a law enforcement agency in connection with a criminal investigation, or to a coroner for identifying a deceased individual.

Sec. 1102. <u>Communications between federally funded government</u> <u>agencies and the Immigration and Naturalization Service</u>. No federal, state or local government entity receiving federal funds shall be prohibited from communicating with the INS regarding the immigration status of an alien.
