You are scheduled to address the National Legislative Conference of the American Chiropractic Association on Thursday, March 9 at 12:30.

You will be the keynote speaker following Speaker Gingrich. They have asked you to speak to an audience of about 500 chiropractic doctors for about 15 minutes.

The theme of the conference is, "Survival in the '90's: The Continuing Battle Over Health Care Reform." The concern of the group is the same as the others you have recently addressed -- medicare cuts and health care in the 104th Congress. Medicare covers very little right now for chiropractic services. They would like to see more of their services covered, which is very unlikely given the fact that we are looking at drastic reductions.

Nevertheless, chiropractors have been essential providers, particularly in rural areas where they are often the only health care provider for many miles.
