In wake of Saigons surrender

The formal surrender of the Saigon government to the Viet Cong has brought some bitterness to the families of missing American servicemen, but also a pledge to keep fighting for information about their loved ones.

"As far as the families of men who remain missing, it is not the final chapter," said Gail Cozart of Bellevue, state coordinator of Washington Families of MIA-POW.

There are approximately 50 men who still remain missing from the State of Washington alone," she said. "And some of them we have pictures of being marched through the streets of Hanoi. We continue to do all we can

to get an accounting." o get an accounting.

Mrs. Cozart's husband. Robert, an
Army captain, was listed as missing
in the Mekong Deta of, South Vietnam March 20,1970; after his obseryation plane disappeared.

"A COUPLE of weeks ago, Hanoi released some names of men they said had been killed in crashes of their aircraft in 1965 and 1968," she said. "We have said all along they had more information than they were releasing. This proves our point. "How they are going to leak it out.

Mrs. Henry Fors of Puyallup still seeks knowledge of what happened to her son, Marine Corps Capt, Gary Fors. He was declared missing Dec. 22, 1967, after his F4 fighter was reported shot down inside Laos.

Her husband was hospitalized Monday night for a heart attack, she explained, but should be home in a few.

"He takes it rather hard," she said. "Our son was over there fighting for our freedom."

Mrs. Cozart sees the Saigon surrender as "a tragedy for the people there, regardless of how the pictures from the cities portray the people welcom-


Mrs. Hagerman sees the surrender as something that could as well have happened during the Lyndon Johnson presidency, though she never actually supported the peace movement.

Holchi Minh for settlement in Viet-nam included overthrow of the Saigon government, removal of the United States, and formation of a coalition government in the south. They never strayed from those points.

Status Determination Changes for Missing in Action (MYA) Personnel

This regulation establishes procedures for continuance of a missing in action (MIA) status or for making changes by a finding of death or issuance of a report of death. It implements chapter 10, Title 37, United State Code.

1. Law Governing Status Reviews. Chapter 10, Title 37, United States Code, specifically authorizes continuance of a missing in notion status or change in such status by a finding of death (Section 655) or issuance of an official report of death (Section 556):

\$555. Secretarial review

(n) When a member of a uniformed service entitled to pay and allowances under section 552 of this title has been in a missing status, and the official report of his douth or of the circumstances of his absence has not been received by the Secretary concorned, he shall, before the end of a 12-month period in that status, have the case fully reviewed. After that review and the end of the 12-month period in a missing status, or after a later review which shall be made when warranted by information received or other circumstances, the Secretary concerned, or his designee, may-

(1) If the member can reasonably be presumed to be liv-

ing, direct a continuance of his missing status; or

(2) make a finding of death.

(b) When a finding of death is made under subsection (a) of this section, it shall include the date death is presumed to have occurred for the purpose of-

(1) ending the crediting of pay and allowances;

(2) settlement of accounts; and (3) payment of death gratuities.

That date is-

(A) the date after the day on which the 12-month

period in a missing status ends; or

(B) If the missing status has been continued under subsection (a) of this section, the day determined by the Sec-

retary concerned, or his designee.

(c) For the sole purpose of determining status under this section, a dependent of a member on active duty is treated as if he were a member. Any determination made by the Secretary concerned, or his designee, under this section is conclusive on all other departments and agencies of the United States. The subsection does not entitle a dependent to pay, allowances, or other compensation to which he is not otherwise entitled. Added Pub. L. 89-554, 5(b), Sept. 6, 1966, 80 Stat. 628.

Secretarial determinations

(a) The Secretary concerned, or his designee, may make any determination necessary to administer this chapter and, when so made, it is conclusive as to-

(1) death or finding of death;

(2) the fact of dependency under this chapter;

(3) the fact of dependency for the purpose of paying 6

months' death gratuitles authorized by law;

(4) the fact of dependency under any other law authorizing the payment of pay, allowances, or other emoluments to enlisted members of the armed forces, when the payments are contingent on dependency;

(6) any other status covered by this chapter;

(6) an essential date, including one on which evidence or information is received by the Secretary concerned; and (7) whether information received concerning a member

of a uniformed service is to be construed and acted on as an

official report of death.

- (b) When the Secretary concerned receives information that he considers establishes conclusively the death of a member of a uniformed service, he shall, notwithstanding any earlier action relating to death or other status of the member, act on it as an official report of death. After the end of the 12-month period in a missing status prescribed by section 555 of this title, the Secretary concerned, or his designee, shall, when he considers that the information recelved, or a lapse of time without information, establishes a reasonable presumption that a member in a missing status is, dead, make a finding of death.
- (d) The Secretary concerned, or his designee, may, when warranted by the circumstances, reconsider a determination made under this chapter, and change or modify it.
- (h) For the sole purpose of determining status under this section, a dependent of a member of a uniformed service on active duty is treated as if he were a member. Any determination made by the Secretary concerned, or his designee, under this section is conclusive on all other departments and agencies of the United States. This subsection does not entltle a dependent to pay, allowances, or other compensation to which he is not otherwise entitled, Added Pub. L. 89-564, 5(b), Sept 6, 1966, 80 Stat. 629.
- 2. Reviewing Officers. Review hearings to consider cases under Sections 555 and 556, Title 37, U.S.C., shall be made by one or more officers appointed by the Secretary or his designee as circumstances require.
- 3. Notification to Next of Kin. Next of Kin (NOK) of a MIA inember currently receiving governmental financial benefits which could be terminated by a status review will be notified

MISSINS

a. The status of the MIA member is to be reviewed on a certain date;

b. They will be afforded a reasonable opportunity to attend the review hearing with a privately retained civilian attorney if they choose;

c. They will have reasonable access to information upon which the status review will be

d. They will be permitted to present any information which they consider relevant to the proceedings.

- 4. Waiver Provisions. NOK may waive their right to attend the review hearing and still submit written matters on their behalf. Failure without good cause to exercise by the time prescribed, any of the rights extended under this regulation will be construed as a waiver of such rights, in which event the review will proceed as if such rights had been expressly waived.
- 5. Policy on Classified Material Classified material will not be disclosed or made available to NOK, nor will it be considered by the review hearing officer or the Secretary of the Air Force, or his designee, in making a status change. However, every effort will be made to declassify such material so that as much of it as possible can be made known and available to NOK and consitered in the status review process.
- 6. Conduct Review of Hearings. Review hearing proceedings will be informal and closed to the

public. They are not adversary proceedings. Strict rules of evidence do not apply. While NOK will be permitted to call witnesses, they are encouraged to use written statements to expedite proceedings. The only limitation as to matters which may be considered shall be one of relevancy and materiality as to whether the member should continue to be carried MIA, or whether a report of death or finding of death should be is-

- 7. Report of Review Henrings. The officer (or officers) appointed to conduct the review hearing will objectively review the information upon which the status review will be based, including information and argument offered by NOK, and make recommendations to the Secretary of the Air Force or his designee concerning the status of Air Force members falling within the scope of chapter 10, Title 37, USC. A summarized report of the review will be submitted to NOK for comment prior to submission to the Secretary or his designee for final decision. If NOK disagrees with the accuracy of the summary, the disagreement will be resolved by comparing the summary to a mechanical (or other verbatim) recording of the hearing. The recording will prevail over the recollection of the parties to the hearing. The Secretary or his designee will notify NOK of his decision.
 - 8. Costs Incurred. Costs incurred by NOK as a result of any aspect of this program are not reimbursable by the Government.





Dear Minnesota Elected Officials:

Today, President William Jefferson Clinton, along with representatives of the Socialist Republic of Vietnam proclaimed agreement to "normalize" diplomatic relations. To us this is not welcomed. After all, there is the unfinished business of Americans abandoned in Southeast Asia.

The United States of America has knowingly left Americans behind during every War including World War II, Korea, the Gulf War and Vietnam, including the Cold War eras as well.

Once again, we would appreciate your support for these critical offerings all of which help correct the past and protect the future for military personnel (families) serving today and those yet to serve.

The announced permatization of of U.S. relations with Vietnam drew an angry response from a Minnesotan who lost two brothers in the war. A solo protest last Wednesday in Saint Paul illustrated the divisivences and

Brian Burke of Burnaville burned the lag of the Socialist Republic of Vistnam (SRV) in front of the Minneauta state capital on July 12 as a protest against the diplomatic moves and

nounced by president Clinton last

In the bright afternoon sup on one of the hottest days of the summer. Burket hald a SRV flag, yellow with three and stars, and immolated it on the steps of the state capitol. As TV video crews watched, the charred blackened remains of the flag drifted down in sharp contrast against the shimmering whitestone steps.

Burke, a Victnam veteran who served in the U.S. army, has been active in the POW-MIA issue for a long time. His anger stems from his personal loss, and the nagging questions brought up by normalization.

For Burke, the immediate question raised is 'did my brothers die in vain?' Beyond that Burke and others in the POW-MIA organization assert that the POWs have not been accounted for; that human rights are routinely violated by the Vietnamese government; that Vietnamese refugees have not been adequately taken care of; and the US government has not told the truth about the war in Vietnam. Because of these conditions, says Burke, "there should be no aid and no trade - accounting first."

POW-MIA organization representatives plan to be in Washington D.C. on July 18th for meetings with Minnesota congressional delegation and with the Victnamese (SRV) embassy. They will continue their search to "find the truth"
